- Mabel will be our new webmaster. There is money in the budget already for her fee, \$1,500.
- 6. Treasurer's Report: Kathy J. presented financial reports as of March 31, first quarter. These files were sent out electronically before the meeting and in addition they were presented as a screen share. Highlights include: Expenses were 13% of budget. Income was up from contributions. Literature sales are up. AAIC Monthly Porfit and Lass respot, Balance sheet, Reconciliation, Bankd statements, and savings accounts were presented. The Treasurer's report of numerous extensive financial reports was presented.

### 7. Information Center Report.

Janie presented her report that she is going into the office a couple times a week to prepare orders, check the mail and prepare bank deposits. Janie said that literature sales are picking up, eight curbside and four shipped out. She has placed orders from WSO for needed literature. Janie has received no requests from people ordering literature for payment by credit cards.

8. **Information Center Liaison Report.** This position is still open. Kathy J. gave a brief description of the duties for this position in Feb. Sam asked people to get the word out to groups that we need a volunteer to serve in this position.

Because Paula H. was absent, Lynn P. gave report as acting Liaison to District 6. There is a new
newsletter coordinator and an electronic newsletter trial is underway and posted on website. There

#### 10. Committee Reports.

- Literature- (Don C. chair) Inventory coming up in June.
- Finance- (Terry F. chair) Contributions are up after the appeal letter. Please thank your groups.
- Volunteers- (Marilyn C. chair) Marilyn had no report since the center has been closed. We
  discussed that the office would remain closed because all our volunteers are in the Covid high-risk
  group. We can possibly discuss a reopening date at the next board meeting.
- Meeting List- (Karen R. new chair) She has reviewed the website and found some errors. Any changes will require ERI to Janie who will forward on the Sam and webmaster.

#### Old Business.

• Members and officers decided to go ahead with a new webmaster.

#### New Business.

- Webmaster position will be a contractor, and the fee is \$600. Ongoing maintenance fees are \$40/month.
- Terry F. suggested that several members provide feedback to new webmaster and new subcommittee.
- Sam has renewed our lease for our office space through 2021. The rate is \$1,000 /month starting in September.

There was discussion about holding the board meeting in-person at Northland. The AAIC board decided by consensus to hold the August 16, 2021 board meeting virtually.
