- 1) Opening. The meeting was called to order by Charlie A. Chairperson.
- 2) Introduction. Those attending introduced themselves and stated whether they were voting or non-voting participants.
- 3) Readings. The Al-Anon Preamble from <u>HOW IT WORKS</u>, <u>FOR FAMILIES & FRIENDS OF ALCOHOLICS</u> was read by John T. The Twelve Traditions & Twelve Concepts of Service were read by Attendees. From <u>PATHS TO RECOVERY</u>, Lois's story, read by Lisa R-F.
- 4) Announcement of quorum, 5 voting persons were present (By-Laws, page 4) Chairperson 4 persons constitute a quorum as based on number of voting Directors at the December 2006 meeting.
- 5) Reading of Minutes from the October 2007 meeting. Motion made by Lisa R. to accept the minutes as presented. Motion seconded by John T. and carried by unanimous vote.
- 6) Chairperson's Report. No report
- 7) Treasurer's Report: Heather W., Treasurer reported accounts thru December 15<sup>th</sup>, 2007. Report attached. Some discussion followed the report regarding purchase of QuickBooks Software to maintain continuity. Previous treasurers had used software already loaded on their computers. The income treasurer did not have that. Lisa R. mentioned that in keeping with Tradition 7, AIC should purchase what was needed for the use of the Treasurer. Heather would continue to look for an inexpensive version of Quick Books that was needed for AIC purposes.

For the period the center has averaged 6 telephone calls a day and 2 walk ins a day. About \$3,000 was spent on literature and \$7,000 in literature sold.

- d) For office of Secretary, Linda B. agrees to serve another term. Pat E. made a motion for Linda B. to serve another full year. Lisa R-F seconded the motion. There was no discussion. All were in favor. The motion passed.
