- 1) Opening. The meeting was called to order by Charlie A. Chairperson.
- 2) Introduction. Those attending introduced themselves and stated whether they were voting or non-voting participants.
- 3) Readings. The Al-Anon Preamble from <u>HOW IT WORKS</u>, <u>FOR FAMILIES & FRIENDS OF ALCOHOLICS</u> was read by Gail M. The Twelve Traditions & Twelve Concepts of Service were read by Attendees. From <u>PATHS TO RECOVERY</u>, Lois's story, read by Judy K.
- 4) Charlie A, Chairperson, reminds board member to sign in with full name for purposes of official minutes. On the web, only first names will appear, but by laws of the State of Texas requires full names to be used in the minutes.
- 5) Announcement of quorum, 6 voting persons were present (By-Laws, page 4) Chairperson 3 persons constitute a quorum as based on number of voting Directors at the December 2006 meeting.
- 6) Reading of Minutes from the December 2007 meeting. Mention was made of a few errors which were corrected. Motion made by Gail M to accept the minutes as amended. Motion seconded by Millie F. The Motion was carried by unanimous vote.
- 7) Lisa R. brought up that in order for Charlie A. to be a back up signer on the checking account it must state in the minutes that the board voted for him to be a back up signer. Gail M. made a motion that Charlie be added as a signer to the checking account. The motion was seconded. Judy K. seconded the motion. The motion was carried by unanimous vote.
- 8) Chairperson's Report. No report

- 9) Treasurers' Report: Lisa R. handed out a printout of report. (attached) One side a break down of accounting for the period, December 17th, 2007 thru February 15th, 2008. (See Attached) She noted a mistake in contribution total. Should be \$1572.65 total contributions for the period rather than \$2172.65. The \$600 contribution made by Bee Caves AFG, had mistakenly been entered as \$1200. There was discussion of the Yellow pages bill. Lisa reported that last year's bill had been paid in September. The Quick Books Software that was needed for accounting purposes was purchased in December and had been installed. Lisa reported that all the paperwork and reports from the previous treasurer had been brought to the AIC office and turned over to Kitty G.
- 10) Information Center Report. Kitty G. reported an average of 6 calls and 2 walk-ins for the period (43 days since the December Meeting). The Center spent approximately \$3100 on literature and took in about \$6700 in sales. Kitty also reported that a new microwave had been donated to the Center by Paula H of the Anderson Mill AFG. The old one that still works will be donated to the Salvation Army. The center now has volunteers to work from 2 to 4 each day of the week except Friday. That spot is still available. Gail M. asked Kitty if there is a record of literature purchased by group. Kitty has receipts only with the name of the person who buys the literature. She may be able to start keeping a detailed list of literature purchase by group in case some one is interested in that information.

Kitty had to leave early and could not stay for the rest of the meeting.
