Janie presented her report that she is going into the office a couple times a week to prepare orders, check the mail and prepare bank deposits. Janie said that literature sales are picking up. She has placed orders from WSO for needed literature. There are no plans to reopen the office. The back door needs to be replaced. Danielle O. questioned reopening of the office and there was discussion about how this decision had been made in March 2020. Most, but not all, volunteers feel there is too much risk for Covid transmission in an open office.
