- 1) Opening. The group held a moment of silence followed by the Serenity Prayer. The meeting was called to order by Chairperson, Pat E.
- 2) Introduction. Those attending introduced themselves and stated whether they were voting or non-voting participants.
- 3) Readings. The Al-Anon Preamble from <u>HOW AL-ANON WORKS</u>, <u>FOR FAMILIES & FRIENDS OF ALCOHOLICS</u>, The Twelve Traditions, The Twelve Concepts of Service and a passage from Lois's Story as related in <u>PATHS TO RECOVERY</u>, Lois's story, were read by attendees.
- 4) Announcement of quorum: There were 7 voting members present at this meeting. That meets the quorum. (6 voting persons were present At the December 2007 meeting. By-Laws, page 4. 3 persons constitute a quorum as based on number of voting Directors at the December 2008 meeting.)
- 5) Reading of Minutes from the December 15th, 2008 meeting. Ann J. made a motion to approve the minutes as presented. Julie K. seconded the motion. All were in favor of accepting the minutes as presented.

## **CHAIRPERSON'S REPORT:**

Pat E. welcomed the new people. She passed out the Agenda for the meeting and flyers for the East Texas Assembly in Diboll. She also mentioned the meeting schedule for the AIC Board meetings and encouraged the members to contact her either by phone or email with any questions or concerns regarding the Information Center or items to put on the next meeting's agenda.

### **TREASURER'S REPORT:**

Lisa R-F handed out the following reports: The 2009 Budget, A spreadsheet of current financial transactions, a detailed breakdown of Petty Cash spending for 2008, and a breakdown of contributions. She pointed out that the interest rate on our savings had dropped. (report follows) A suggestion was made that the treasurer number the pages or put titles on the pages of the spreadsheets. Lisa agreed to do that.

The Southwestern Bell bill will be paid monthly from now on rather than yearly. That does change the overall amount but is more convenient.

The IRS and The Hartford Ins Company have both had incorrect addresses for the Information Center Office. The insurance is paid and current. Lisa had looked the current coverage we have with The Hartford Ins and reported we now have \$25,500. She thinks we may be over insured and is looking into bids for lower rates on \$10,000 and \$15,000 coverages. We generally have from \$5,000 to \$7,000 worth of literature in the office at anytime.

Pat E explained to the new, incoming board members that the 2009 Budget had been presented to the last board. The finance committee that had worked on this budget had presented it to the board. Now the new incoming board needed to vote to accept it. Judy W. made a motion to approve the 2009 budget. Paula H. seconded the motion. All were in favor of accepting the 2009 budget as presented. All were in favor. The motion carried.

Pat E. read from the By-Laws the statement that required that the AIC Board have a standing Finance Committee. Judy W. and Pat E. volunteered to be on the committee with the Treasurer, Lisa R-F. Lisa would be the Chairman of the Committee.
