7) **BUSINESS:**

OLD BUSINESS: Pat E submitted the following report as Liaison to World Service Committee from the AIC from the East Texas Al-Anon Assembly that met May 29-31 in Diboll.

Austin Information Center Liaison to Area World Service Committee ETAAA, Diboll, Tx May 29, 2009

I attended the East Texas Assembly in Diboll on May 29th. The main focus of the Spring Assembly to is hear the report from our Delegate Rosie M who represented Texas East at the World Service Conference in Virginia Beach, Va. In April 2009.

One of the main topics Rosie shared was regarding the Knowledge Base Decision Making which they use at the WSC and we also have been using this at our Texas East Assembly and our District 6 Meetings. The basics of this process is to have the discussion regarding a topic and after the discussion a motion may be presented and voted on by the Group Representatives. The old process caused a lot of confusion where a motion was made and voted on and then everyone did not understand what they were voting on. A lot on discussion came after the motion and most of the time the motion had to be amended.

Rosie explained that we were not using all of the process. An idea is presented at the Area World Service Committee meeting. If it seem feasible, the Chairman of the Assembly appoints a Thought Force that looks into the topic, researches the idea, looks through motions and past experience and brings their findings back to the AWSC. A Task Force is then appointed that looks into the feasibility of the action that needs to be taken and brings the results back to the AWSC. The AWSC then votes if this should be presented to the Assembly for a motion to put it into effect or if the motion fails there is no further action.

We will no longer have Regional Service Seminars put on by the World Service Office. We will now have T.E.A.M. (Together Empowering Al-Anon/Alateen Members). These will be put on by the Areas and maybe several Areas combine to put them on, e.i. Texas East and Texas West. We will be hearing more about these from our Area and Delegate.

New Motions that were approved at the 2009 WSC will be posted on the members website. When these motions are posted, you will be able to the WSO/members website and print out the changes to the Service Manual and insert the pages in your own 2006-2009 Service Manual.

E Cal, on the WSO members website has been on a three year trial basis. Due to lack of participation it was decided to discontinue the E-Cal.

The definition of a "Experienced Sponsor" in the Alateen Sponsor's Certification Process has been in discussion. The Area Alateen Coordinator along with District Alateen Coordinators and getting together to come up with a definition of "Experienced Sponsor".

Our Delegate, Rosie M who lives in Humble will be attending our District 6, District Meeting in July and give her report. I think the date if July 18th but I do not know the location of the host group; maybe Pflugerville or Wimberley.
