DISTRICT 6 ELECTIONS IN OCTOBER WE NEED YOU!

Sissy S. Story

I have been in Al-Anon since 1991. My birthday will be this coming September. I have been telling my story since I was the Public Outreach Coordinator. I found that my story is too long to tell at any one time. So this time, I will talk about growing up with alcoholism. I have spent many years in therapy and once I said to a therapist "You must think I am crazy", and she said "You are the sanest person I know, but I cannot figure out why". I finally figured it out. My first five years were pristine and THEN came the alcoholism. The first five years of a person's life are the most important and will determine a lot of their future life.

When I was five, my grandmother was hit by a truck. We went to another state to care for her for three months, and left my dad at home alone. When we came back, my dad was different.

By the time I was six, my life was upside down because my dad was drinking and my 12 year old brother was drinking. Things happened that I couldn't understand. Things got worse as the years went by, and by the time I was 10, things were really bad. I started going to church and soon was raped there. I have since found out that the kids from dysfunctional families are targeted. Watch your children; they are vulnerable and it is your job to keep them safe. It is far more important than caring for the alcoholic. I was a good victim because I never said anything. I knew my dad would kill someone and my mom would fall apart. I was in my 40s before I told anyone, even myself. That event caused me to make bad choices for many years to come.

The form asks for a requested date and an alternate date; my idea was to do it between July and September, 2012, which is halfway between the spring and fall assemblies. We will have time to talk about the details after the Area and World Service Office accept our request form. I am available to anyone who has questions or would like to volunteer to help with this project.

Finally, I want to remind everyone that our next district meeting in October will be our district elections. Secretary **DISTRICT 6 MEETING MINUTES** July 16, 2011 Hosted by Killeen AFG

The meeting was opened at 9:10 by Paula H., our Alternate District Representative, (in Shelley's absence) with a moment of silence followed by the Serenity Prayer. The Steps, Traditions, and Concepts were read. We all introduced ourselves. There were four Al-Anons present for their first district meeting. The Ask-It-Basket was passed. The Donation Basket was passed (amount collected \$128.00). Housekeeping announcements were made. A skit titled "Facing the Ghosts of Our Past"

was presented. It was about an Al-Anon group having elections at their monthly business meeting. No one wanted to accept a position because they felt they weren't good enough, smart enough, didn't have enough time for the position, afraid of failure, etc. The point of the skit was to face your fears and step up to the plate. This referred to our upcoming District 6 elections in October.

In place of our usual workshop, our Delegate, Rosie M., gave her report from the annual World Service Conference she attended in April in Virginia Beach, VA. Rosie's report will be in The Beacon.

The Business Meeting began at 10:30. Paula gave Shelley's District Representative report and her Alt. Dist. Rep. report. The other officers and coordinators gave their reports. Group Representatives. gave their reports. We dismissed for lunch at 12:06. There was a District Alateen Sponsors meeting held during lunch. The Business Meeting resumed at 1:07. A report was given on the May Assembly held in Round Rock. With the \$2000.00 seed money and the raffle money, \$3,981.30 was returned to the Area.

Jenny from the Killeen AFG made up a very helpful booklet for "Hosting a District Meeting". She organized all things necessary for putting together our meetings. Thank-you, Jenny.

Our next district meeting will be October 22 at St. Mark's United Methodist Church in Austin hosted by either Suburban Friends AFG and New Beginnings AFG or Georgetown West. DISTRICT ELECTIONS WILL BE PLEASE PLAN TO HELD. ATTEND. The following district meeting is tentatively set for Jan. 21st hosted by Suburban Friends AFG, New Beginnings AFG, or Georgetown West. If Georgetown hosts, it will be held at the Church of Christ on Highway 29 West. The January. date is subject to change based on the date of the January AWSC meeting.

Ask-It-Basket:

1. Question: Is there a good reference for the Fourth Step that is comprehensive but not complicated?

Answer: Your sponsor is your best reference, but if you're looking for reading material, Paths to Recovery is great. Blueprint for Progress is also good, but a little more complicated. Tally commented that her group has used the Blueprint for Progress for a meeting. They copy the questions, put them in a basket, and pass them out.

2. Question: What can we do to encourage people to keep coming back?

Answer: Here are some things that I have found helpful: When there is a newcomer, read the Newcomer's Welcome, then have one or two people in the group give a short discussion on why they started coming along with their experience, strength, and hope. Another is to give them a copy of a daily reader or the new soft back of Al-Anon Works with a Newcomer's Packet. You might also want to have some people volunteer to greet others at the meeting or have someone volunteer to talk with a newcomer after the meeting. Also, let the newcomer know that people will hang around to talk after the meeting. Once you know why a newcomer is there you can introduce them to a member who might have experience to share. Some groups have temporary sponsors. Some groups socialize after some meetings, e.g., breakfast once a month or luncheons. If needed. babysitting may be arranged. people to perform specific functions within the group in order to get them involved. Suggest that people read When I Got Busy I Got Better. Do a Group Inventory.

3. Question: How do I know when to surrender? When do I stop doing the footwork?

Answer: I surrender when my way (forcing a solution) is not working. I am trying to do it my way. I say the **Continued next page**

first three Steps to myself and turn over the problem to my Higher Power. My footwork is doing my partthinking before I speak is a big one for me. When I get a peaceful feeling, I know I have done all I can do.

How can we stop 4. Question: someone from dominating a meeting politely?

Answer: Make a sign requesting a time limit. One group has a bell they The chairperson may kindly inform the person that there needs to be time for everyone to speak. A Group Conscience can be called for. If all agree, that person could be talked to. Unity of the group comes first so boundaries can be set. commented that her group sets aside a ten minute discussion time at the end of the meeting for Newcomers.

5. Question: How do you handle difficult people or situations?

Answer: Personally? Use the acrostic STOP in a meeting: Sorry you feel that way, That could be, Oh!, and Perhaps! or Perhaps you're right. Tradition One: "Our common welfare should come first; personal progress for the greatest number depends upon unity." Tradition Two: "For our group purpose there is but one authority-a loving God as He may express Himself in our group Our leaders are but conscience. trusted servants-they do not govern." In a meeting, any disruption if serious, may be handled initially by a very low-key reminder that we are here for a "loving interchange of help among members" (Svc. Man. Pg. 11). "All Al-Anon discussions should be constructive, helpful, loving, and understanding" (Svc. Man. Pg. 24). Suggested Meeting Format The readings allow for insertion "specific routine for calling members". A Group Conscience can be held to determine a few words of reminder. I've attended groups with varying reminders such as: "Our group conscience requests that we

keep our sharing brief, that we do not give advice, that we do not judge others, interrupt, question, or comment on their sharing." Another experience I have had is that a group held a Group Conscience to decide what to say to an individual who was bringing into Al-Anon various political and religious ideas that were offending people. From the Service Manual: WSO or GSO can only offer suggestions by relating the shared experiences of other groups or by providing the appropriate references in existing Service Manuals (pg. 79). A healthy level of non-aggressive, assertiveness is helpful if it becomes necessary to remonstrate an individual with offensive behavior.

6. Question: How did you work your 8th and 9th Step?

Answer: In my opinion, this is a question that could better be addressed by talking to fellow Al-Anon members and/or one's Sponsor. Paths to Recovery is an excellent piece of literature that might help. Perhaps attending meeting that focus on the Steps would help.

7. Ouestion: Someone shared "12 Promises of Al-Anon" at one of our meetings. Are these World Service approved?

Answer: In Al-Anon, there are no promises. Read From Survival to Recovery pgs. 265-270 and the new Al-Anon book - Many Voices, One Journey. Paula reiterated that there are no promises in Al-Anon. We are already accustomed to promises being broken. Pat also confirmed that there are no promises in Al-Anon.

8. Question: Is there such a thing as Al-Anon chips?

Not officially. Answer: Check various gift shops or the internet. Also EBay and woodenurecover.com. Google: recovery chips. Refer to pg. 94 in the Service Manual. Pat said that Al-Anon doesn't sell stuff.

9. Question: How to get more participation in groups?

Answer: Avoid discussions of religion. Avoid gossip and dominance. Discuss

how to apply the Traditions and Concepts to one's personal life. LET IT BEGIN WITH ME. Courage to speak up. Use literature for experience, strength and hope solutions. Have specific topics such as a Step for each month or a Tradition. Use the "go around the room method" versus the "speak up method".

10. Question: My group is finding it difficult to get to the local service center to obtain literature such as newcomer packets. I know they can be ordered from WSO for mail delivery, but in the interest of supporting our local service center by obtaining literature there, what options are available for obtaining literature locally?

Answer: Call Kitty: 512-441-8591. Kay suggested have the Representative pick it up.

Pat E. commented that when an Alateen graduates into Al-Anon, it is nice to give them a copy of our Al-Anon book How Al-Anon Works. She had seen this done.

New Business:

Kay C. announced that the ATAAC (All Texas Al-Anon Alateen Conference) would be held in Austin in 2013 and 2014 at the Holiday Inn on Middle Fiskville Rd. by the old Highland Mall. Kay C. is the Chair. Carolyn K. is the Co-Chair and Shelley S. is the Secretary.

District 6 will be hosting a TEAM (Together Empowering Al-Anon Members) event in 2012. Input for topics of interest is needed from groups by September 1. The date of the event is between July and September, 2012 at the Wingate Hotel in Round Rock.

A Thought Force was formed regarding the use of Kristi Fund scholarships for attendance to TEAC. The Thought Force members are Steve J., Pat E., Chelsea, and Jayne G.



When I was 15, my dad got very sick and I spent the summer taking care of him. He was an angry man and very difficult. My brother came home for the summer. My brother took a 16 year old friend of mine and me out to a dance. He and my friend got drunk and I had to drive them home. It was 10 miles away from home on mountain roads (by Aspen, Colorado). I had never driven on a highway. I learned how that night. I was a care giver by then, so I tried to do most things really well.

That summer, my Aunt Dee tried to kill herself. She came to me and I got my parents. They called her doctor, and he said that we had to care for her because, if we took her to the hospital, everyone in our town would know. Mom had to go to work and dad was sick. My aunt had taken a whole bottle of Valium. I stayed up until about 5 am and kept her walking. She lived, and the next night we celebrated with a drinking party where she and my dad got drunk.

When I turned 16, I got a 23 year old boyfriend and a driver's license. I have pretty well been taking care of myself since then, except my mom was a strong person in my life and was always there for me.

My boyfriend was, of course, an alcoholic. We went out, he drank, we made out, and he passed out. Time, after time, after time. My family loved him and I loved him so much. We became engaged in my junior year of high school, and then hen ran off a cliff (drunk) on New Year's Eve, wrecked his 1964 Mustang convertible, and lost his license. He went back to college and I stayed to finish high school. Short story – he married someone else and I fell apart.

I went to college for three years and left to marry an alcoholic. I was married for seven years, had two kids, and then got divorced. Then I finished college at the University of Texas. This part of my story ends here. Except:

It took me a long time to realize how much my dad had taught me and done for me. He was not a daily drinker, so there were good times as well. He taught me that I was able to do anything. So today, I am a carpenter, electrician, and a businesswoman among other things. I watched many football games with my dad and learned to love the game. I am a fisherman and can camp as well as anyone. He taught me a lot about cars and how to do many things myself, which helped when I had no money.

He was my friend and my father who loved me. He was a very respectable man and had a very good character. I was always proud to be HIS daughter. I am lucky to have had him as a father.

My brother still drinks, and I still live him so much. He was always my big brother and no one could ever take his place. I still have to work at deciding when I should help him and when I need to get out of the way. But when he fell down and broke his neck (because he was drunk), I dropped everything and went to him as soon as I could get there. But when he got out of the hospital, I came home and let him get on with his drinking. I don't say anything about his drinking. I am proud to say that you taught me how to love him without taking his drinking personally. I now know that he loves me too. Thank you Al-Anon for that. Sissy S.
