Our Gift of Service Begins with Tradition Seven

How often do we hastily pass around the Gratitude Basket at meetings, hoping not to interfere with the personal sharing in progress? How often do we explain the different opportunities that members have to make a contribution? Do members understand that their donations are a financial investment in their own spiritual well-being?

As a non-profit organization, our financial contributions need to be more in balance with our literature sales. In 2011, the gross profits from literature sales totaled 65% of our income (\$3,354,000). Our AFG and personal contributions equaled \$1,206,000 from groups, Appeal Letter, birthday/memorial/individual, and bequests.

Many Al-Anon members aren't aware that they can contribute directly to the WSO, and often only contribute to the Quarterly Appeals by adding a dollar or two in the envelope --- that's only four times a year!

Why not encourage members to put a dollar or more in the birthday envelope for each year they have been in Al-Anon, or a group take up a collection to send to WSO for the group birthday? This is a way to show your gratitude for the years of serenity you have been able to have and a way to give



back. Another way to give a personal contribution is in the form of the memorial contribution. You can donate in memory of a loved one, family, friend, pet, etc., as long as it is sent by a member.

The birthday and memorial envelopes are free, so order some for your group, the next time you put in a literature order and then you will have them! This is one way to ensure that the hand of Al-Anon is always there.



Coordinator Reports

ALATEEN

This past quarter saw the 5th Texas East Area Alateen Conference held in Gonzales. We had five sponsors and four Alateens from our district attending. Our guidelines state that each sponsor is responsible for no more than five Alateens at events. Our district currently is the only one with male sponsors, so Steven stepping up to the plate allowed some Alateens from Houston to participate. We gave out three Kristy scholar ships - thank you District 6 for having this scholarship program! Some Wimberly folks are getting Al-Anon members to start a new meeting. That's great news, as our district has more Alateen meetings than any other district in our area. Yeah District 6!

I have been approved to present the Alateen Sponsor Workshops and I hope to be able to provide more training in the near future, so we can see Alateen bloom again in our area. Just let me know and we'll schedule something for everyone interested and invite current sponsors to come and share their experience, strength and hope. This coming November the Area Alateen Committee will be presenting a motion to rescind a previous motion to have Alateen Sponsors training available at Assembly. This came about as a realization from the work of the committee.

The Assembly Agenda Item reads, in part:

"In May, 2006, Area 53 voted that our assemblies include Alateen Sponsor Training. Our area's Certification/REcertification Process defines a Training Session as no less than a six hour training (or attendance at POSSE). Training has not been offered at Assembly because of the challenge of including Sponsor Training into the regular Assembly schedule. The Area Alateen Committee (AACmte) has evaluated the possibility of providing Sponsor Training at Assembly and has concluded that it is not possible to provide a complete six hour session and it is less than optimal to have the session split up, for example, by having three hours of training at each Assembly. The original intent of the 2006 motion was to make Sponsor Training more accessible to more members. Since the AACmte is also working on a recommendation that our area develop a system of additional trainers offering more training opportunities throughout our entire area, greater accessibility can be achieved this wav."

The Al-Anon/Alateen Committee is recommending to the Assembly that this policy be reversed, which would require a motion from the Assembly floor. I encourage all of you who will attend November Assembly to vote to remove this motion. If you have questions, please feel free to contact me.


Our lives, no matter how battered and degraded, will yield hope to share with others. We will begin to feel and will come to know the vastness of our emotions, but we will not be slaves to them.

BIG Thank You to all that supported the following accomplishments! Without you, Public Outreach would not be possible. If you are interested in getting involved, please contact Judy W. to express your interest.

- 1) Began a weekly Saturday Closed Parent's Meeting at the Phoenix Academy Juvenile Center on Saturdays. This meeting has 14 rotating members to support the parents of children attending the facility. In August, a member volunteered to be the primary contact and be responsible for scheduling. - 2) Conducted 4 panel speaking events for monthly Family Support Day Austin Transitional Center Family Day / Del Valle. This low-security halfway housing center provides clients with support systems for a 90 day period.
- 3) Provided one speaker to Hacienda Solutions on Family Support Day.
- 4) Supported three monthly visits to the Texas Civil Correction Drug Court to speak with families.
- 5) Held 2 three-panel member speaking events at Developmental Counseling Center, Inc for Client/Family Day.
- 6) Continued working with Kathy to identify five more snail-mail sponsors for the Women's Lockhart Prison system Al-Anon Wednesday meetings.
- 7) Provided literature for Al-Anon booth at "Cash on the Green", which was supported by the Independence Group Meeting on 45th Street.

AL-ANON DISTRICT 6 AREA DELEGATE REPORT

Report to District 6 from Delegate visit in July, 2012

I was asked to summarize my concerns, specifically related to my perception from attending the World Service Conference in April.

Here are my thoughts:

I will begin with a picture and conclude with some questions we - as members, districts and area - need to ask ourselves regarding which direction we see Al-Anon going, and whether we want to do anything about that (it even if it is only opening up a dialog to the membership).

My mental picture:

When I walked into the stable, from the outside it looked beautiful and clean and noticeably very quiet. Then I opened the door and noticed it was empty but all neat and clean with all the horse manure gone. My first question was, "Who opened the back door and let the horses out?"

In looking around, I noticed a sign that said "Please do not talk with others." That seemed a bit strange, but being a new kid on the block and knowing little about horses, I followed the orders given by the building owner. But it left me feeling very uneasy and a lot of questions that left nowhere for me to go for answers

Now I will try and state as simply as I can my perception of what I believe has happened over the past 15 + years with Al-Anon. We have reached a point where the Delegate's responsibility has become little more than being a cheer leader for the WSO and assisting in their money-raising efforts - hopefully to bring the fellowship back in compliance with the IRS, to be a non-profit fellowship, as we were in the beginning.

My passion and personal desire for Al-Anon is to keep it as inclusive to all members and allow them to be a major part of a large group conscience, regardless of how uncomfortable that may seem. I want to let everyone - even the minority opinion - be heard, and if necessary, have the problem discussed until an informed group conscience can be reached.

WACO

We are still in the black and receiving donations from other groups in the central TX area, individuals and two Waco groups to keep paying our bills. Our New Beginnings meeting on Thurs night continues to be hosted by one of our Waco groups and continues to have regular attendance by newcomers. We still get many calls on the pager and many of these callers end up at our Waco meetings. Cindy, Chair, AIS

We have become a select few (six - seven) appointed executive committee members having a discussion apart from the body and making Power Point Presentation or skits that are supposed to deliver the message of the "force" - with no motion or vote from the floor.

This process is called Knowledge Based Decision Making or KBDM. KBDM was adopted after the WSO hired a consulting firm and accepted their recommendation. Although this method has proven over the last seven years to make our procedures go faster and with less friction, what we have lost is the most important element - the voice of the membership from the groups up.

Let's also look at where this method is used extensively, mostly by educators and the business community. When I came into the program in 1983 the message from the WSO was very clear and though I was personally seeking recovery from the effects of living as a child in a home with a problem drinker, we were told not to dilute our program with recovery language, so our groups were very careful to not use recovery language in our meetings. Yes, I understand we have to do the business of Al-Anon at our Assemblies and the AWSC meetings, but why is it now recommended from the WSO that we transgress the same guidelines and use business language? Let me end this paragraph by expressing my greatest concern for the fellowship as a whole - Putting all discussion outside the motion deprives the majority of the membership the ability to express their concerns or knowledge of the subject.

Bottom line – the corporation – AFG, Inc., is intimating that they know better what is right for the Fellowship and that we are not adequately informed to "govern" ourselves. The question to ask: is that true? Because if we continue to allow them to take away our voice then we deserve the outcome.

My fear is that I see a pattern of indifference being promulgated in the Al-Anon fellowship. Plato said: "The punishment of wise persons who refuse to take their part in the affairs of government is to live under the government of unwise persons".

Suburban Friends AFG



Q: How do we communicate non-WSO (World Service Office) events like ATAAC?

A: For non-WSO events, refer to pg. 52 of the Al-Anon/Alateen Service Manual:

"Tradition 6: Our Family Groups ought never endorse, finance or lend our name to any outside enterprise, lest problems of money, property and prestige divert us from our primary spiritual aim. Although a separate entity, we should always cooperate with Alcoholics Anonymous."

It is important to remember that we only announce Al-Anon/Alateen events in our meeting. Events that can use the Al-Anon name and logo are connected to the Al-Anon links of service (district, area, WSO). Because of our special relationship with AA, those AA events with Al-Anon and Alateen participation can be announced, but at an Al-Anon meeting or meeting location, groups do not announce or discuss activities of other anonymous Twelve Step programs.

Publicizing events of other organizations creates an appearance of affiliation, even if the event is composed primarily of Al-Alon or Alateen members. Note that in order to use the name "Alateen", any event with Alateen participation must have a connection to the Al-Anon Area in which it is held, and have event requirements that meet or exceed the Area's Alateen Safety and Behavioral Requirements.

For non-WSO events, speaking outside the meeting room with friends and stating it is not an Al-Anon approved event is appropriate. For the sake of anonymity, e-mail announcements should be avoided. In personal or phone conversations about the event, protect anonymity best.

Q: Where can I get the map of out District?-Like the one at the registration table.

A: In the latest BEACON-The East Texas Area Al-Anon/Alateen Newsletter-or online at http://www.texas-al-anon.org/

Q: In the service manual it speaks of charging extra for literature to meet needs of district. At a group level is it also acceptable to charge more than cost and what amount is reasonable?

A: See page 211 of the Service Manual. Haven't heard of it being done locally, so have a group conscience to decide how much extra your group might charge. Encourage members to increase their contributions (\$1.00-\$8.00). Personally, we think this is a spiritual program and keeping it accessible to all is vital.

Q: What are examples of non-conference approved literature materials and can they be used at Al-Anon meetings? Also, can we offer AA material at Al-Anon meetings?

A: See page 101 - use of materials at Al-Anon meetings. To keep Al-Anon's message, the focus and encourage unity only Al-Anon/Alateen conference approved literature (CAL) and Al-Anon/Alateen service tools are displayed, distributed, and used at Al-Anon/Alateen meetings, including meetings at conferences and conventions.

Page 100 - Identification of Al-Anon/Alateen publications "CAL" look for the seal at the bottom of page 100.

Page 99 - How does it become CAL?

Page 56 - Conference approved literature is written by and for members.

Page 101 - AA literature is not used at Al-Anon meetings because it is written for and from the view-point of Alcoholics and is not Al-Anon/Alateen Conference Approved Literature. Reliance on opinions expressed in AA and other outside materials can distort the Al-Anon approach.

Get and read the two pamphlets P-53 <u>Al-Anon Spoken Here</u> and P-35 <u>Why Conference Approved</u> Literature?

PERSONAL OPINION BY THE PERSON ANSWERING THIS QUESTION: I find the big book very interesting and helpful to understand the alcoholic. But I need to be careful when reading it, because it brings out my need to focus on them, not me. My job is to focus on me and fix only me.

Q: Knowledge Based Decision Making (KBDM)? A brief description please.

A: KBDM ensures that every voice is heard. Thorough discussion takes place before voting on an issue. Motions are made and seconded after discussion, then the vote takes place. The group can decide whether a majority or two-thirds vote is acceptable. Nancy M., our East Texas Area Al-Anon/ Alateen Delegate will address KBDM and she will talk about it at the Area World Service Committee Meeting in September. Look at the World Service Conference Summary 2009.

Q: Another Al-Anon does not respect my boundaries. What can I do?

A: This is a guestion that could be discussed with a personal sponsor.
