## Anna's Story


My husband's drinking really progressed after he retired. He had a lot of time on his hands and a lot of resentment, which the alcohol numbed. It was also killing him. When he woke up one day and couldn't walk, he decided on his own that it was time to do something. I was out of town, and in a day, our daughter had helped him get into a detox facility. By the time I got back, he was ready to go into in-patient treatment. My sponsor once said to me, "Isn't it amazing what happens when we step aside and let our Higher Power drive?" It was true. I had nagged my husband for months to do something, and it all happened when I wasn't even here.

My husband went into in-patient treatment and was doing well. I went to visit him on a weekend, and visitors were told that if we wanted to stay for dinner, we would have to attend the Al-Anon meeting while the clients went to their AA meeting. Since the burritos they were serving that night sounded tasty, I decided to stay. I went to the meeting and thought, "What am I doing here?" They're talking about God (I hadn't been a practicing Catholic for years), trying to sell me books (sounded like propaganda), and not handing out the instruction manual on how to get my husband to stop drinking. I was even willing to take the abridged version ("How to Get My Husband to Not Drink Again") since the treatment center had been successful in getting him to stop. I left the meeting, had my burrito, and came home. I didn't give Al-Anon a second thought.

I was back the next weekend to visit, and it was déjà vu. If I wanted to stay for dinner, I had to go to the Al-Anon meeting while he attended the AA meeting. Thank goodness this place had good food. Italian cuisine was on the menu this week, so to indulge my LOVE of pasta, I went to the Al-Anon meeting. I was sitting there thinking about what groceries I needed when they handed out the list of Al-Anon Dos and Don'ts. It was my saving grace - the first time I had the thought that maybe I had issues, too. Before then, I blamed my husband for everything. He had the problem; he was causing all my problems; and he needed all the help. That list is what made me come back. Now, I have so many more reasons to keep me coming back, like this wonderful fellowship, the literature (that I so resisted at first), the opportunities to serve, and the life tools to get me through each day because even without active alcoholism, every day can be a challenge.

## **Delegate Report**

Thank you, District 6, for allowing me the privilege and honor to serve as your delegate at the World Service Conference, the largest group conscience. Your love and support with cards, letters, texts, phone calls, prayers and gifts was amazing. Thank you for handmade love gifts and candy for sharing with other delegates to carry back to show this is a worldwide fellowship of gratitude.

"Living Our Spiritual Principles – Expanding our Vision." This theme of the 2015 World Service Conference (WSC) encouraged us to dream expansively while being guided by our spiritual principles. There were many discussions and decisions that were balanced by what is best for Al-Anon Family Groups worldwide – now and in the future – that demonstrated compassion, generosity, and understanding.

The Board's big question to Conference members was "How do we envision responsible service leadership in Al-Anon — a vision that inspires today's members to be tomorrow's leaders who are motivated by spiritual principles?" What is your area doing to prepare our leaders of tomorrow?"

A Thought Force presented strategies to Spiritual Connection of being a registered group — **Unity**, **Accountability**, **Responsibility**, **Participation**.

The Finance presentation asked us to dream and then presented a process to help areas build a plan to make their dreams come true. As the Conference dreamed about the future needs of the fellowship and services provided by the World Service Office, a deficit budget was approved with trust in Spiritual Abundance. Average cost of services by WSO per group is \$285.67. Average US/Canada group contribution was \$118.01. By groups contributing only \$5.50 more a year, the \$52,000 deficit could be covered. For only \$20 more a year, the entire budget would be covered, and \$25/year more (that is \$.50 per week) would cover the entire budget plus extra for carrying the message. Big Dream – Abundant and Grateful Giving.

The Conference affirmed by consensus for the WSO Policy Committee to draft language for a proposed policy change to allow family members to make a one-time memorial contribution in memory of a deceased Al-Anon member with safeguards as a spiritual gesture of love and gratitude, not a monetary contribution intended primarily as financial support.

"Meet the Board," currently in a three-year trial basis from 2013-2016, is an opportunity for local Al-Anon members to meet and interact with the 19 trustees and three Executive Committee members. Area 53 will be submitting a request for October 2016 on or before the deadline of September 15, 2015. If accepted, further details will be shared as they become available.

Conference members approved the following description of family recovery to be used in outreach to professionals: Family recovery is a process of healing and growth for family members affected by someone's drinking. This process helps these individuals make healthier life choices and develop relationships that are more positive and supportive.

During the conference and open board meeting, there were conversations about the current model of Alateen and whether this is the best model for the future of both Al-Anon and Alateen. The focus was on finding ways to encourage more attendance and participation by teens to ensure the future of Alateen. An overview of the home page for the Alateen web site was also presented. Details can be found on this link.

**AFG Connects** was announced during the WSC. This communication system will replace e-Communities and is more user-friendly. The Conference gave approval to allow Al-Anon members to sign up to receive general announcements when it is feasible.

A more comprehensive report of the WSC can be found in the 2015 World Service Conference Summary when it comes out in late August or September. It will be available in hard copy or can be viewed and/or

## Ask It Basket July 18, 2015

- Can our group have two GRs, meaning co-GRs? Joint GRs?
   Answer: Please see Page 146 in the service manual, "Election of a GR and an Alternate."
- How long must an individual be a member of Al-Anon to qualify for a GR position?

**Answer:** The answer is not really found in our service

- manual; however, on Page 133, general information can be found under "Group Representative." A member does not have to be in Al-Anon any length of time, only willing to serve as their group's GR and not be a member of AA, "subject to the dual member policy."
- 3. What are examples of great things

groups have done or are doing? **Answer:** Public outreach can occur at all levels — working with the district coordinator, doing whatever the group wants to do, or taking individual initiative. Health fairs, delivering literature, etc. all count as carrying the message. One group used Craigslist to announce their group's location. See GR reports for more information.

## Ask It Basket (cont'd)

4. What kinds/types of announcements shall I make to the group as group representative?

Answer: 1) Additions to phone and e-mail lists; 2) news about members (i.e., health updates); 3) news from district and area meetings, announcement of upcoming meetings, public outreach activity, and distribution of *The Forum*, newsletters, etc.; and 4) occasional reports on group finances (e.g., need to contribute to WSO).

5. What is the best way to conduct a group inventory and do you find it helpful?

**Answer:** Please see the service manual, Pages 53-55, especially Pages 54-55. Useful information on Page 54 (first three paragraphs) and Page 55 (second and third paragraphs). *Taking a Group Inventory* (Guidelines 8a & 8b) can be found on the Members' Web site. Can allocate 10-15 minutes per meeting over course of several weeks.

- 6. We are discussing how much of a prudent reserve to have. What guidelines would be helpful?
  - **Answer:** See the service manual, Pages 271-276, "Concept Twelve" and "Warranty One." G-41 is available on the Al-Anon Member's Web site.
- 7. Can an Al-Anon group put an ad in its local newspaper for its meeting?

**Answer:** Yes. See the service manual, Page 112, "Paid Advertisements" and "Publicizing Meeting

Locations." Also read Page 109 on attraction vs. promotion and cooperation vs. affiliation. Most newspapers allow for free community service announcements.

8. Is there a definition for crosstalk?

Answer: Crosstalk is a professional or treatment center term. It's not addressed in the service manual. However, there have been several WSO publications like *The Forum*, *Inside Al-Anon*, and conference summaries. Two familiar examples are: 1) A member shares, and others in the group comment on the sharing; and 2) During a meeting, there are other conversations among members, which are very distracting. It is up to each group to define crosstalk for the group.

9. Any ideas on how to boost attendance? Our group has few people coming in the summer.

**Answer:** Twelve Step calls, contact between meetings; share chair; rotate meetings on Steps, Traditions, discussion, and speakers; and invite attendees for fellowship after the meeting.

10. Our group meetings are large. Even though it is recommended to keep sharing at two to three minutes, we're having long shares. Recommendations on keeping shares to the requested time? Timers?

**Answer:** Either use a timer or if possible, split the large meeting into two group meetings.

## **Information Service Centers**

### **Austin AIS**

The Austin Al-Anon Information Center is doing well financially. We are in the process of defining our ample reserve, and more work may be needed on the by-laws regarding this topic. More information will be discussed at the August 18 board meeting. Currently, the information center has \$2,000 more revenue than a year ago.

To make the center information more accessible to groups, documents from the board meetings can be posted on the Austin Al-Anon Information Center Web site at <a href="https://www.austinalanon.org">www.austinalanon.org</a>. Minutes are currently posted.

A policy regarding Al-Anon literature sales to AA conferences with Al-Anon participation was voted on at the May 18 information center meeting. Literature can either be purchased by the AA conference, or if the information center employee knows the Al-Anon liaison to the conference, literature may be distributed to that person with a signed agreement.

The rent at the current location is being raised. At the August board meeting, discussion will take place on either to approve the new rent or to look for another location for the information center.

Also at the August board meeting, the possibility of obtaining Internet for the information center will be

discussed. Currently we have only a phone, an answering machine, and a fax machine. Kitty G., our information center employee, does a fantastic job of keeping the center running efficiently.

This is the only booklet you need at a meeting as it has all the latest wording for the various readings each group has adopted. It can be a great substitute

for that outdated notebook many groups are still using. If you are reading the opening, the Steps and Traditions, and/or the closing from something someone typed up or copied a while ago, your group may not have the correct or current wording. It is also important for members to know that copying our literature may be in violation of the copyrights Al-Anon Family Groups hold on our literature, The Forum, and service materials/tools (see the current Al-Anon Alateen Service Manual, Page 106, for the exceptions to this policy).

Groups at Work (P-24) is sent to each new group anywhere in the world that registers with the World Service Office (WSO). This booklet is available in many languages and is often carried by our members when they visit a new area or country where Al-Anon does not have a presence. Just think, every meeting, every day, around the world opens the same; we read the same Steps and Traditions, and we use the same closing, even though our closing thoughts or prayers may differ. In the opening format, there is a time for optional readings, which are all included in this booklet and can be wonderful topics discussion. They include "Anonymity," "Three Obstacles to

Success in Al-Anon," "Four Primary Ideas". and favorites. my "Understanding Alcoholism" and "Understanding Ourselves" from Understanding Ourselves and Alcoholism (P-48). You might be surprised at is not what recommended that meetings often use.

This booklet sells for \$1.10. encourage each group to purchase enough for every member to use to follow at meetings, as well as a few extras for members to purchase. Hope for Today meets every Monday at 3:30 P.M. in the


