### My Story

I grew up in a volatile alcoholic household with lots of secrets. It was safer to be invisible, and I can do that very well. I used to be so ashamed and embarrassed that I don't remember very much, but now, I consider that a simple blessing.

I got married young to an alcoholic. That's what we often do. I've read that spouses of alcoholics tend to be either overly responsible or irresponsible - either solving the alcoholic's problems or expecting the alcoholic to solve ours. I did both to avoid examining my own behavior. My marriage was short and awful. I was a victim before but can now understand and admit my role in the relationship. As it ended, I was crushed at my failure and terrified to be on my own.


After a time, I fell in love and married again. My husband was an alcoholic in recovery, and I thought all would be well. He did not stay in AA. Our marriage didn't work. He was not sober, and I was not sane. I continued to try to fix, and control, and fail. Although I loved him, we could not remain together, and I left to raise our two sons alone.

For as long as I could remember, I'd wanted more than anything to be a mom - of six. That wasn't meant to be, and when I lost babies, I felt a pain so deep I was sure I couldn't survive. I used to believe that grief was wrong and somehow diminished me. I know now that I can feel many different emotions at the same time, and none of those feelings are wrong. They're just part of what makes me a whole individual, and I have the beautiful gift of four little angels. They're fond of sitting on our shoulders and have often done so. Somewhere along the line, during those raising-the-kids-alone years, I came to accept that God truly didn't give me more than I could handle.

I became very self-critical as I started to see my part in the poor decisions I'd made. I never regretted having my sons, but I wished that I had waited, finished college, grown-up, healed-up, and learned how to be so much better and so much more. When I was 28, I learned I couldn't have waited to become a mother after all. I came away even more grateful to have my boys and with some understanding of "God's time."



## My Story (cont'd)

I'm still struggling to find my place in the world, and I get frustrated when physical limitations slow me down. Some days, I'm not capable of doing a lot. Sometimes, it takes all I've got to be patient and kind and giving to my own family - just to attend to everyday things. Often, I fail even at that. Those days, I have to remember to simply do the best I can.

Our pantry is always full, to assure me that we are indeed provided for. I am still frightened of angry people and overly sensitive to personal criticism. I fight my tendencies to isolate, and it took me a long time to get accustomed to being greeted with hugs.

My husband and I spent years apart before he came back into our lives. It took many more hard loving years, both apart and together, to work out this relationship. We remarried on his fifth AA anniversary, almost 20 years ago, and it's been very healing for our sons to see us love and forgive one another. It isn't always easy, but I've

pretty much recovered from my childhood, personal losses, and financial insecurity to emerge with sons who have gratitude and compassion. These struggles may always be with me to some extent, but there has been a lot of healing. I'm happy. I'm playful. Most of the time, I feel peaceful, as if I've led a life very different from my own. Today, my life is filled with miracles, gratitude, hope, and a desire to share them all.

Before Al-Anon, happiness was a blessing I doubted I deserved and never believed I would receive. I'm grateful more than I can tell you - for a relationship with my Higher Power, for my family, my friends, our program, our home, and every bit of my past and present.

And...I am truly grateful for you. There are so many ways alcoholism has affected each of us. We bring our brokenness, and because we're in community with each other, we continue to heal and recover.

#### **District Representative**

The AWSC meeting to plan for the fall Assembly was held on Saturday, August 8, in Houston, TX. Highlights from the meeting include:

- District 2 (Corpus Christi area) is continuing to prepare for the fall Assembly, scheduled for November 4-6. The theme is A Sea of Miracles. Volunteers to lead a bilingual workshop are being requested.
- Flyers for the All Texas Al-Anon/Alateen Conference (ATAAC) were handed out and are available on the Texas Web site. Dates are February 17-19.
- District 4 (southeast of Houston) is preparing for the spring 2017 Assembly. Registration before May 9 will be \$30 and \$35 after. Since 2017 is an election year, a job fair is planned for this Assembly.

- District 6 gave an update on our current plans for the fall 2017 Assembly, which will have a theme of *Elect* to Serve since this will be the election Assembly closing out the Area officers' and Area coordinators' terms at the end of 2017.
- The Al-Anon Alateen International Conference (2023) is looking for locations on where to hold this event. Both San Antonio (District 12) and Houston (District 5) gave updates on their preparation to submit bids by the September deadline.
- Be sure to read your Beacon newsletter before the fall 2016 Assembly because there will be several items to vote on by the GRs. Among the voting topics will be: Moving some counties between the districts to better balance the districts and spending surplus Area funds among the East Texas districts via the Public Outreach sub-teams' recommendations. Judy will give more of an update on the public outreach activities at the District 6 October 2016 meeting.

Secretary's Report-Meeting Minutes July 16, 2016 Hosted by Spiritual Awakenings AFG, Hope for Today AFG, and Serenity Seekers AFG

Lori L., district representative, called the meeting to order at 9:05 A.M. and thanked the host groups.

Marilyn C. welcomed everyone.

A moment of silence was observed, followed by the Serenity Prayer and the reading of the Three Legacies. The Ask It Basket and donation basket were passed, with \$111.00 collected.

After introductions, Marilyn C. presented the video *Lois W. and the Pioneers*. A discussion led by Genise H. followed, with members sharing their thoughts and impressions of the video, their experiences in service, the joy of service, and why they continue to be of service.

At 10:31 A.M., a break was taken until 10:50 A.M., when the business meeting began with the officers' reports (Page 4).

Alice M. asked if there were any corrections or additions to the April 16, 2016 minutes as printed in the "Summer 2016" *District 6 Newsletter*. There were no corrections or additions. The minutes were approved as printed.

Lori L. advised that the Spanish Coordinator and Alateen Coordinator service positions are still open. Kay C. shared that being a coordinator does not require a lot of time, and Jayne G. shared on the benefits of being an Alateen coordinator. Pat E. was recognized for her 22 years of service as an Alateen sponsor.

The coordinators' reports followed (Page 10). Anna A. announced that the newsletter submittal deadline is August 15. The meeting broke for lunch at 11:30 A.M.

The business meeting resumed at 12:38 P.M. Alice M. called the roll. There were 49 attendees, with 26 voting GRs.

The Ask It Basket questions were answered (Page 6).

**Old Business:** Peggy H. advised that approximately 300 Alateen posters have been distributed to middle schools and high schools, including posters being displayed in Cedar Park and Bastrop at the beginning of the school year. Nancy B. volunteered to distribute posters to Taylor and Copeland schools. A volunteer is needed to distribute the posters to Georgetown and Leander schools. Peggy H. asked for a volunteer to coordinate the completion of this project as she is unable to do so.

Lori L. advised that she had received a suggestion that the skit/workshop portion of the district meeting be eliminated to shorten the district meetings. A lengthy discussion followed on the pros and cons of the suggestion. The consensus was to keep the fun skit/workshop part of the district meetings.

## Ask It Basket July 16, 2016

1. Is it against Al-Anon principles or other rules governing registered Al-Anon groups to use materials other than CAL or the Big Book of AA during Al-Anon meetings, either reading material or other things ("props" used by chairperson to demonstrate a point)? If not, is there something that can be voted on by the group in a group conscience (i.e., to approve or disapprove use of other material)?

**Answer:** See Pages 102-104 of the *Al-Anon Alateen Service Manual* (Page 102 – "What It Is";

Page 104 – "Use of Material at Al-Anon Meetings"; Tradition One – for group unity, common vocabulary brings unity).

- Can an Alateen sponsor be a dual member (both AA and Al-Anon)?
   Answer: Yes, as long as the person meets the following qualifications: active for two years in Al-Anon, passes a background check, and completes Alateen training.
- 3. Concerning crosstalk where in the literature is there information?

Answer: Crosstalk is not an Al-Anon term. It comes from treatment centers. There is an article in *The Forum* addressing "Loving Interchange" in Al-Anon, which is the preferred practice.

4. Our group is considering replacing photocopied Twelve Steps/Twelve Traditions with Al-Anon Alateen Groups at Work. How did (or didn't) this work for your group? Answer: A lot of input from various groups on how to introduce the small booklet, P-24, instead of the binder.

## Al-Anon Information Service (AIS) Centers

#### **Austin AIS**

The Austin Al-Anon/Alateen Information Center (AAIC) Board Meeting was held on August 30, 2016 at 2809 Northland Dr. in Austin at 6:30 P.M. Twelve voting members were present as well as several non-voting members. The minutes from the May board meeting, submitted by Secretary Charlotte T., were approved as amended.

Joyce L., AAIC chair, reported that she and Peggie F., AAIC treasurer, opened a savings account, as authorized by the Board. A new phone system was purchased since there were problems with the old system. There is now a capability for people to leave messages on the new answering machines so that their calls can be returned. The phone bill for the information center is over \$90 per month, and there is a possibility that it can be renegotiated to a lower price in January. Joyce also completed revisions to the information center office manager guide and gave it to the AAIC office employee and her assistant to review.

Peggie F., AAIC treasurer, reported that the information center's current operating finances are adequate. However, there is not a sufficient ample reserve. A motion was made and passed to put a portion of the embezzlement repayment into the ample reserve. The amount that was voted on to put into the ample reserve was \$3,860. To date, the amount repaid from the 2012 embezzlement is \$36,630; the balance owed is \$19,497.94. Repayments are being made monthly.

Kitty, the AAIC employee, gave a report on literature sales, donations, walk-ins, and calls from the last 71-day period. Literature sales and donations are slightly lower than the previous period, but out-of-town sales and sales from walk-ins have slightly increased. A literature inventory was conducted, and the total from that inventory was \$8,694.21. Here is a complete breakdown of calls and walk-ins to the information center in the past 71 days: May – 33 calls and 27 walk-ins; June – 67 calls and 35 walk-ins; July – 88 calls and 49 walk-ins; and August – 76 calls and 35 walk-ins.

At this time, I need to amend my April 2016 report regarding the information center walk-ins and calls. I reported that

calls and walk-ins might have increased due to the Al-Anon/Alateen posters that were placed on Capital Metro buses. However, in looking at the data from June 2015 to June 2016, it appears that the calls and walk-ins were around average for January 2016 to April 2016. Therefore, it cannot be specifically determined that the calls and walk-ins were directly due to the Capital Metro bus posters.

A motion was made and passed for the treasurer to conduct a comparison of literature sales from the last five years and to give a report at the next board meeting. A Chair is still needed for the Volunteer Committee. Full documentation regarding the Austin Al-Anon/Alateen Web site is available at the information center if another web site coordinator is needed in the future.

There was quite a bit of discussion regarding the use of technology at the information center. Two computers and supporting equipment have been donated; however, at this time, the center does not have Internet access. Therefore, a technology committee was formed to research the feasibility of having a computer and Internet access available in the future. Group input is wanted regarding this issue, so groups can send their input to the committee; committee members are Joyce L., Gail, and Julie.

Several items were tabled until the November board meeting. Discussion on how to promote literature sales, extending information center office hours, and how to determine the underlying issues regarding group participation in the information center were all tabled. Also tabled were sending out another appeal letter and record retention for items such as sales tickets.

**IMPORTANT!!!!** OFFICER ELECTIONS FOR CHAIR, TREASURER, AND SECRETARY will be held on November 14, 6:30 P.M., at the Austin Al-Anon/Alateen Information Center at 6301 Manchaca Rd. All groups are encouraged to attend this very important meeting and to share the information that follows with your groups.

A motion was made to consider changing the by-laws to extend the term to possibly three years. A printed motion regarding this possible change in the by-laws will be distributed at the meeting on November 14 at 6:30 P.M., prior to the regular business meeting. Board members will vote on the motion during the regular business meeting.

- 1. Must by 18 years or older.
- 2. Must have attended Al-Anon/Alateen meetings regularly for two years.
- 3. Cannot be a member of Alcoholics Anonymous.
- Must be either a current board member OR must have attended at least two board meetings in the past.



Lois Remembers, B7, is an autobiography written by our co-founder, Lois W. Lois was quite adventurous, and after she and Bill were married, the adventures did not end. Lois did not really want to do anything except work in her flower gardens and make a home for Bill and herself. She was sixty-five when she finally succumbed to Bill asking her to do something for the families of alcoholics. The book has a lot of information about her love, the home Bill and Lois called Bil-Lo's Break and later known as Stepping Stones. She also tells of the early days of Family Groups meeting and coming to be known as Al-Anon Family Groups.

- 1. Go to the Texas Al-Anon Web site at www.texas-al-anon.org.
- 2. Click on the "Members" tab.
- 3. On the "Members" page, type in "anonymity" (without the quotes) for the password.
- 4. On the next page, scroll down and click on the "Access Area 53 (Texas East)" hyperlink, just above the state of Texas image.
- 5. On the Texas East page, scroll down to the "Group Representative (GR) Information" section and click on the hyperlink in the "Texas East Al-Anon Registration/Group Change Forms" bullet. This will take you to the change form, and at the bottom, you will see Candy N.'s contact information. You must turn the form in to her to ensure your records are up-to-date with WSO. This should also ensure that your group receives a printed copy of the *District 6 Newsletter* and the Area newsletter, *The Beacon*.
