## My Story (by Kitty) Reprinted from Spring 2009 in memoriam

I was not raised in an alcoholic home. However, the disease was abundant on both sides of my family. My father's father suffered from the disease. He lived with us for a short period of time when I was about nine. I didn't "like" him because he stank of five-cent cigars and he would come in while my sister and I were listening to the Green Hornet on Inner Sanctum on the radio. He would switch the stations! All of 4' 11", my mother would storm in and make him change it back. When he would leave in the mornings and come home, staggering and falling down, my mother gave my father an ultimatum, "him or me". My grandfather left.

On my mother's side, it was her brother – my favorite uncle and Godfather. He was a good man who became very sick and was found dead in the gutter. None of this really affected me. I had a happy upbringing. Everything pretty much went my way, so no need for negative emotions.

Then, I got married! How dare everything not go my way! I remember the very day Resentment and Self Pity reared their ugly heads, and I felt that I had every right to it. I remember one day when I was feeding my little girl. She dawdled over her food and I screamed at my precious child. It never occurred to me that my negative feelings were caused by ME!

I didn't have Al-Anon in my first marriage, and his drinking did bother me. Ten children and 21 years later, I divorced him. I remained single for five years, and lucky me, I found a second alcoholic to love (and rescue, try to control, ad nauseum).

I saw an advertisement on television about Al-Anon and was at a meeting the next day. Al-Anon members gently opened my eyes to my defects by sharing their experiences, strengths, and hope. Al-Anon made available the "tools" of the program and helped me work the steps to the realization that I am powerless over other people, places, and things. Al-Anon taught me that I get insane if I try to control and made me realize that only with the help of a loving, caring Higher Power and by working and walking the program, can I achieve peace and serenity.






#### From the South

## Officer Reports

# District Representative – Judy

There is not a lot to report on since the July District meeting. There are two projects active in the district and folks wanting to get involved in service (carrying the message) are needed; especially to assist with the poster project. Our two active projects are:

- 1) Al-Anon Faces Alcoholism (AFA) Pamphlets: Groups attending the April district meeting collaborated to request and take pamphlets into their group's area for individual public outreach action. A total of 800 English and 100 Spanish pamphlets were ordered, divided and are now being sent to group representatives. I am looking forward to hearing how the groups are planning to use these for their public outreach efforts.
- 2) Alateen Posters in District Schools: At the July district meeting, \$1500 was approved to . complete Round 1 of distributing posters/pamphlets into the ISD's high schools within District 6. This motion allowed us to order enough packages for 400 more schools. We have distributed about 50% of the ISDs identified in round 1. I do not know how many schools are in each ISD that has not been distributed? I

need help to identify the ISD information (SHAC and school name/counts), before we can do the next step; distribution. Currently, the 800 posters and 40,000 pamphlets order was placed and received. Public Outreach North Coordinator, the Information Center, and our Alternate DR is helping divide the pamphlets into 100 pamphlet grouping, but more help is still needed. Spanish Coordinator is working to identify schools with over 10% ESL students so that Spanish poster may supplement those school packages.

The AWSC meeting is scheduled for September 8 in Corpus Christi. Agenda items include discussing officer and coordinator job responsibilities, updating the assembly guidelines (to assist hosting districts), and preparing the Fall Assembly agenda.

Secretary's Report **Meeting Minutes** July 21, 2018 Hosted by: Wimberley AFG 956 FM 2325 Wimberley, TX 78676

Judy W., District Representative, called the meeting to order at 9:06 A.M. and thanked the host group. Mimi welcomed everyone.

A moment of silence was observed, followed by the Serenity Prayer and the reading of The Twelve Traditions, Twelve Concepts of Service and General Warranties of the Conference. Judy W. welcomed several new GRs.

The officers' reports followed. (Page 3)

DR, Judy W., presented her report, first asking for support for the October 20, 2018 District Meeting's Serenity Trail AFG as well as for the January 19, 2019 District Meeting hosted by Bee Caves. She announced the April 20, 2019 District Meeting will be on the fourth Saturday. She then encouraged everyone to see and take a love gift from the Baltimore WSO Conference. Last, she presented new literature and summarized her experience at the WSO Conference. The theme was "Be yourself, everyone else is taken."

Secretary, Doon R., asked if there were any corrections or additions to the April 21, 2018 Minutes as distributed electronically by the DR prior to the July 2018 District Meeting. There

Treasurer, Robert G., presented the 2018 District 6 2ndQuarter Operating Statement (Page 7) and announced his intention to encourage groups to have GRs and participate. WSO, District 6, Area 53 and the AAIC are our service arms. The Seventh

Tradition pamphlet and Service Manual help groups determine where to donate funds. The Coordinators' reports followed. (Page ) Raffle gifts donated by Paula H. were presented.

Anna A. gave the AAIC report for Info Center Liaison, Cathy K.

Judy W. would like soft copies of Minutes in advance to distribute to GRs. She encouraged Reps to see to it that their groups have GRs and to make sure to provide her with their e-mail addresses.

Reports resumed. The Newsletter submittal deadline is 8/20/18. The Ask-it-Basket was passed. Kay C. answered a question about the difference between the WSO meetings list vs. the Austin Information meetings list. The only meetings WSO lists are those which are registered and active. WSO weeds out meetings from which communications are returned to sender.

Everyone enjoyed a skit presented on "3Cs, slogans and tools of the program" by Cleve R. (manipulator/authentic), Jill J. (martyr/acceptance), Marian S. (controller/let go), and Steve S. (people pleaser/self-care). Doon R. called the roll. There were 44 attendees with 25 voting GRs, a simple majority being 13 votes.

#### **New Business:**

Alateen Coordinator, Bill W. spoke regarding the 2018 Alateen Training Budget. Robert G. stated that so far this year we've spent \$204 on AMIAS were no corrections: The Minutes were approved. training. LaDonna C. moved -- To approve \$500.00 for Alateen training for the 2018 Budget. Mary R. seconded the motion. The motion passed unanimously.

Anna A. presented information regarding sharing the cost of the website with the Austin Information Center. The AAIC has been paying \$207.00 per year. Jennifer M. moved – That District 6 budgets \$100.00/year to give to the Information Center to offset the cost of the austinalanon.org website. Peggy D. seconded. The motion passed with 23 votes in favor, 1 against, 1 abstention.

Anna discussed adding a Spanish tab to the AAIC website. We would take care of translation; the AAIC would take care of posting. We would hand over the information to the webmaster. The District has approval from the AAIC Board to proceed. Judy W. asked for volunteers for a Thought Force to define what information is to go on the Spanish tab of the AAIC website, and present their recommendations to the group. Paula H. volunteered to serve on the committee. Judy will approach Spanish Coordinator Pat I. along with another member.

Jessica P. was not in attendance and discussion regarding distribution costs of the District Newsletter was tabled. Per Robert G., current distribution costs are approximately \$550.00-\$575.00 per quarter.

#### Old Business:

For the Alateen School Poster Distribution Task Force, Judy W. reported that progress on the distribution of Alateen school posters is ongoing and we are in need of more posters and pamphlets. We are currently out of budgeted funds and cannot continue the project without them. The Student Health Advisory Committee (SHAC) contact coordinates posters for ISD schools. Additional volunteers are needed. Kathy J. moved to approve \$1,500 to spend on Alateen

posters and pamphlets for school distribution. Pete B. seconded. The motion passed with 23 yes votes and 2 abstentions. A discussion regarding the District Workshop Formats Thought Force was tabled.

After a 15 minute break, the business meeting continued at 11:50 A.M.

The Seventh Tradition basket was passed. The donation totaled \$130.00.Paula H., Austin Area Representative for ATAAC, gave details regarding the February 8-10, 2019 conference in Houston. There is an opening on the Board for ETAAA. Robert G. announced the Al-Anon Faces Alcoholism 2019 magazines have been ordered. In addition, per Kay C., there is an immediate opening on the WSO Literature Committee which develops new literature.

Ask It Basket questions were answered. (Page)The group broke for lunch at 12:03 A.M and resumed at 1:30 P.M., at which time a Knowledge-Based Decision-Making (KBDM) Workshop was led by ETAAA Delegate, Kay C.

## Background:

The "Road Trip! You and Your Board Connect" event is an opportunity for local Al-Anon members to meet and interact with the 19 Trustees and the 3 Executive Committee members to discuss Board Members' service to the fellowship, relationship to the WSO, and to the organization of Al Anon Family Groups. There will be people from all over the U.S., and maybe Canada and Mexico attending the event. It is a wonderful opportunity to see the World Wide Fellowship in action. Think of it as a snap shot of the World Service Conference.

The Board of Trustees will come to the Houston Hobby Airport Marriott for the week of October 15, 2018 and conduct one of their 4 Board meetings at the Hotel. 

The new computer provides a way to order books, send GR-1 forms, update group records and the meeting list. WSO does not have all literature online; some orders must be faxed.

#### **Chair Report**

Web site hosting is coming up for renewal. It will cost \$208 for one year.

AAIC Board elections will be held for all positions at the November 12, 2018 meeting.

These positions include: chair, secretary, treasurer, and committee chairs.

### Information Center Report.

The Center is open M-Tu-Th-F from 10-2. High volume days (calls and walk-ins) are T-W-Th.

The long day is now Wednesday from 10-7 PM. Please let your groups know.

Treasurer's Report. We are exactly on target for contributions.

## **Committee Reports**

A financial review of the weekly and monthly bank statements is balanced.

I am offering an update on the Alateen Service Project. I met with some of the Coordinators last Friday. All pamphlets and posters are in.

- Anna, Susan, and Janie (Information Service) are going to help bundle the 40,000 pamphlets into 100 pamphlet bundles.
- 2. Patrick is going to research schools in District 6 that have greater than 10% kids with population of ESL.
- 3. Susan is going to work with the north side of the district to investigate the status of the north ISDs. (#3, except Jarrell; Judy is going to work with Pat E to determine that ISD's status & next steps.)

I need groups or people that are close to the 5 ISDs (see #4, Bastrop, Hutto, Manor, Del Valle, Elgin) that can help do some research; how many schools in the ISD, what are the SHAC contacts.

Please consider taking one or more ISDs to help share this service work.

I would like to begin in thanking all volunteers that have helped on this very large project; getting posters into the schools in district 6 over the past several years. You know who you are and I thank you all from the bottom of my heart for helping do the planning, the research, and all the footwork to help get this project this far. The

volunteer names are too many and if I began to start listing them, I would surely forget critical member contributions. I estimate we are a little of half done with ISDs, but the good news is that the larger high school districts are done. WE still need more volunteers (planners, delivery folks, etc.) to complete the Round 1 distribution of posters into the remaining schools. Please consider helping carry the message to the high schools for our children that may need Alateen; today or at some point in their future.

#### Background:

At the last district meeting in July, a motion was passed to spend \$1500 to help finish the Alateen poster distribution through the remaining Independent School Districts (ISDs). The purpose of this email is to share an update on this project's status & request some volunteers to step forward to help with complete this project; finish Round 1 of poster distribution in District 6.

Last March / April we stopped this project for two reasons; we approached the end of the school year and posters are normally removed after school lets out. Secondly, we had depleted our materials and needed to order more and find some new volunteers; rotation of service.

## Alanon Service Project Update (cont'd)

Last March / April we stopped this project for two reasons; we approached the end of the school year and posters are normally removed after school lets out. Secondly, we had depleted our materials and needed to order more and find some volunteers; rotation of service.

We estimate 27 Independent School Districts (ISDs) exist within District 6. I do not have a count of the schools within each district but hoping to get this nailed down and stored in an electronic file as past and future volunteers step up to assist with this effort. Status for 27 ISDs:

1. 12 ISDs (Completed: Austin, Georgetown, Leander, Haves, Pflugerville, Taylor, Eanes, Copeland, Barlett, McNiell Middle School, Hopewell Middle School, Lake Travis);

2. 1 ISD (In progress: Round Rock), 3. 6 ISDs (Unknown status: Temple, Jarrell, Salado, Belton, Troy, Academy),

8 **ISDs** (Not Done: San Marcos\*, Wimberly\*, Dripping Springs\*, Bastrop, Hutto, Manor, Del Valle, Elgin)

"\*" - I have a volunteer to do 3 of 8 ISDs in "Not Done" status.

#### Materials Purchased:

Our \$1500 purchased 400 school packets; 800 English posters, 40,000 S20 pamphlets. A packet for a single school is made up of 2 posters and 100 S-20 (Alateen 20 Questions). The posters purchased can be found on the Texas Website and is NOT the tornado poster, but the poster with the one-way signs pointing in

opposite directions.

After purchasing 400 school packets and the volume discount already achieved with the poster order, I was able to order an additional 200 English posters & 200 Spanish posters and stay within the \$1500 approved motion. Whether these surplus posters go into the schools or not, others may want to do public outreach with these materials. Our priority will remain on Round 1 school distribution first. Other assumptions included: the 400 school packets would help finish out the remaining ISDs and its possible S20 pamphlets from the already distributed ISDs (Round 1) may not need these to be refreshed although posters tend to be taken down at the end of each school year.

1. Previous team members: If you have been on the previous Alateen High School Poster distribution teams and have status on the UNKNOWN posters, please call me or send me an email with what you do know. (Goal - Due: Sun, 8/19)

GRs: Please take this information to your groups and announce volunteers for those with time or interest to help in getting the Alateen posters into the remaining high schools are needed; the priority is complete Round 1 - ISD schools in the In Progress, Not Done, or Unknown status states. (Goal -Due: Sun, 8/19)

3. Project Lead: I need one volunteer I can work with to help plan / oversee getting the posters into the ALL remaining distribution. I will share the history with this person so they do not have to reivent the wheel. This person will be helping split up the work and monitoring the overall progress as we collect a list of volunteers to support this effort. I will continue to mentor / help this person as they need it, it is not my job to govern other trusted servants but to share my experience strength & hope. (Goal - Identify person by: Sat, 8/25; Meet with person by: Thurs, 9/6) ISD Team Leads: I need ISD team leads (a person over one or more ISDs). This person will identify numbers of schools in each ISD, the SHAC (Student Health Advisory Committee contact), and seek out other volunteers to do the footwork for delivery into the schools. (A working pre-defined process is in place. You do not have to figure this part out.) (Goal - Identify ISD leads by: Thurs, 9/6)

5. Posters will be ready - This Week; Weds 8/15. I will pick them up and store them in my garage until I can find leaders to help this project move forward.

6. Pamphlets - I estimate a couple of weeks to have these delivered to the Information Center. We are grateful to the IC for providing their discount to us so that we could maximize our district's project. (Est delivery - end of August)

7. Packet Creators: A packet is 2 posters & 100 pamphlets. need volunteers to help split up the 40,000 pamphlets into 100 count rubber band counts. (This can be more than one person or one group, but we need help! Ten people would bundle 40 packets.) (Goal - Identify Packet Creators by: Thurs, 9/6)

8. Data Collection Person: I am hoping this information is placed in an excel spreadsheet since it has been suggested the district want to repeat information or have it for future projects. This person will work with person #3 and me to help create single point of information. (Goal Identify person by: Sat, 8/25)


