#### We work the Al-Anon/ Alateen program in Spanish in District 6!

In our district, 2019 has been a year of increasing participation in Spanish-speaking and bilingual Spanish-English Al-Anon family groups. Hispanic AFGs are also taking a greater role in program service work for the district and also for the entire state of Texas.

Nueva Visión AFG and La Alegría de Vivir AFG recently attracted new members and are growing.

Representatives of *Valor para Cambiar*, *Nueva Visión* and *Serenidad* AFGs attended the July 20 District Meeting. In the morning session, Maria S. shared news about the Fifth Texas Statewide Hispanic Al-Anon/ Alateen Convention October 18-19 in Pflugerville. (See page 19.) After lunch, many Spanish-speaking members participated in the Alateen breakout session.

Austin-area Spanish-speaking and bilingual AFGs (*Esperanza, Fuente de la Paz, La Alegría de Vivir, Nueva Visión, Serenidad,* and *Valor para Cambiar*) continue to meet together one Saturday each month. Maria G. is coordinating the updating of the registration information for all these local groups as part of the district's new group record process. These groups are also working together to organize the Hispanic convention.

Members of *Nueva Visión* took part in the August 3 training for AMIAS certification (Al-Anon Members In Alateen Service).

Spanish-speaking Al-Anons volunteered throughout the day at the Al-Anon table at the Manor ISD Health Fair on August 13.



#### **District Representative**

Here is a recap of the Area World Service Committee (AWSC) meeting held on August 24 in Schertz, Texas.



- Twenty-six voting AWSC members attended.
- Workshop on Leadership was given by Judy P.
- Discussed topics to include in the AWSC 2020 Leadership Conference Workshop next year for ASWC members.
- A few noted updates by the delegate during her district visits included:
  - One smaller district (District 7) is using a conference call speaker to have folks dial in as well as attend their district meetings. (District 6 will discuss on their October agenda.)
  - ⋄ "Newcomer Welcome" is no longer part of the service manual, but groups may choose based on autonomy to continue to use it. This was removed because of the wording having many "should(s)" within it.
  - In the Loop" is an online WSO newsletter that was endorsed as a good electronic communication tool.
- Area Abundant Funds Thought
   Force recommended that the area
   proceed in having a policy on
   abundant funds
- "Parents Drink Too Much" is no longer in print and will no longer be sold by WSO
- DRs need to remind the GRs to

bring their orientation folders to the assemblies. (*The documents* will be uploaded to the Texas East website for all GRs to access.)

Meeting Minutes Secretary, Doon R. July 20, 2019 Hosted by: Courage to Change AFG 2128 Barton Hills Dr. Austin, TX 78734



DR Judy W. called the meeting to order at 9:01 A.M., thanked the host group and welcomed new GRs. Peggy D. welcomed everyone and gave logistics.

A moment of silence was observed, followed by the Serenity Prayer and the reading of The Twelve Traditions, Twelve Concepts of Service and General Warranties of the Conference. After introductions, the Ask It Basket was passed. The Seventh Tradition donation was \$147.00.

#### **BUSINESS MEETING BEGINS**

The Business Meeting began at approximately 9:30 A.M. with DR Announcements.

Judy W. thanked everyone and reported that seven groups submitted reports electronically before the District Meeting. She was very

pleased and encouraged more involvement. She then asked GRs if they would like to know about AA events with Al-Anon participation in accordance with the Service Manual, pages 91-93. There was a positive response. In addition, Judy W. announced the host of the October 19, 2019 District Meeting will be The Glass House AFG in Temple. Hilltoppers AFG in West Austin will host on January 18, 2020. The tentative location for the April 18, 2020 District Meeting is Faith AFG in Northwest Austin.

Distributed Report Questions followed.

On behalf of Secretary Doon R. (absent), Judy W. presented the April 27, 2019 Minutes as printed in the *Summer 2019 District 6 Newsletter* and provided to Group Reps electronically prior to the Business Meeting. There were no additions or corrections. The Minutes were approved.

Treasurer Robert G. presented the 2019 District 6 2nd Quarter Operating Statement. As of June 30, 2019 we have an unallocated balance of \$14,366.99. There were no questions.

Public Outreach North Coordinator Susan T. submitted a written report prior to the meeting. In addition, she reported that since PO North had not had a coordinator for the past few years, there had not been much of the budget used previously. So far this year PO North has gone over budget by about \$46.00. Also, PO North has included Georgetown in its area since PO South is so large. There were no questions.

Public Outreach South Coordinator Dave L. provided a written report prior to the meeting. He also reported that he had staffed a health fair at Cedar Ridge High School in Round Rock in April, and said that quite a few of the other organizations (Bluebonnet Trails, and others) were interested in learning more about Al-Anon. There were no questions.

Newsletter Coordinator Mary M., who had submitted a written report prior to the meeting, requested cover stories of 600-1200 words. She then read off the returned Newsletter contacts and asked the GRs for information about them. She also corrected the date for Officer, Coordinators, GR, & Thought/Task Force Groups to submit their reports to September 5, 2019. There were no questions.

Spanish Language Coordinator / Coordinator hispanohablante Pat I. submitted a written report prior to the meeting. There were no questions. He also helped Spanish speakers get in contact with Bill W. to help with the Manor ISD open house for parents on August 13.

Alateen Coordinator Bill W. provided a written report prior to the meeting. He also reported that there are now 30 certified AMIAS in the District. He was put in contact with an organization called Communities in Schools Central Texas that works with several school districts in the area and is eager to have Alateen in all the high schools. There were no questions.

## Upcoming Events & Volunteer Opportunities were announced.

Bill W. appealed to GRs to sign up for the AMIAS training session set for August 3, 2019 at Grace Presbyterian Church in Round Rock.

Pat I. introduced Maria S. (one of the bilingual GRs who was in attendance) of Nueva Visión. She spoke on behalf of several Spanish-speaking Austin area Al-Anon family groups hosting the Quinta Convención Al-Anon/ Alateen Estatal Hispana de Texas (the Fifth Texas Statewide Hispanic Al-Anon/Alateen Convention). It will be held in the Austin area for the first time on Friday and Saturday, October 18 and 19, 2019 at Chisholm Point Community Center in Pflugerville. (Maria S. spoke mostly in Spanish; Pat I. provided a translation.)

She invited everyone to attend, distributed a flyer, and made some requests for help:

- 1. Groups or individual members are invited to donate gift baskets.
- 2. The convention organizers need information about what must be done to include Alateens.
- 3. If the convention loses money, as the last convention in Houston did when it was postponed due to Hurricane Harvey, would the District consider helping the convention organizers out financially?

The convention organizers plan to follow up with an email to all District 6 GRs explaining how to volunteer, providing details on what seems most useful for Spanish-Speaking Al-Anons to receive in a gift basket, and requesting Alateen help.

Maria S. said there is a need for an area for the Spanish-speaking Alateens to meet during the convention at the Pflugerville Community Center. It was later determined that Alateens in attendance will likely be included in the main convention proceedings, since there appears to be no separate space available.

Everyone appreciated a "Newcomers Welcome" skit presented by the supporting group, Three C's AFG.

#### Thought Force /Task Force / Committee Status Updates / Motions began.

Roll was called by Judy W. There were 49 attendees with 31 voting GRs, a simple majority being 16 votes, a two-thirds majority being 21. It was agreed by consensus that



we would use a simple majority for usual business matters and a twothirds majority for election purposes.

For the District Workshop Format Committee Status Update, Josie R. reported the committee has finalized their process and information for the Texas website. Josie R. is to send Judy W. a request (to push to the groups' distribution list) for any other workshops /information that may be desired for the central repository.

The Spanish Website Tab Thought Force Status Update was given by Pat I. They have a design and words for the Spanish web tab which he is going to work with the Information Center to get online ASAP, so that people can start using it and suggest improvements.

During the Unallocated Funds /Day in Al-Anon Thought Force Status Update, Mary R. spoke on a need to cover Area Public Outreach Coordinator Lynn B.'s expenses. Lynn B. will be coming from Houston to provide A Day in Al-Anon training for GRs at the October, 2019 District Meeting.

The Alateen School Poster Distribution Task Force Status Update was given by Lorelei L. The Task Force continues to document the history of Alateen poster distribution. They have created a spreadsheet containing the process, who deployed distribution on the first round, and contact information. They have planned to get posters into the SHAC hands by August 15, 2019 to be put up as school starts. The Task Force wants the groups to take ownership for distribution in the future. This project is directed toward high schools, middle schools and some charter schools.

The Website Thought Force – District Domain Status Update was

summarized by Judy W. She reminded the GRs that the project will take a lot of work and will not happen overnight. After discussion on the benefits of moving forward or not, the general consensus was to continue the work.

Judy W. asked Coordinators and team leaders about any additional financial needs they will have through the rest of the year. She requested this information before the next District Meeting.

She then called for Motions. A Motion was made to spend up to \$500 for 1,000 Al-Anon/Alateen English posters. The Motion passed with 30 votes for, one against, no abstentions.

In addition, a Motion was made to increase the PO North budget by \$300.00 for 2019 for Outreach activities. The Motion Passed unanimously.

Judy W. introduced the topic of a new Coordinator's position - the District Group Records Coordinator (DGRC).

She summarized the role of the DGRC as working closely with the DR which would allow the DR time to perform more responsibilities. This Coordinator will be keeping Excel GR distribution spreadsheets current so the Alateen Coordinator, Information Office Employee, Newsletter Coordinator and Area Group Records Coordinator (AGRC) receive timely updates. The DGRC will be attending quarterly District Meetings and be available to assist GRs with GR-1s and other matters. The DGRC may also be working with other Outreach Coordinators (including Spanish and Alateen) to help verify group status. In addition, they may be turning in Quarterly Coordinator reports. A Motion was made to create a position of District Group Records Coordinator. The motion passed unanimously.

A Motion was made to amend the budget to add \$250 per year for DGRC expenses to attend District Meetings and perform duties. The motion passed unanimously.

Kim C. from Cedar Park stood for the position through December 2020. She ran unopposed and was elected unanimously. [Editor's note: Kim C. was forced to resign due to a family move and the position will be up for election again on October 19.]

A Potluck Lunch was enjoyed from 12:43 P.M. until 1:35 P.M.

#### **BUSINESS MEETING CONTINUES**

Judy W. took a count of members still in attendance. There were 25 voting GRs, a simple majority being 13 votes, a two-thirds majority being 17.

#### Parallel Work Sessions began.

The GRs chose subjects that were of interest to them and broke into subgroups. They discussed additional ideas to take forward and made suggestions about what can be done next. Summaries were provided after completion.

On behalf of the District Workshop Format Committee's group, Myra and Josie R. reported they have been working on suggested service responsibilities for sharing workshop experience through a database and a binder passed from host group to host group. In addition, other groups' events (i.e. workshops, etc.) will be communicated to GRs by Judy W.

The Alateen School Poster group's discussion was reported by Lorelei L. The committee has three priorities. First is to replicate what has already been done successfully. Second is to get posters to the

schools that have Alateen meetings nearby. And third is distribution to counties that have no meetings.

On behalf of the Workshop for Alateen in schools, Bill W. reported that several schools are wanting to start Alateen meetings for the next school year, but we are short on AMIASes. We can't have Alateen meetings without certified AMIASes present to facilitate the meetings. The work session was attended by those, most notably several members from Spanish-speaking groups, who may be interested in becoming AMIASes. Bill provided information on AMIAS certification in general and the certification training that was scheduled for August 3, 2019 in Pflugerville. The main goal of the work session was to get as many people as possible to sign up for the August 3, 2019 certification training.

For the Unallocated Funds /Day in Al-Anon Thought Force work session, Mary R. reported that this is still a Thought Force and ideas are welcome. Donations come to and are collected in Austin, but the money is needed in the counties, particularly in rural areas. They are exploring ways for people to apply for Unallocated Funds to support groups in the counties. The Thought Force requested suggestions.

This group is also a Task Force and made two Motions. Motion to use up to \$500 Unallocated Funds to pay for Lynn B.'s travel expenses to provide A Day in Al-Anon training for GRs at the October (2019) District Meeting. Motion passed unanimously.

The other Motion concerned whether to support the Spanish-language Convention in Pflugerville. Discussion focused on the District setting a precedent vs. our commitment to support the growth of the Spanish-language community. The second Motion regarded the Fifth Statewide

**Hispanic Al-Anon Convention** scheduled for October 18-19, 2019 in Pflugerville that has a budget of no more than \$3,000 and a plan to meet those expenses through registration fees. The motion was that upon presentation of documentation of monies spent and received, the GRs permit the Treasurer to reimburse the AFGs organizing the conference for any loss of no more than \$3,000, documented and reported no later than November 30, 2019. Any disbursement will be funded from Unallocated Funds. Motion passed with 22 for, three against, no opposed.

Updates on GR successes and challenges were not made due to time constraints.

Ask-It Basket questions and answers were not addressed, again due to time constraints. [See page 12 for Aske-It Basket questions and answers.]

A raffle was conducted and the winner of a *Forum* subscription was Mary M.

#### MEETING CLOSED

The Meeting closed at 3:10 P.M. with the Al-Anon Declaration in English and Spanish.

#### <u>Public Outreach, South,</u> Dave L.



Al-Anons participated in two health fairs this summer, the first being the Manor school district's School Resource Fair. There were more than 700

people at the fair, and many of them stopped by the Al-Anon table to pick up literature and engage in conversation (in either English or Spanish) with a dozen or so District 6 volunteers. Parents who visited fifteen "vendors" collected stamps on their "passports" in order to receive school supplies, which made it a lively event for everyone.

The second event was a smaller health fair, the Williamson County Overdose Awareness Day. Volunteers from Round Rock's Seekers of Serenity AFG, along with district representative Judy W., passed out Al-Anon literature (and fortune cookies) and networked with law enforcement and health care providers from the county, which has a population of 556,000 as of 2018. Deanna M. of Serenity Seekers said one organizer of the annual event said she was "thrilled" to include Al-Anon participation in the event, partly because so many drug addicts in recovery turn to alcohol and then

return to their drug of choice.

Upcoming in mid-October is Al-Anon participation in two panel discussions at the Jeremiah Program, which supports single mothers who are developing educational and work skills. The Addiction and Substance Abuse Life Skills class is scheduled for Oct. 16 in central Austin.

Finally, Lynn B., the East Texas - Area 53 Public Outreach Coordinator, will come to the Oct. 19 District 6 meeting in Temple to share her experiences about how to organize a Day in Al-Anon, aimed at health care and law enforcement professionals, among others.

# 1. Where can *The Twelve Steps & Twelve Traditions* be printed for meeting use with revised and updated openings in the Service Manual?

Most groups type up their own onepage Twelve Steps & Twelve Traditions. If Conference Approved Literature, a daily reader, etc. is not used during the meeting time to conduct the meeting, and a group wants to type up their one-page document for lamination, it is suggested you reference the source of the introduction for the *Twelve Steps &* Twelve Traditions in the footer of the typed document. For example, the Courage to Change reader has a slightly different introductory paragraph from the Al-Anon Service Manual, but both are okay for use.

# 2. Is the "Keep coming back" saying used after the Serenity Prayer or Al-Anon Declaration Conference approved? Do groups use both with the "Keep coming back..." phrase?

In referencing the Closing in the *Service Manual* (page 20), you will notice no mention of this phrase. The "Keep coming back..." phrase said after the prayer or Declaration at many meetings is often referred to as chanting. It is not Conference approved, but if the group conscience supports use of it, based on group autonomy, it is okay for that group's use. Many groups choose to

use the Al-Anon Declaration as a closing in lieu of "Keep Coming Back..."

# 3. Do we have Service Manual exercises or meetings; something to help us learn the Service Manual?

Today we do not have published exercises, but groups hosting District Meetings in the past developed workshops where games were used to reference the index in helping look up answers in the Service Manual. As we begin to record more of our workshops in our central repository, it is possible groups may share more examples to have the groups become more familiar with the Service Manual.

# 4. My group has a member who thinks there should be a vote on the group contributions to the District, Area, and WSO on a quarterly basis. My other groups use a formula to make contributions quarterly. A) Is it okay to use the formula? B) Is it okay for a group to choose not to donate to a service arm (District, Area, WSO)?

Please see the Service Manual (Group Finances / Budget, pages 55-57) and the WSO Guideline (G-41). A) This question falls under the group autonomy principle. A group conscience can decide what is best for the group (for example, if the group wants to vote on a quarterly basis or use a formula). Normally, the group is first self-supporting, caring for their own rent, the Group Representative (GR) expenses, literature, etc. Then the group is encouraged to contribute to the service

arms (District, Area, WSO, Austin Information Service (AIS) Center). The G-41 guideline suggests 25% to each service arm or a set amount be made once group expenses are met. B) Yes, it's okay to not donate, but this is also a group conscience decision.

# 5. What is the process to request funds from the Unallocated Funds Committee: A) To help Spanish speaking Al-Anon Conference? B) Can money be used for scholarships to help members that cannot afford it? C) Can money be used for donating Spanish literature?

There is currently no District Committee. There is a District Unallocated Funds Thought Force trying to establish ideas for what the surplus funds may be used for and how district groups or other public outreach projects can apply for the surplus money. B and C) This has not been determined, but the GRs will vote before the process is activated within the district. A similar effort is being conducted with the area on Abundant Funds, and we also hope to get some guidance from that effort.

### 6. When and how does the Group Rep (GR) determine that there needs to be a group conscience (GC) meeting discussion?

Please see the Service Manual (Group Business Meetings and Group Conscience, page 49). Based on the autonomy principle, the group can decide on the process. The result of a business meeting is a group conscience. Some groups have a set frequency (i.e., every other month) and allow anyone to place topics on the agenda. Some groups allow anyone to call an emergency group conscience following a meeting if needed when a topic/subject cannot wait for the scheduled group conscience. Other



larger groups, e.g. Northland and Hilltoppers, have Steering Committees and can sometimes resolve questions/concerns without the business meeting needing to address a member's question.

## 7. How often should groups have business (group conscience) meetings?

Based on the autonomy principle, the group can decide what is best for them.

# 8. Is it true that the Newcomer Welcome (NW) is no longer recommended by WSO at an Al-Anon meeting? How do our members look this up in Conference Summaries or other historical WSO literature?

This falls under group autonomy and what the group decides is best for them. The Newcomers Welcome was discontinued by the Board of Trustees Policy Committee in April of 2004 by affirming that Al-Anon would only have one "Welcome." The consensus was that the Newcomer's Welcome was directive (telling newcomers how they felt and what they needed to do). At that time the Newcomer's Welcome was removed from the Group Binders. This information was published in the 2004 WSO Conference Summary and in our CAL book Many Voices, One Journey (page 348). I, Josie R. continue to be so grateful to serve on this committee. I'm happy to report real progress towards honoring and preserving the workshop activities of District 6 members. Many thanks to the members who participated in the Workshop Committee break-out session at the July 20th District 6 Meeting. It was suggested that we include a definition of Workshops. Page 90 of the *Al-Anon/Alateen Service Manual 2018-2021* states:

An Area, District, Al-Anon Information Service (AIS) or one or more Al-Anon or Alateen group may host a weekend, day or evening of workshops and meetings, luncheons or banquets. These activities are planned in keeping with the spiritual principles of the Twelve Traditions to address various topics of interest to members or for public outreach purposes. Weekend events often combine workshops and speaker meetings.

Another suggestion was that we add a Workshop link to a Hosting Group Checklist.

Additionally, it was suggested that we invite local groups who have presented workshops within our district, not just at district meetings, to submit their presentations.

With the *Keep It Simple* slogan in mind, I revised our original Workshop form to include all workshops, noting the date (when) and type of event (where) for the workshop presented.

The goal is to ask our District Rep., Judy W., to send this revised Workshop form out to Group Representatives (GRs) with the request for it to be filled out by anyone that has EV-ER presented a workshop activity in District 6.


