# GROWTH THROUGH SERVICE

Looking back over my growth in service, I feel none of us came into Al-Anon to become a part of the history. That is just what happens when we come into Al-Anon. We become a part of a group, get a sponsor, read the literature and start on the journey of recovery through the Al-Anon Twelve Steps. The working of the Traditions and Concepts came sometime later. I did not come into Al-Anon for the "long stay". I came to get my husband sober and stayed to save my life. Then I could get on with my life. I never have figured this out because life without Al-Anon is not worth the struggle. Finding trust in a Higher Power has taken away some of the drive of self will. You told me to come to the meetings one day at a time; suit up, show up and grow with the flow. That has been over three decades of attending meetings, reading the literature and working the Twelve Steps of the Al-Anon program. The true personal growth has been working the Twelve Traditions and Concepts of Service with sponsees. It is truly a blessing to Service Sponsor those eager to learn more about recovery through service.

Service in the Al-Anon program has been the icing on the cake. If you stick with the winners, they will show you the way to detachment from the problem and how we can be of service to others through our own recovery. One of the greatest tools of our fellowship is "get in the car". My home group had several very active area service officers, they had something that I wanted, peace and serenity and how to have fun. I became the designated driver for these three wonderful Al-Anon ladies. What great meetings took place in the car, traveling to Area Assemblies two or three hundred miles away. I learned the workings of the offices of our area as well as learning the importance of "obedience to the unenforceable." Attraction to our fellowship through the attitudes and wisdom of our longtime members adds so much to the growth and unity of area assemblies and district meetings. They have been there for us by stepping aside to allow the newly elected officers to grow in service while walking beside us holding our hands. Being service sponsors to those

The meeting was opened by Shelley at 9:05 a.m. with a moment of silence followed by the Serenity Prayer. Shelley then read the suggested welcome, followed by going around the room to read the steps, traditions, concepts, and warranties.

Announcements included a note that Pat E. had broken her ankle and would be immobile for 6-8 weeks. We then went around the room and introduced

ourselves. There were several people present for their first district meeting.

The workshop was on the traditions, using questions from Paths to Recovery. We broke into three groups and each group covered four traditions. The groups then reported a summary of their discussions to the whole meeting.

The Business Meeting started at 11:10 a.m. with officer and coordinator At the beginning of the reports. meeting, the Ask It Basket was passed. Paula Н.. Alternate District Representative, is visiting groups in Austin and the outer areas as well. Paula explained that Hope for Today, a Wednesday evening meeting, is just getting started and is inviting people to attend. Paula reminded members to let Kitty at the Al-Anon Information Center know if groups have disbanded or other changes have occurred. Paula also explained that WSO is doing a new history book (we had a writing workshop at our last District meeting). Finally, Paula stated that the AA International needs 300-400 Al-Anon volunteers to support the convention in San Antonio, July 1-4, 2010 (see Al-Anon state web site to register as a volunteer). There is also a need for foreign language support, being chaired by our Area's Rosie and Bennie.

Secretary's Report. Minutes were amended to remove "A RSS task force was formed. Kay C., Pat E., and Tom B. will be on it", because the previous District Meeting had established a thought force and the thought force completed the necessary actions. A motion to approve the amended minutes was made and seconded. The motion carried.

Treasurer's Report. Kay C. requested that groups make sure that group donations are sent to her at the new address contained in this newsletter. Kay also stated that the ETAAA treasurer has changed and the new address for mailing contributions is at the Texas state Al-Anon web site. Kay mentioned that WSO has a pamphlet on contributions.

Coordinator reports were presented by the Alateen coordinator (POSSE is coming up), the Austin Information Center Board (a secretary is needed), Newsletter, Public Outreach South and North. There was also information from the Area Public Outreach Coordinator on a Good Morning America spot about the death of Casey Johnson that contained a significant segment on Al-Anon. There was also some discussion about an upcoming Hallmark Channel movie about Lois W. named "When Love Is Not Enough" based on a book of the same name that was written by the Director of Stepping Stones.

In her DR report, Shelley stated that she has copies of the area budget and group donations to the area. Area highlights include information about the second printing of Al-Anon Faces Alcoholism: the order cutoff date is February 10. The Area World Service Committee meeting is June 30 in Houston. The quilt for the All Texas Conference is ready, but raffle tickets must be purchased in person; tickets are \$5 apiece. Arbutus from Amarillo died recently; she was the first delegate from Texas and the only one to represent the entire state. biography can be found at the Make Everlasting Memories website at this

Everyone should note that the May Assembly location has been moved from the Inn Place Hotel in Victoria to the First English Lutheran Church in Victoria, but the dates are the same. There are new flyers on the web site.

Future Meetings: Courage to Change indicated they would host the April 17 meeting and Wimberley AFG will check about hosting the July 17 meeting.

## Ask-It-Basket Questions:

1. What is TEAM: what is RSS?

Answer: RSS stands for Regional Service Seminar, regionally based events scheduled service sponsored by WSO (see page 65 in the Service Manual). TEAM stands for Together Empowering Al-Anon Members, new service events that are replacing RSS. TEAM event ideas and requests can be made by any area to WSO. WSO will then help in making the TEAM event happen.

2. Is there a service commitment that needs volunteers? Which commitment is the one that struggles or doesn't get enough volunteers?

Al-Anon is an all Answer: volunteer organization and there are no "musts". Therefore, each person is able to choose when or if at all to serve or "volunteer". Among many areas needing volunteers are Alateen, writing for literature, and contacting lone members. Just serve where you feel comfortable.

3. What can we do to encourage attendance and participation at District meetings?

Answer: Remember concept 4 -Participation is the key to harmony. meetings Publicize District discussing at groups to get ideas, announcing meetings, posting Newsletter on Al-Anon boards, sending out emails announcing upcoming meetings, continuing to

rotate District meetings and personally inviting others and arranging carpools to District meetings. When at District meetings, participate in discussions, vote (if you can), take notes to report back to group, volunteer for District office.

4. How do groups encourage newcomers to keep coming back?

Answer: I'll share what our group does. We ask if there are newcomers at the beginning of the meeting and welcome them as a group. We give them a Newcomer's Packet then read the Newcomer's Welcome. I'm told that the Newcomer's Welcome is no longer in our CAL. I will ask the group if we want to continue using it, but I feel we will. We then tell the newcomers to please take a page from the back of our sign-in book and write down names and numbers. groups give out pre-printed lists of names and numbers. During the meeting, some of us share parts of our experience, strength, and hope. At the end of the meeting, we always make sure that we greet and talk to the newcomers. We want them to feel welcomed, cared about. encouraged. We then invite them to go out with us after the meeting. After that, it is no longer our business if they come back right away or later. It seems they do end up back with us.

How can I encourage my grown daughter to attend Al-Anon? I have noticed more and more of her father's alcoholic characteristics when she engages with her boyfriend, and believe that she could benefit from the Al-Anon program.

Answer: Be careful! If you "tell" them to go, they will probably not go. The thing that seems to work the best is to keep going herself and be an example. When they see changes in

you, they may want to join you Remember to focus on yourself. We cannot change anyone else. This is a program of attraction, not promotion.

6. Are there members who would be willing to meet to take meetings to members who are temporarily disabled due to surgery, taking care of ill spouses/family, etc.? Answer: District 6 has appointed a Thought Force to review and report back to the District on this issue. The Thought Force is Coy, Jane, and Katy. This Thought Force can bring us information regarding the practicality and resources for doing this.

New Business: Kay presented the 2010 budget. There was an amendment to add a line item for the Spanish Coordinator with a budget of

\$200. The amendment was moved, seconded, and passed. Then Sharon moved acceptance of the 2010 budget, Tally seconded the motion, and the budget was unanimously approved.

We closed the meeting with the Al-Anon Declaration



# **District Meeting Directions**

## From the north, going south on I-35:

St. Mark's is south of the river. Exit onto Oltorf Avenue, turn right (west). At South Lamar Boulevard, turn left (South). At Barton Skyway, turn right. When you reach the intersection of Barton Skyway and Barton Hills Drive, St. Mark's is on the west side of Barton Hills Drive. The parking lot can be reached from a narrow driveway off of Barton Hills Drive.

# From the south, going north on I-35:

Take the Ben White (Hwy 71 west) exit, go under I-35, and continue west on Ben White. Take the South Lamar Boulevard exit and go north on Lamar. At Barton Skyway, turn left (west). When you reach the intersection of Barton Skyway and Barton Hills Drive, St. Mark's is on the west side of Barton Hills Drive. The parking lot can be reached from a narrow driveway off of Barton Hills Drive.

#### From Mopac:

Take the Rollingwood exit. If going south on Mopac, go left, under Mopac, then left again to go north on the Mopac frontage road. If going north, just continue on the frontage road. Turn right on Barton Springs Road (through Zilker park). Turn right on Robert E. Lee Road., then turn right at Barton Hills Drive. When you reach the intersection of Barton Hills Drive and Barton Skyway. St. Mark's Episcopal Church will be on the right (2128 Barton Hills Drive). A narrow driveway on the right will take you to the parking lot. (Note: Barton Skyway from Mopac does not go through to where St Marks church is; follow the directions above.)

#### Si viene del Norte hacia al sur en la 35:

La iglesia St Mark's está al sur del río. Pase el area del centro (downtown). newer in service has added greatly to the unity and understanding of the Al-Anon process. We grow together by walking hand in hand and praying along the way.

Over the years our Area Assemblies have grown from one day business meetings to Al-Anon/Alateen Convention weekends. Feedback from Group Representatives and the use of evaluation forms have led to changes to have more Al-Anon speakers, workshops on service and Area Coordinator's workshops with District Coordinators. Having speakers from the World Service Office, we are now familiar with their Al-Anon stories and have allowed them to lead workshops at Area Assemblies where we can get to know one another. We keep ourselves open to change for the good by using the three year trial basis method to see if this is what will work for our Assembly. We have thirteen districts in our area and, over the past ten to twenty years, we have started rotating our Assemblies around to allow each district to be host committee and another district to assist in workshops and registration. What a growth this has been to get the smaller districts to step up and get involved. It all leads to growth and confidence in our members and a stronger, united Area Assembly.

We have a large area archives that we display at all of our Assemblies. This allows Al-Anon/Alateen members to see clips of history through photographs, all copies of our Forum magazine from the early 1970's to present plus memorabilia from past delegates terms through all Conference Summaries and donated papers from their panel standing committees.

Alateen is a part of our Area Assemblies. We have Alateen speakers 15 minutes before the Al-Anon and AA speakers. Alateens have their own room for meetings but they participate in the workshops at Area Assembly with all of us. Alateens add a lot to the workshops as their ideas and opinions are very important.

The new certification process for Alateen Sponsors has been a growing process for our assembly area. We had skits and fun times trying to bring some amusement into the seriousness of this process. Our guidelines are in place and we are growing in harmony as we accept these changes and do what is best for Al-Anon and Alateen as a whole and the safety of our younger members.

As Lois said "anyone can start something, but it takes many to make it happen." Through the unity and love of our fellowship we continue to grow One Day at a Time. Service is one of the most important growth processes for me and other longtime members of this fellowship.
