The Twelve Steps Summary

The Twelve Steps suggest acceptance of four primary ideas:

1. We Are Powerless Over the Problem of Alcoholism.

When we can honestly accept this truth, it brings us a feeling of release and hope. We can now turn our full attention to bringing our own lives into order. We can go forward to spiritual growth, to the comfort and peace to be gained from the entire program.

2. We Can Turn Our Lives Over to a Power Greater Than Ourselves.

Now that our well-meant aid to the alcoholic has ended in failure and our own lives have become unmanageable, we realize we cannot deal with our problem objectively, perhaps not even sanely. In Al Anon we find a Power greater than ourselves which can direct our lives into guiet, useful channels. At first this power may seem to be the group, but as we grow in knowledge and spiritual understanding, many of us call it God, as we understand Him.

3. We Need to Change Both Our Attitude and Our Actions.

As we become willing to admit our defects, we begin to see how much of our thinking is distorted. We realize how unwise some of our actions have been, how unloving many of our attitudes. We try to recognize and correct these faults.

4. We Keep Al Anon's Gifts by Sharing Them with Others.

This sharing makes Al Anon the vital, forward-reaching fellowship it is. Our great obligation is to those still in need. Leading another person from despair to hope and love brings comfort to both the giver and receiver.

The meeting opened at 9:07 with a moment of silence followed by the Serenity Prayer. Our Three Legacies were read and housekeeping announcements were made. Everyone introduced themselves. Many were here for their first district meeting.

The Ask-It-Basket and the donation basket were passed. A workshop was held on the new 2010-2013 Al-Anon/Alateen Service Manual. Also during this time, a separate Alateen Sponsor meeting was held. Business Meeting began at 11:00 with Officer and Coordinator reports. The amount collected in the donation basket was \$250.00. The deadline for the Summer District 6 Newsletter reports is June 3. It was announced that Ann F. from WSO who fell at the Fall Assembly is finally back in New York for Rehabilitation. The morning meeting broke for lunch at 11:55.

The afternoon session began at 1:05 with thanks to our hosts.

Old Business:

Updates on groups were given. Future meetings were discussed. The next meeting will be hosted by Faith AFG at Unity Church of the Hills-Anderson Mill.

New Business:

Georgetown Alateen Group will chair the Decorating Committee for the May Assembly.

The budget for 2011 was approved.

Tom B. and Paula H. have been on the Thought Force "What types of events should the District Newsletter Announce?" The Task Force will follow. We are asked to come up with recommendations and discuss it with our groups.

Lockhart Town and Country AFG, part of District 3, has asked to become part of District 6. Jackie made a motion for Lockhart AFG to be accepted into District 6. Tally seconded. The vote was unanimous. Shelley will take this to the AWSC.

1. *Question:* In October, we will have District officer and coordinator

elections. Does a person interested in a position have to be present to run for a position?

Page 140 of the current Answer: Service Manual addresses the election Representative of District Alternate DR, especially the first two paragraphs. It would be helpful to the district if the district knew what position one might be interested in. It would be optimal if the person interested in the position were present to be able to state his/her interest and to be able to answer questions, should they arise. If the person interested in the position is not able to be present due to work or illness or other emergency, it would be helpful for that person to have something written, prepared in advance so that someone else could read it at the meeting.

2. Question: Are the Al-Anon groups supposed to use the Concepts of Service in groups, or are the Concepts only for use in the Conference? For instance, should groups use the Warranties (like making unanimous decisions) in group conscious meetings?

Answer: I have been fortunate in that I was exposed to the concepts since day one in Al-Anon. In my Step Study group, after we went through the Steps, we went through the Traditions, then continued on through the Concepts and the General Warranties. I found all three Legacies to be useful not only in my Al-Anon group, but also in my service life in Al-Anon and my personal recovery. One of my favorite pamphlets is Al-Anon's Best Kept Secret-The 12 Concepts. The General Warranties, in my opinion, are a summary of the whole program. Yes, the Concepts and General Warranties are certainly valuable at the individual Al-Anon Family Group level.

3. *Question:* Is there a suggested donation/support percentage to give to the four service arms? And the frequency per year?

Answer: Part 1-No. See pages 53-54 in the Service Manual addresses Group funds/Budget. Part 2-No. Most groups give on a quarterly basis.

4. *Question:* Our group has been without a Group Representative for a couple of years. In lieu of a GR, we're trying a "committee" approach until someone steps forward as our GR. If a different person attends each District meeting, when it is time to vote, can that particular "temporary" representative vote?


Answer: This can be done provided that it is understood that if more than one person from the group attends, only one person get to vote. One person is designated to receive the mail from the World Service Office and newsletters if a Post Office box is not used. The GR's job is to report back and share information to the group. See pages 139 and 147 of the Service Manual.

5. *Question:* What is the difference in the new manual in the Concepts section between Concepts and Amendments?

Answer: The text of the Amendments section is from the 2005 revision of the concepts and their descriptions. Footnotes are located throughout the Amendments text which mark changes to the text that occurred pre-2005. The original text (before the Amendment) is in the back of the Amendments section. The section in the front of the Concepts section is the current version, post 2005, which has some changes from the previous version, as noted by the black lines in the margins. The Amendments section is included to leave "a record of former experience". and to "forestall such repetition by holding the experience of the past clearly before us". (page 172, Service Manual)

6. *Question:* Are there any books available on CD and if so what languages? Are any books available in Braille?

Answer: Courage To Change was printed on CD ROM but not any longer. There are several publications



7. *Question:* How do we decide how much is needed for our Prudent Reserve?

Answer: Most groups prefer not to accumulate money beyond current needs and a small reserve with just enough funds to pay the GR expenses to assembly and group expenses for a couple of months. (page 53 of the Service Manual)

8. *Question:* Steps 3, 7, and 11 refer to God as He and Him. Can this be changed?

Answer: Page 164, d. and e. of the Service Manual.

The Meeting ended with the Al-Anon/Alateen Declaration.

THOUGHT FORCE – What types of events should the District Newsletter announce?

1. What do we know about our members and prospective members needs, wants and preferences that is relevant to this discussion?

We know that AA information is posted on some Al-Anon sites; that the Beacon contains some information about AA events; that the Forum used to contain some AA meetings when they included upcoming event information (now on the WSO site listing AA events with Al-Anon participation); that there was widespread publication about the AA International; that Tradition 6 says we should cooperate with AA. We also know that we have heard several people share that when they came into Al-Anon, they wanted nothing to do with AA and that any references to AA might have been enough to have them quit Al-Anon.

In our District we have members who are children/grandchildren of alcoholics, parents of alcoholics, spouses/significant others of alcoholics, siblings of alcoholics, and dual members of AA and Al-Anon. However, the newcomer is the most important person in our meetings. While striving to understand/cope with the disease of alcoholism is important in recovery, the newcomer may be confused and turned off to Al-Anon by announcements of AA events with Al-Anon participation. We can talk to newcomers after the meeting so that they will know we are not AA. Where do we draw the line in announcing events?

2. What do we know about our resources (finances, membership participation) that is relevant to this discussion?

We don't think that resources play any role in this unless it would be so upsetting that people would quit contributing to the District.

3. What do we know about our current realities (membership, culture) and our fellowship's environment (technology, our Legacies, and spiritual principles) that is relevant to this discussion?

We think that we covered this in question 1 above. The only thing that we might add is that there is a long history of AA and Al-Anon cooperation.

Current realities: While researching these questions, we used various pieces of literature, the Austin Information Center website, the Texas Al-Anon website, and the Austin AA website.

Literature: "Cooperation between Al-Anon and AA"

Al-Anon/Alateen Service Manual 2010-2013 -- page 117 "In keeping with the Al-Anon/Alateen focus, the groups do

not announce or discuss activities of other anonymous Twelve Step programs. Al-Anon/Alateen Area newsletters and local bulletins may publicize activities of Al-Anon/Alateen groups and those AA activities with Al-Anon participation."

<u>Paths to Recovery</u> -- page 163 "Tradition Four cautions us to be sure that decisions made by our group do not affect another group adversely or present an unfavorable or inaccurate picture of Al-Anon or AA as a whole."

Page. 187 "It should not be forgotten that we are a fellowship separate from AA with a different focus, but we often cooperate to bring recovery to all in need of it. Al-Anon's Sixth Tradition recognizes the influence of AA on our recovery program and states that we "should always co-operate with Alcoholics Anonymous." Over the years groups, areas, and even the WSO have cooperated with AA. An example of the spirit of cooperation on a worldwide scale is Al-Anon's participation with AA at our international conventions. In our districts and areas, large projects such as conventions and conferences are excellent examples of how cooperation can be in the interest of both AA and Al-Anon."

Al-Anon Information Center website/Texas website: There are links to AA/Al-Anon conventions/conferences.

4. What are the ethical implications of our choices?

Is it the District's responsibility to announce AA conferences with Al-Anon participation if those conferences are not in our District/Area? Examples: Manto-Man in Brownwood; Woman-to-Woman in Brownwood; Brazos River Conference; Crested Butte; AA International; AA State or District Conventions;

Do we want to announce AA events with Al-Anon participation in our District Newsletters or just provide a link? Example: "For AA events with Al-Anon participation, see Texas Al-Anon website, www.texas-al-anon.org."

How would groups perceive the District's announcing AA events with Al-Anon participation? Would they view them as functions of the District?

5. What do we wish we knew, but don't?

What is the general feeling of the District membership? If our District chooses to announce AA conventions/ conferences with Al-Anon participation in its newsletters, will this change participation in Al-Anon in our District and affect our unity?


