
Lori's Story

Hi all, my name is Lori, and I am a very grateful member of the Al-Anon and Alateen Family Groups. Anna asked me to share a little bit about myself and what I hope to accomplish in District 6 over the next three years, so here goes. Growing up, my parents were social drinkers, and I had a pretty normal childhood. When I met and married my first husband, I discovered a little too late that his mom was really bothered by my former father-in-law's drinking. She was extremely controlling and manipulative. Well, after about a year and a half of marriage, I had to walk away. I knew something was not right, much less normal. It began to affect me physically. I had sores in my scalp the size of quarters. I had headaches every day, and to top it off, I had been diagnosed (by her doctor no doubt) with a spastic stomach; if I did not watch it, I would end up with an ulcer. Unbeknownst to me, this was all due to the stress of being affected by the family disease of alcoholism.

Eventually, I made the geographic change and moved to Austin in October of 1989. I loved Austin and was dying to get out of Houston, so away I went, much to my mother's surprise, to a city where I really did not know anyone except for my former college roommate and her husband. I lived with them for a while then got my own apartment. I worked for Capitol Beverage, which is a Coors distributorship. I had worked for a beer distributorship in Houston before I moved to Austin, so it felt comfortable to me. I was at work one day talking with some of the guys that were coming in, and I just happened to be in between boyfriends. In fact, I had just ended an engagement to a guy that I dated when I first moved to Austin because it just did not "feel" right. He drank a little too much for me, which was about a six-pack a night. Anyway, I knew one of the guys had a younger brother, so I asked him, "David, what about your brother?" The other guys knew Doug and started to snicker a bit. David said, shaking his head and looking down at the ground, "Lori, I don't know; he is a good kid, but I just don't know." I thought, well, okay. Well, I ended up meeting Doug at David's wedding, to which I did not want to go because I am directionally challenged. It was way outside of Austin, near Paleface Park if memory serves me correctly. I begged our keg guy to please let me take care of his baby, so he and his wife could go. He said, "No, Curly, you are going!" He called me Curly, and I called him Dad. I ended up going by following someone else out there. I did get to meet Doug, and we hit it off right away. Almost a year later, we got married.

Lori's Story (cont'd)

That first day, I thought Doug drank a little too much, but, based on my experience with the guy that I had broken the engagement with, I chalked it up to an Austin thing, a culture.

After three years of marriage, DJ came along. We moved to Smithville January 1, 1995, and DJ was born April 21st. I thought for sure Doug would ease up or slow down when we started a family. Nope. I was always the bartender in the car. I remember a specific time going somewhere; we were just outside of Smithville, and DJ was in the backseat. Doug was asking for another beer, plus he had just had one. I said, "Please, pace yourself, or drink some water in between!" Doug is 6'5". I am only 5'3", and I am not going to tell you my weight; however, it could be a bit challenging for me when he drank. He said these very words to me, "I will stop drinking someday, just not right now." I really hoped and prayed it was soon because I was not sure how much longer I could hang on. He finally hit his bottom in December of 2001. He came in our room and said that he just could not live like this any longer (the drinking) and what should he do. The only thing I could say was to call his dad, as his dad already had 20+ years in the program. My first thought was that within 24 hours, we would be right back to where we started-"I am okay, I am okay," and he would continue to drink. The next thought I had was that I would never have to worry about him taking another drink again. By the grace of God, he has been sober for 13 years.

I share this much with you about my husband as he was the reason I sought out Al-Anon, but Al-Anon quickly taught me to keep the focus on myself and not on my alcoholic, much less anyone else since that always gets me into trouble. After a year of watching Doug in recovery, he was very much a program of recovery for me, and I wanted what he had. So, late December of '02, I went crawling into an Al-Anon meeting in Bastrop.

There were six women in the room that night. I could feel the peace and serenity that they had, and I wanted it, too. I heard two things that night: go to six meetings as close together as I could to see if Al-Anon was for me and to keep coming back, and that is what I did. I have to admit after a few years in Al-Anon, I thought, "I have got this. I don't need to go to any more Al-Anon meetings." Wrong....!! I quickly returned to my meetings.

Moving on to my introduction to service work, I was Jayne G.'s "Get in the car!" I will never forget my first district meeting or maybe it was an Assembly. I'm not really sure, but it was crazy. I looked over at her, thinking to myself and pretty sure it was evident on my face, "What on earth did you bring me to, Woman?". Anyway, I became my home group's GR, then the newsletter editor, then later, an Alateen sponsor, which I remain today as well as being your new DR. I am very grateful to Jayne for introducing me to service work as it has helped me to continue to keep my focus on myself and helping others. Thank you, Jayne! I love you.

I believe our vision and hope for District 6 over the next three years is to get more groups involved in service work, be it hosting a district meeting, volunteering in September in Smithville when District 6 hosts the AWSC meeting, or going for the different officer and coordinator positions. I have found that when I get busy in service work, I am not focusing on what my problem(s) may be at that time in my life. I have met a lot of new friends that I cherish, and I am very grateful for that. I hope those of you who are new GRs will continue to seek out different positions to see what joys they will bring you.

Thank you, Anna, for asking me to share my story and what our vision is for District 6. I have learned to Keep It Simple, and this is what I came up with.

Secretary's Report-Meeting Minutes January 31, 2015 Hosted by Courage to Change AFG, Austin, TX

Lori L., District Representative, opened the meeting at 9:03 A.M. Lori thanked Courage to Change AFG for hosting the meeting, welcomed the new members, and asked the new Group Representatives to introduce themselves. Kay, of the host group, made housekeeping announcements. Lori L. reported there were flyers for the 2015 Al-Anon Membership Survey, which can be completed on-line until Feb. 22nd. Paula H. reported that Shelley S. is in good spirits, is continuing to miraculously recover, and may be able to go home in the next few weeks. Bill reported that Shelley's home group has brought meetings to her in the rehab facility. Lori L. reported Lynn B., District Representative for District 5, passed away.

The meeting continued with the Serenity Prayer followed by the Three Legacies and Warranties. Lori L. passed the donation basket and the Ask-It-Basket.

Josie led a workshop on gifts we would like to receive from Al-Anon in 2015. There were four exercises: lose weight by creating a God Box; lose weight by creating your own tool box; get fit through spiritual conditioning; and gain wealth in Al-Anon.

The workshop ended at 11:00 A.M. The Business Meeting began and reports were given by the Officers and Coordinators. Alice M. read the revised minutes from the October 18, 2014 District Meeting (found on Page 7). There were no corrections or additions. Doon R. presented the 2014 District 6 Spending Plan and the 2015 District 6 Proposed Budget. Approval of the budget was tabled until after lunch. The donation basket held \$134.25. Adrian C. announced there would be an Alateen sponsor meeting during lunch. We broke for lunch at noon.

The Business Meeting resumed at 1:04 P.M. Roll was called for voting Group Representatives. There were 29 present. A 2/3 majority was 19. Judy W. handed out copies of Officers' and Coordinators' contact information and advised this information is also listed in the printed version of the Newsletter.

Judy W. suggested everyone read the guidelines on dual-membership on Page 82 of the Al-Anon/Alateen Service Manual. Judy W. then proposed a motion to open non-voting coordinator positions to dual members in District 6. Nancy moved and Charlotte seconded. The motion passed: 26 for, 2 abstaining, and 0 against.

Elections were held for open Coordinator positions with 29 voting GRs by 2/3 majority method. The results were:

(Paula H. offered to help whoever fills the position)

Ask-It-Basket questions were answered (found on Page 6).

Doon R. presented the 2015 Budget for approval. After a discussion on the amounts of prudent reserve and other reserves, the group requested that Doon R. reconcile the budget to the bank account and report at the next meeting on April 18th. Judy W. will also provide updated costs for the billboard and posters at that time. Tom B. moved to increase the prudent reserve. After the discussion, Tom B. withdrew his motion. Lori L. appointed a Thought Force to propose a prudent reserve for the District. Thought Force members are Tom B., Judy P., Doon R., and Jennifer M. They will make a recommendation at the April 18th meeting. Pat E. moved to accept the amended budget as presented. Jan B. seconded. The motion passed: 24 for, 1 abstaining, 0 against. The amendments to the budget were: correct spelling to AMIAS, delete 2015 Love Gift for Area Delegate, delete 2015 Donation to TEAAC, and delete 2015 Billboard.

The GRs gave their reports (found on Page 12). Lori L. announced Kathie F. needs female volunteers for Lockhart prison service. Her contact number is 512-705-8850.

Lori L. read a submitted suggestion: I suggest we reverse the meeting order and have the business meeting first. The group attendees would then have the choice of staying for lunch and the workshop. This would provide flexibility for the attendees – if they want to stay, they can; if not, they can leave. Puts the emphasis on the Business portion of the meeting. After a discussion, the group decided to keep the meeting agenda in its present order.

Ask It Basket January 31, 2015 District Meeting

- 1. I need an update on name and address, so our group can send in donations to District.
 - **Answer:** Information is in the District 6 Newsletter.
- 2. What is the most important role of a GR, in particular a new GR?

Answer: The most important role of a GR is to represent their group at district meetings and Area Assemblies, so their group has a voice, vote, and is heard. A GR should also bring information back to the group. This can be in small increments, such as announcements at different times to not take up a lot of meeting time.

- 3. How can we better embody the phrases "principles above personalities" and "say what you mean, mean what you say, and don't say it mean," while voting on finances?
 - Answer: Remember to modulate your voice. Everyone has an opinion so try not to say "you are wrong." Say, "I have a different opinion."
- 4. For newcomers' meetings and smaller groups that don't have a lot of retention of long-time members, any suggestions on how to inspire/motivate more attendees to stay or to get involved in service positions?

Answer: Share experience, strength, and hope - service kicks a program into high gear. Encourage sponsorship in meetings (maybe offer to be a temporary sponsor rather than wait for newcomers to ask). Emphasize benefits of service and the fact that no special qualifications are needed. Tailor service positions to meet the needs of your group (e.g., may not need Alt. GR, combine secretary and treasurer). Read Concept 9, especially Bill W.'s essay on Leadership.

Secretary's Report (cont'd from Page 5)-Revised Meeting Minutes (For Record) October 18, 2014 Hosted by Bee Caves Road AFG, Austin, TX

The meeting started at 9:01. Housekeeping announcements were made by Adrian C. She also introduced her group. Jayne G. announced there would be an Alateen sponsor meeting during lunch. Paula H. announced that Shelley S. is in Cornerstone Rehab in room ICU 9 and is in good spirits. Pat E. gave an update on herself and her broken kneecap. The meeting then formally opened with the Serenity Prayer followed by the Three Legacies. Everyone then introduced themselves. Paula passed the donation basket and the Ask-It-Basket. A workshop was then held on Three Nurturing Serenity-for the Newcomer-Activities: *Inspiration*, Gathering Courage-next step in recovery-*not working steps yet*, and Sharing Wisdom-*actively working steps*. The workshop ended at 11:07. Reports were given by Officers and Coordinators. The donation basket held \$112.00. We broke for lunch at 12:20.

We returned for the afternoon session at 1:15. Ask-It-Basket questions were answered.

- 1. Does WSO still send a free manual to new groups and also a binder with the "basics"? Answer: WSO sends a "Groups at Work" and a Service Manual only to groups and GRs. It takes several months for groups to receive their manuals.
- 2. How do I handle when, during a meeting, someone is making excessive noises during someone else's share? Example-Eating, opening crinkly containers. Answer: We put in an extra paragraph in the opening specifically stating what would be considered "distraction." We also try to talk to the person after the meeting.
- 3. Do group officers with three year terms get elected on the same schedule as the district or does it/can it overlap? Thanks! Answer: Tradition 3 says-Each group should be autonomous. If a group finds they have elections between district and area cycles, and

they wish to only do three years, it is in their right to do so. Just remember to send in Group Records Form with the new GR info.

4. What should a GR do if they only want to commit to one year, not the three year commitment? Answer: GR who resigns would be replaced by Alternate GR to finish out their term. If one person is willing to run for three years, and another only wants one year, the one year person should not run. But if the one year person is the only one who wants the position, one year is better than no GR and gives the group another year to find someone for a three year period the next year.

Personal Freedom AFG


