My Story (by Sheila Q.)

You know, I guess I could tell you how my life started and what it was like then and blame lots of things on what my parents did or didn't do for the way I am today. However, I know that's not reality, and the way I react today to life or what brought me to Al-Anon are the same things that keep me here. My story has changed from when I first arrived, and I blame no one for the choices I made until I finally got to the rooms of Al-Anon.

My childhood was happy, scary, unpredictable, and full of love. Most of the adults in my life drank. Drinking, partying, and chaos were the norms. My dad had a full time job but retired when I was young with health issues as a result of heavy cigarette smoking and drinking. Up until then, things seemed OK, or "normal." My mom went to work in an uncle's bar, and my dad would sit and drink and smoke while she worked. My brothers and I depended on my grandparents during this time, or we were home alone or at the bar. My mom was loving, but very busy from work, household chores, gardening, and a night life. Now, I know she did the very best she could.

We lived on a farm so I learned to hunt, fish, milk cows, make hay, raise a garden, ride horses, slop hogs, and feed chickens, pigs, cows, turkeys, peacocks, and horses. I also enjoyed a lot of other fun adventurous excitement that goes along with farming. Needless to say, I was a tomboy. These were happy times! I loved that farm; the animals and my grandmother were my staples. We come from very hard working people.

I also endured sexual abuse early in life and as a young girl and know that this is unfortunately common for men and women in alcoholic homes. While I don't wish this on any child, I know my Higher Power was always with me, and I am the person I am today because of everything I experienced in life. It also seems that I have many opportunities to share my experiences with women in the program.


In my teens, I drank (a lot), did some drugs, and really didn't have to answer to anyone. I'm very lucky to be alive. So many of my friends didn't make it, from car wrecks, fights, over doses, and other diseases directly related to untreated Al-Anonism or alcoholism. I didn't have any balance in life, had low self-esteem, and looked to bad boys for love. I was very promiscuous and thought it was love.



My Story (cont'd)

In school, I thought I didn't fit in but through my Fourth Step, I uncovered that I actually participated in lots of activities. I was a cheerleader, majorette, served on the yearbook team, played sports, and sang in choir. I always had the stinking thinking going on from a young age. At school, I did very well until my senior year when my grandmother died from diabetes [maybe untreated Al-anon(ism)]. I almost quit school, but my guidance counselor called my parents to school and wouldn't let me quit. I'm so grateful to Mr. Gonzales.

I got pregnant right after graduation, got married, and had a beautiful baby girl. Her father was the first love of my life. When we split up, I felt like I was going to die. I soon turned to other men for comfort, my go-to. I had to have someone that I thought loved me, and I them, to fixate on to feel secure, and this is what I thought was happiness.

My daughter is the joy of my life today. She did not, however, have the best upbringing. Despite this, she is a wonderful daughter, mother to two girls, and great wife. Today, I hope to be a better example due to the program.

I moved to Texas in the early 80s, and married my second husband. There were many affairs and relationships in between. We met in a bar (my go-to place for prey/next victim), and we had a love-hate love affair. When I wanted to settle down, he wanted no part of it. I remember the last time he disappeared for days. I sat on my front porch crying, praying to God for help (the only time I really prayed, when all hell broke loose), wondering why I was in so much pain and why I felt as if I were dying? Sound familiar? I thought I was different than most people and that everyone else had "the" secret to happiness.

I believe that I too suffer from the disease of alcohol(ism) – the I, the self, the me, or what I like to refer to as Internal Spiritual Malady. That night, as I sat on my porch feeling like I was dying, I didn't know where to turn, and I called a suicide hot line just looking for someone to listen. The lady on the phone ask if I ever heard of Al-Anon? That phone call got me and my husband into recovery and introduced me to a new way of life. I went to meetings and had a sponsor for about three years and then again divorced, did a geographical cure, and moved closer to family (co-dependence).

After I moved, I quit going to meetings, found another guy in a bar, and got married. He didn't speak English and was 18 years younger than me, a drinker, and spicy, (my picker just kept getting worse as my disease progressed).

I remember thinking – "Wow, I am improving." We dated six months before he moved in with me and married after one year. After my third marriage and divorce, I had many one night stands, affairs, oneway relationships, and only then did I finally hit a low rock bottom. Men were no longer the answer, and I couldn't live with them or without them. I was restless, irritable, and discontent. Everything in my life up to this point all led me to look for an answer to my problems. I almost lost my job, had no clue who I was, and was alienating myself from my family and a precious daughter and granddaughter that I loved very much.

I knew where to go for help. I went to counseling and Al-Anon. I was diagnosed with PTSD from this disease, which is also common. I needed professional help to uncover the buried memories from my childhood. I had no clue that alcohol(ISM) was the problem. I was willing to do anything this time. I got a sponsor right away, did whatever she told me, and tried to go to as many meetings as possible, which was about three or four per week. I still go to about three per week.

My home group is the best group, I am so grateful! We make newcomers the most important people in the room. We make sure they are welcomed, listened to, and most importantly - Loved! But, what I am most grateful for are the women and men in AA and Al-Anon, and my sponsor (who is the best sponsor in the world and who suggested that I go to open AA meetings). This really opened my eyes to this disease. It also healed me from the bitterness and anger I felt for my family. I believe that absolutely nothing in this world happens by mistake, and my attitude is everything. I pray to remain willing, open, and honest. Acceptance and rigorous self-honesty are the keys to life for me. Today, I know one thing for sure - "I don't know much of anything."

I'm getting ready to begin studying the principles a third time to discuss the relationship across the same Step, Tradition, and Concept. What a blessing this program has been. My self-discovery and the relationships just keep getting deeper and better. I am truly a grateful Al-Anon and plan to keep coming back to help carry the message to others that need help the way I did when I arrived 12 years ago. I must mention the wonderful gift of sponsorship! I sponsor the most loving women. I have learned so much from them about myself and feel so loved. Words cannot express my feelings and how they have changed my life.

Through a daily routine of RPMs (reading, prayer, and meditation), I grow in my experience of a Higher Power. It's so true what they say – to believe in God is not good enough. For me, I have to live in GOD - a conscious daily awareness of a living, all-knowing, allloving God. This is a daily surrender of my will. As soon as I get out the door, usually in traffic, I take it back, but that's OK. This is what keeps me surrendering. This is what keeps me sane and able to live life on life's terms.

The promises have come true for me in recovery and Al-anon has saved my life. The solutions and answers I sought for all of my life are in the literature, meetings, conferences, my sponsor, phone calls, RPMs, and you. I have so many true friends and am so grateful that I found what was inside of me all along my spirit, Good Orderly Direction, aka GOD! Thank you!







Officer Reports

District Representative - Judy W.

Thank you to those who have responded to updating your GR-1, Group Rep Change Forms! I hope to bring more blank GR-1 forms and our district's latest contact information (from the database) to the next district meeting scheduled for April 28th (in Cedar Park).

It is very challenging having approximately 80 groups in our district, to have multiple names per group, and wrong names in our Area's District 6 Group Records database. For this reason, my plan in the future will be to send the district communications to the GRs and continue reaching out to other groups that do not have a GR named. Our District 6 South and North Public Outreach Coordinators, Spanish Coordinator, Alternate District Representative, and I plan to visit those groups to help update our district's records. We will invite the Information Center's Meeting Committee to also validate group information. Updating/ validating your group's meeting information helps our district work closely with the Austin Information Center to keep their records as accurate as possible, so when those in need reach out, we can provide accurate responses. WSO will continue to send their all electronic information to the Current Mailing Address (CMA) contact.

Since our January district meeting, an Area World Service Committee (AWSC) Transition Meeting was held (1/26 to 1/28) in Gonzales, Tx. The meeting offered opportunities for topic refreshers, learning new things, and networking with other new three-year term AWSC members. Some key highlights included:

- Sharing our District 6 coordinators' contact information for Public Outreach, Spanish, and Alateen with neighboring DRs from District 5 (Houston) and District 13 (Kerrville). We also discussed Spanish bilingual translation ideas with District 4's previous DR and now our new Area Alternate Delegate.
- Receiving a very helpful demo of the Texas Web site. The new service manual can be downloaded (free) off the main Texas Web site, http://texas-al-anon.org/members.

- Reminder that the hardcopy manuals will no longer be free and sent to the groups. (I have asked the Information Center to send English and Spanish service manuals to our next District meeting. Estimated Cost: \$5)
- Verification that the latest GR-1 Forms (English or Spanish) and many helpful WSO guidelines are now found under the Texas East link.
- Attending a workshop on Knowledge Based Decision Making (KBDM); presentation (English or Spanish) is under East TX Area Information and Guidelines.
- Confirmation that The Forum (a previously free subscription) will no longer be sent to the groups; it must be purchased.
- Discussion that prep work by the DRs from Districts 4, 5, and 7 on realignment is expected to begin. Minor group changes are expected to be the start of the realignment based on geographic group locations. We hope the DR work will be published in a future Beacon so that a vote may occur at the November 2018 Assembly meeting.
- A Task Force was appointed to formalize interview questions for the recertifying Alateen Sponsors that want to use a self-guided study approach. Only two Alateen trainers exist so our Area Alateen Coordinator is also interested in getting more trainers ready throughout our Area.

Our Area Delegate sent District 6 a very nice Thank You note for our love gift to help supplement her out-of-pocket expense when she attends the annual April World Service Conference. I will bring the card to the next district meeting.



Secretary's Report – Doon R. Meeting Minutes
January 20, 2018

Hosted by: Central Texas Serenity Seekers AFG Grace United Methodist Church Fellowship Hall

Judy W., District Representative, called the meeting to order at 9:01 A.M. and thanked the host group, Central Texas Serenity Seekers AFG. Barbra H. from the host group welcomed everyone.

A moment of silence was observed, followed by the Serenity Prayer and the reading of the Twelve Traditions, Twelve Concepts of Service and General Warranties of the Conference. Judy W. welcomed 5 new GR's and asked them to see her for a new GR-1 Form. After introductions, the Ask It Basket was passed.

The business meeting began at 9:01 A.M. with the officers' reports (Page 5).

Judy W. presented her report and asked for assistance in learning G-mail for group e-mails. She announced her e-mail for District purposes: etx.district6@gmail.com

The 7th Tradition basket was passed. \$198.00 was collected.

Anna A. recognized chairpersons who participated in Fall Assembly and reported on its success.

Doon R. asked if there were any corrections or additions to the October 21, 2017 minutes as printed in the "Winter 2018 District 6 Newsletter." There was one correction: page 7, Update, July district meeting will be on July 21, 2018. The minutes were approved as corrected. Changes to the group meeting schedule will be brought to Janie by Judy W.

Robert G. presented the 2017 District 6 4th Quarter Operating Statement. (Page 9)

The coordinators' reports followed. (Page 11) Paula H. reported for AIS Liaison (position unfilled).

Everyone enjoyed participating in a Jeopardy game led by Barbra H., Robin C., and Julie R.

The group took a 20-minute break and resumed at 10:50 A.M.

Pat E. is the Registrar for TEAAC, 4/13-15, 2018. Bennie P. is Registrar for POSSE, 3/23-25, 2018. Robert G. requested that all district business be mailed to the Treasurer's PO Box, not to his residence.

Judy W. presented a summary of the current district meeting format in preparation for new business meeting topics with an aim to working on education and taking our program to the next level. She requested groups consider hosting the October 2018 district meeting.

Doon R. called the roll. There were 46 attendees with 26 voting GRs. A 2/3 majority was 17 votes; a simple majority was 14 votes.

Old Business: Robert presented the proposed budget for 2018. Some discussion followed regarding financial needs of Archives and content of Archive literature. Discussion to resume after lunch.

The group broke for lunch from 11:34 A.M.

The business meeting resumed at 12:30 P.M.

Doon R. took a count of members still in attendance. There were 44 members with 24 voting GRs. A 2/3 majority being 16 votes; a simple majority being 13 votes.

Old Business Continues: Robert G.'s presentation of the 2018 budget resumed. After further elaboration, it was unanimously approved as revised.

Deanna M. reported that progress on the distribution of Alateen school posters has been very challenging. Additional volunteers are needed to help provide feedback on streamlining the process.



There are still 17 schools to get posters to. She is learning the chain of command. Seekers of Serenity AFG is forming a group to work on the project. Rosemary and Kelly T. will help support her.

Bill W. provided an update on the "Thought Force on increasing Alateen and Alateen GR membership and participation in Al-Anon functions." Its conclusions: active outreach is the goal, along with personal outreach, keeping in mind the slogan Let it Begin with Me and Step Twelve. He encouraged GRs to go to meetings and announce what Alateen meetings are available, to announce every week, and to get certified, so they'll know what they're talking about. He also encouraged them to motivate their group members to get certified. Bill made some posters. The Thought Force was dissolved.

New Business: Judy W. led a discussion on format of future district meetings. GRs considering several ideas: speakers on the study of principles (Traditions/Concepts); conflict resolution; games; knowledge-based decision making at district level; A Day in Al-Anon - Traditions; and a workshop on the new service manual.

Judy W. asked for volunteers for a "District Workshop Thought Force" to present ideas at the April 28, 2018 district meeting. Cathy M., Betty B., Josie R., Barbara M., and Peggy D. agreed to serve on the committee.

Jessica P. announced the deadline for the newsletter cover story is due by February 28, 2018. She asked if there has ever been a request to have the newsletter in Spanish. Paula H. stated she'd translated Secretary minutes in the past. Her experience was that it was not as effective as face-to-face communication, and an inroad with feedback first might be helpful. Jessica

asked if we can have the newsletter in Spanish on the Web site. Pat I. suggested a social media link.

Judy W. expressed the desire to gather info about Alateen participation regarding ½ scholarships for POSSEE attendance and mentioned that a list of past motions is needed. Per Anna A, old Newsletters contain previous motions and have been provided to Jessica P.

Ask It Basket January 20, 2018

1. What is the position of Al-Anon on the use of social media (Facebook, Instagram, Pinterest) for outreach?

Answer: WSO is working on further guidelines on social media. The service manual has words of advice about respecting anonymity. At the group level, a private Facebook page has been beneficial to build good fellowship among the members.

This might be a good one-day workshop topic - inviting an "expert" or two to describe how Facebook and other social media can be taken advantage of at the group and district levels. It sounds like Alateen could be a separate discussion at the workshop.

General discussion followed regarding concerns for anonymity and personal privacy; that it does not take the place of a sponsor; and that there should be someone to monitor content. Per Pat E., WSO has monitors for content.

Judy W. will ask Kay C. about WSO guidance as we try to engage younger members. Pages 110-116 in our service manual provide some guidelines and suggestions.

2. Ideas on how to retain newcomers?

Answer: Make more personal contact after meetings, follow-up call, group e-mail (some that are not still coming want to remain on e-mail list), greeter at meeting who has packet for newcomer.

3. Ideas on how to get better contributions from members?

Answer: Make sure Service Manual 7th Tradition language is encouraging people to donate what they can. GR can communicate group to donation is more than just rent. It can also be applied toward the budget for Area, District, and AIS contributions, for newcomer's literature, GR participation, and public outreach.

4. Any funds available for info packets/booklets? Our group goes through a lot. It's expensive for our smallish group.

Answer: Some groups can't sustain the gift of newcomer packets. GRs and officers need to say that we have certain financial obligations and are entirely self-supporting. Groups can have a meeting on the 7th Tradition and can build their own less expensive, mini newcomer packets.

5. What is the process for current AMIAS to be recertified?

Answer: A current AMIAS can recertify by viewing the online manual, having a phone interview with a trainer sending in the paperwork, and completing a background check.

It is recommended that we attend a workshop, even if it is not necessary, in order to share experience, strength, and hope.




Public Outreach (North) (by Susan T. – new coordinator)
