My Story

Growing up, we were the family who lived in the biggest house on the block with a nice swimming pool. The neatly manicured lawns and mirrored windows gave an illusion of normalcy, but on the inside we lived in fear of my father's wrath. My father was a workaholic, as well as an alcoholic. Sometimes he would work seventy hours a week, and when he wasn't working, he was at home drinking.

There were early memories of my dad when he was happy. I remember the parties my parents hosted where everyone would play pool, dance and drink. I can recall the scent of Jean Nate perfume and aftershave, as my parents headed out for a night of dancing and drinking while we stayed with the sitter. These seemed like good times from a child's perspective. I took pride in being able to make an acceptable vodka tonic. However, as the years progressed, the disease got the best of my dad. He became bitter, resentful, and angry. We all did the best we could to survive.

My dad saw the importance of an education and planned for us all to go to college. I went off to school damaged. I had trouble trusting and building healthy relationships. I dabbled in drugs, always searching for peace and acceptance. I practiced paganism, Christianity, metaphysics and Buddhism. Still I searched...I even attended a few AA meetings in college but figured they weren't for me. I felt a deep void inside as if something were missing.


It wasn't my dad who drove me to Al-Anon. After raising three kids as a single mom, I reunited with an old friend from high school. We fell in love and got married. Nine months later we had a son. I knew that he had struggled with alcohol, but at the time, I didn't realize that it would be an ongoing struggle and that it was incurable. Our family became a bad reality show. We yelled and screamed in the front yard. I stalked the parking lot of the local honky tonk bar for his car. One time I broke my hand punching my husband in the head and another time, knocked him out cold with a frying pan. I left him

Judy W. recognized four new Group Reps and welcomed everyone. After introductions, the Ask It Basket was passed. Treasurer Robert G. asked that group contributions be given to him. The Seventh Tradition donation was \$188.00.

DR Announcements

Judy W. announced the host of the District Meeting on April 18, 2020 will be Let it Begin with Me AFG in Dripping Springs. She requested hosts for July 18, 2020, and October 17, 2020. For guidelines see the hosting checklist on the TX website under District 6. She also invited the contribution of love gifts for our Delegate Kay C. for her trip to the World Service Conference in April to represent our Area (Texas East Area 53).

Distributed Report Questions

For Secretary Doon R., Judy presented the October 2019 Minutes as printed in the *Winter 2019 District 6 Newsletter* and provided to GRs electronically prior to the Business Meeting. There were no additions or corrections. The Minutes were approved.

Treasurer Robert G. presented the 2019 District 6 4th Quarter Operating Statement. A discussion about making a donation to WSO was held later in the meeting. Since TEA AC (Texas East Area Alateen Conference) has been discontinued, that line item will be removed from the Budget. Robert needed to see those requiring reimbursement before the close of the meeting.

Newsletter Coordinator Mary M. distributed her report electronically prior to the meeting and had no report at this time. There were no questions.

Upcoming Events & Volunteer Opportunities / Al-Anon Related Announcements

Alateen Coordinator Pat E. spoke on P.O.S.S.E (Program of Sponsors Sharing Everything) for current sponsors and those interested in becoming sponsors, who can be certified there. The event will be held on March 27-29, 2020. The cost will be \$125.00. Some one-half scholarships will be available at a cost of \$62.50.

District 6 ATAAC Representative Paula H. provided information on ATAAC, the All Texas Al-Anon/ Alateen Conference in Houston, February 7-9, 2020 to be held at the Marriott Westchase, Houston. To register, go to www.ataactx.com.

ATAAC 2021/2022 will be in Fort Worth.

ATAAC will be coming to Austin in 2023 and 2024. An Austin Rep is needed to chair this event. A resume form is available for those who are interested in running for the position. In order to understand the position, anyone interested is encouraged to attend an ATAAC prior to hosting.

Public Outreach Coordinator (South), Dave L. received a letter from Austin Recovery inviting the participation of Al-Anon speaking panels. Austin Men in Recovery will have a group conscience about overseeing the panels. Dave L. brought a sign-up sheet for volunteers.

AAIC Liaison Kathy J. reminded group members to attend the next AAIC Board Meeting at Northland on February 18, 2020, at 6:30 pm.

NEW BUSINESS (GRs Propose any District Motions, etc.)

Roll Call & Voting Procedure Agreement

Roll was called by Doon R. There were 33 voting GRs, a simple majority being 17 votes, a 2/3 majority being 22. Each group gets one vote. The GRs would use a simple majority for usual business matters and a 2/3 majority for election purposes.

Approve 2020 Budget

Robert G. presented the 2020 Budget. Several points of discussion followed, some of which were: Should we add a line item for donations for WSO? To Area? How can we do more outreach with the money we have?

We have 80 groups (not meetings). Some have a lot of funds, some are just making it. A GR expressed a preference for not adding additional line items, so we would not be limited to a certain donation amount, but rather to address an issue we choose by vote, perhaps quarterly. If the GRs need more information than we have available today, we will resume the discussion in April.

Questions and suggestions followed. Several points were brought up. Less than 20% of groups are supporting the District. We should take care of the District first. In previous discussions regarding excess funds,

it was determined that excess funds we do not use will be donated to WSO. Do we want to put money into P.O.S.S.E. scholarships or onehalf scholarships? We should use what funds we have already designated first, then add to that as desired. Currently, we have four unused one-half scholarships. Full scholarships should be available because trusted servants' costs should be covered. Scholarships are intended to cover part of the costs, not full expenses. The discussion would resume later during the Unallocated Funds presentation.

A motion was made to accept the 2020 Budget with TEA AC discontinued. The Motion passed unanimously.

Elections

ELECT DISTRICT GROUP RECORDS COORDINATOR

Judy W. discussed the importance of a District Group Records Coordinator (DGRC) to encourage GR contacts. This person coordinates with the AAIC and Area. Connection to WSO and their records is vital. The Alternate DR will support the new DGRC to learn the position. The elected DGRC will not serve a full 3-year term. They will complete the current term through December 2020. Cathy M. from Keep it Simple AFG /Buda stood for the position. Because there was only one candidate, ballots were not required. Cathy M. was elected DGRC unanimously.

ELECT DISTRICT REPRESENTA-TIVE

On January 14, 2020, Judy W. notified the District of her decision to resign as DR at the conclusion of the January 18 district meeting. Her resignation made it necessary for the District to elect a new DR. The elected DR will not serve a full 3-year term. The person will complete the current term through

December 2020. Anna A., current Alternate DR volunteered to serve in this capacity. Because Anna ran unopposed ballots were not required. Anna A. was elected DR unanimously.

ELECT ALTERNATE DISTRICT REPRESENTATIVE

With Anna A. being elected DR, it was necessary for the District to elect a new Alternate DR. The elected Alternate DR will not serve a full 3-year term. They will complete the current term through December 2020. It is necessary to be or have been a GR in order to bring experience to the position. Lynn P. from Faith AFG volunteered for the position. Because there was only one candidate, ballots were not required. Lynn P. was elected Alternate DR unanimously.

Identify Free District Newsletter Recipients

Newsletter Coordinator Mary M. requested stories for the District 6 Newsletter. The GRs expressed a desire to continue free newsletters to past delegates if they choose. Comments followed. A question to be discussed at a later time: Do we need to include some of the things we currently include in the hardcopy when we could use the space for other things? The newsletter is available online at http:// austinalanon.org, under the District 6 tab. But, to protect anonymity, the online version does not include Officers' and Coordinators' contact information.

A Motion was made to send a free copy of the *District 6 Newsletter* to past delegates. Due diligence will be taken to ensure past delegates wish to receive them before sending. The Motion passed unanimously.

Survey – Al-Anon Awareness to Help with Use of Unallocated Funds/Public Outreach

Judy W. reported that Jenny D. is preparing three or four survey questions for an email push to the District. The questions are meant to get an idea of how members found Al-Anon to help focus resources when it comes to Public Outreach and potential use of district unallocated funds.

District Workshop Format Committee – Status Update

For the status update, Josie R. reported they have created a chart to allow access to a variety of workshops and related material. On the Texas Al-Anon website (texas-al-anon.org), go to Members and scroll all the way down to the bottom to find the workshop option. She encouraged members to submit presentations.

Unallocated Funds /Day in Al-Anon Thought Force - Status Update

The Unallocated Funds /Day in Al-Anon Thought Force status update will be presented by Mary R. following the afternoon Workshop.

Spanish Website Tab – Status Update

Pat I. introduced Maria S. and Leandra M. from Nueva Vision AFG who reported on the fellowship enjoyed and success of the Fifth Statewide Hispanic Al-Anon / Alateen Convention (Quinta Convención Al-Anon/Alateen Estatal Hispana de Texas). On behalf of the Hispanic Al-Anon / Alateen Family Groups, they thanked all the other District 6 Al-Anon /Alateen groups for their moral support, service, and donations. Special thanks to those who contributed basket items, which were raffled and proved to be a

significant help in funding the Convention. It was also reported that the \$3,000 allocated to the Convention from the District to cover any losses was not needed.

Alateen School Poster Distribution Task Force - Status Update

Judy W. and Anna A. gave an update to the group. Lorelei L. has the posters and last information they gave her. They've been in contact with the printer. They're ahead of the curve, and the project will continue.

Domain Thought Force – Status Update

Judy W. spoke on behalf of the Thought Force. At one time, the District was considering setting up its own domain. However, the Texas East Al-Anon website has proven to be effective in storing district information. Some information has already been posted to the Texas East Al-Anon website, such as the hosting procedure for District Meetings and workshop information. We have more space available. As you come into the Texas East Al-Anon website, search for "District 6" to find the District's web page. With the availability of the space on the Texas East Al-Anon website, the Thought Force is dissolved at this time.

A musical Al-Anon skit, "Powerless over Pickles" was presented by Hilltoppers and Bridge to Shore AFG. Participating members were Joe M., Max, Lauren K., and Judy M.

The group broke for lunch from 12:15pm until 1:17pm.

BUSINESS MEETING CONTINUES

A second roll call was taken. There were 25 voting GRs, a simple majority being 13 votes, a 2/3 majority being 17. Each group gets one vote. The GRs would continue to

use a simple majority for usual business matters and a 2/3 majority for election purposes.

Parallel Work Sessions Begin

The GRs chose the subject that was of most interest to them and broke into two subgroups. They discussed additional ideas to take forward and made suggestions about what can be done next. Readouts would be given after completion.

The meeting took a break at 2:00pm and resumed at 2:05pm.

Josie R. reported on behalf of the District Workshop Format Committee. She shared that she continues to be grateful to serve.

Workshop Committee Members last met at the January 18, 2020, District 6 Meeting. As committee lead, she shared their progress during the business meeting, and their group participated in a break-out session to continue the work of honoring and preserving the workshop activities of District 6 members.

Available committee members met the weekend before the District Meeting to discuss how best to scan, save, and send the collected workshop/skit presentations to the Texas Al-Anon website. Josie expressed much gratitude to committee member Deanna M., who volunteered to scan all the hard copies received, and to everyone who continues to support their work.

Next Steps: Continue to ask for and collect workshop/skit presentations. Send collected and scanned workshop/skit presentations to our Texas East Area 53 Website Coordinator. Request time for committee members to work in a break-out session at the next district meeting.

Mary R. reported on the Unallocated Funds /A Day in Al-Anon Thought Force work session. There are two

areas of recommendation for excess funds: 1) to support Alateen in whatever way possible. This would include money for training AMIASes as well as supporting Alateen groups with literature; and 2) to support Al-Anon groups in providing education and information to communities as well as providing training for Al-Anon groups. Each instance of support would need to be studied to assure compliance with the Three Legacies of Al-Anon.

A Motion was made regarding AMIAS P.O.S.S.E. scholarships: Motion to increase the Budget to a total of \$1,750 (addition of \$1,500 added to the existing Budget of \$250) for P.O.S.S.E. to cover 100% of 14 registrations. The Motion passed unanimously.

A Motion was made to give \$7,000 dollars to WSO from unallocated funds as a one-time donation. The Motion failed.

A Motion was made to give \$4,000 dollars to WSO from unallocated funds as a one-time donation and to have another review of surplus funds once 2019 numbers come in to support WSO. The Motion passed with 20 votes for, two against, two abstentions.

The Unallocated Funds Thought
Force is now dissolved. Judy asked for
volunteers for a Task Force for
Unallocated Funds to polish-up a
form and create a process /guidelines
to request any remaining surplus
funds. Josie R., Dave L., and Robert
G. agreed to serve. Dave L. will head
it.

Announcements

Pat E. has a form to fill out to register for P.O.S.S.E. She offered to get it to the GRs if they give her their email address. She has an article in the "Winter 2020" edition of the *District 6 Newsletter*. She shared that we have sponsors for Alateen groups that don't

have any kids and asked members to spread the word at Al-Anon and AA meetings. Michele P. offered to email the flyer she made to increase Alateen's attendance. In addition, Pat announced there will be a P.O.S.S.E. training at the AAIC on a Saturday, probably in April.

In honor of Bill W., Bill H. is carrying on the project Bill W. had underway. He is working with Austin Independent School District to have Alateen meetings in the schools. His contacts have been very cooperative but often difficult to reach. More Alateen members' participation is needed.

A drawing was conducted, and the winner of a subscription to *The Forum* was Michael H.

GRs shared their successes and challenges. A GR asked whether it would be appropriate to provide baskets for ATAAC. The Conference is not like an Assembly. It is independent of the District and Area. Baskets from individuals would be welcome, but they should not be contributed by groups.

Ask It Basket questions and answers will be addressed in the context of the *Service Manual* and will be published in the next *District 6 Newsletter*.

On behalf of herself and the District, Anna A. expressed her gratitude for Judy W.'s service and fantastic ability to facilitate, saying she had learned so much. Anna A. also thanked Judy W. on a personal level for her help in alleviating Anna A.'s stress during her service positions. She is grateful for a strong, healthy District and will do her best as our DR. She expressed confidence in Judy W.'s decision but is sad to see her leave.

Judy W. reminded the group that Al-Anon is a "we" program. "We" is

the first word of the First Step. And life gets easier when it's a "we" program. Stepping down was not an easy decision. She expressed gratitude for some of the things she heard in the skit today and is very, very grateful for the support of the members. She shared that stepping down feels right today based on all the information she has about what's going on in her life. And if she finds out later that it wasn't the right decision she can always make a different one. That's something our program has taught her. She concluded by thanking the group for letting her be of service and for all the interactions she's had with the members, each of whom has touched her life in some way.

CLOSING

The Meeting closed at 2:55pm with the Al-Anon /Alateen Declaration in English and Spanish.

Let It Begin With Me. When anyone, anywhere, reaches out for help, let the hand of Al-Anon and Alateen always be there, and Let It Begin With Me.

stranded in New Orleans in the middle of the night, banned him to the trailer outside the house, and contemplated calling the authorities on him numerous times. The disease had affected me. I struggled with depression and had suicidal thoughts. I endured physical, emotional and mental abuse. Not only was I broken, but worse, I was paralyzed.

I was so caught up in the chaos that at times saw death as the only way out. Desperate, I found a counselor who suggested that I attend Al-Anon. I sporadically attended meetings while we lived our lives in cycles. When my husband drank, our lives were like a cyclone, and then the winds would settle and life would become somewhat bearable. Yet, depression cast a dark cloud over me.

I started to attend Al-Anon meetings more often and began to like what I heard. I found people who could relate to my stories, for they had once played in their own bad reality shows. I listened at the meetings. I began to see a way out. I found people who accepted me despite all my flaws, and with each meeting, I grew stronger. In fact, when the next disaster struck, I had the strength and courage to take myself and my son to a safe place. There we stayed for three months while my husband went through rehab. Those months living with my in-laws allowed me to attend meetings, see my counselor, take horseback riding lessons and begin the slow process of healing because I was just as sick as my alcoholic or even more. We laughed and cried in the meetings. I found peace, acceptance, love and my Higher Power. I finally found what I had been searching for my whole life.

After getting a wonderful sponsor and working the program for two years, the deadly disease of alcoholism finally crippled my dad. I always say that alcoholism doesn't discriminate. Last August he was bedridden, dying from cirrhosis of the liver and kidney failure. My scary giant of a father was now feeble and weak. I took care of him. I fed him, administered his medicine, played his favorite oldies and told him stories. My dad gave me some of my greatest gifts, such as my staunch work ethic and my love for travel, literature and knowledge. These were the things that I was able to thank him for in the end. I was able to show my dad mercy, the same mercy that my Higher Power has shown me, and care for him with the tenderness and love that only comes from God. I know now that my dad did the best he could with what he had. I am forever grateful to Al-Anon for giving me the ability to mend my relationship with my dad, to pray over him in his final hours and to hold his hand in his final minutes.

I don't have to look for peace and acceptance anymore. It waits for me at an Al-Anon meeting. It is readily available in the literature. It's just a phone call away to my sponsor. I do the best I can with what I have, and I am grateful because now I have so much more.

As of the vote at the recent District Meeting, a free copy of the District 6 Newsletter will be sent to those past delegates who want it.



1. Someone at a meeting said their GR unilaterally decided to limit the group's group conscience meetings to one hour. This doesn't seem to follow Tradition 2. How should the situation of determining the length of group conscience meetings be handled?

The length of the group conscience meeting is autonomous. Page 51 of the Service Manual: "The group conscience is the will of the group. The guiding principles for the group conscience are always the Twelve Traditions and the Twelve Concepts of Service.....Some simple group decisions may be decided quickly; however, others take time. It is by taking the time necessary to hear from all members who want to participate that a group conscience evolves." See Page 51 for additional information.

2. How can the district assist with starting groups in small towns? How are we as a district able to help groups start in towns and counties with no Al-Anon/Alateen meetings? Tradition 11 should guide this.

Those interested in starting the group should work out the details of how the meeting will be conducted and review the guideline *Starting an Al-Anon Meeting* (G-12). They should then contact the District Representative or District Group Records Coordinator for information on how to register

The district can help them follow the proper procedures to register with the WSO. Once the registration is complete, the GR or group contact can work with the district to get on the Austin Al-Anon Information Center meeting list and work with the district's Public Outreach Coordinators to further get the word out about the meeting(s). Additional information can be found on Pages 33-36, 46-47, and 118-126 of the Service Manual.

3. Where can I find the suggested group contribution amounts/percentages to outside organizations (i.e., WSO, District, etc.)?

Although an Al-Anon group supports Al-Anon/Alateen financially at all levels of service by contributing to the District, Al-Anon Information Services (AIS)/Intergroup, Area, and WSO, Al-Anon/Alateen groups are autonomous in their financial matters. Additional information regarding group finances can be found on Pages 56-57 of the Service Manual and in the Reserve Fund Guideline (G-41).

Page 103 of the Service Manual: "In any calendar year, an Al-Anon member may contribute in gratitude to the WSO any amount up to one percent of the total revenue of the WSO General Fund as identified in the previous year's audit. When giving locally to our groups, Districts, AIS/Literature Distribution Centers, Areas, or General Service Offices, we make our gifts in a similar proportion to the revenue and expenses of these service arms... Our contributions express our individual abundance, so no one donation, regardless of amount, is more important than another." Additional contributions to WSO can also be made through birthday plans, memorial contributions, quarterly appeal, workplace combined giving campaigns, and bequests. See Pages 103-105 of the Service Manual for additional information.

4. Have any groups had issues around safety? If so, specifically how were the issues addressed.

See Let's Talk about Safety in Al-Anon Meetings! which can be accessed at https://al-anon.org/for-members/group-resources/ and then selecting the "Safety in Al-Anon Meetings" button.

This document addresses problems found in the outside world that can make their way into the rooms of Al-Anon, including (in part) dealing with disruptions, group safety and unity, Al-Anon and the law, emergencies, and what groups and members can do. Be aware that the document applies only to Al-Anon meetings, groups, and members. For Alateen, refer to Alateen Safety and Behavioral Requirements.

If district members would like to have a discussion about safety in Al-Anon meetings, they are encouraged to email the District Representative at etx.district6@gmail.com for potential inclusion at a future district meeting.

5. Would it be possible to use District extra funds, or unmarked funds, to host an event that would help group members connect to a sponsor?

We are developing a form to request funds from the District. When submitting the request and in any subsequent discussion of the request, consideration should be given to the event objectives, date and length, venue, hosting volunteers needed, and any other pertinent information. This will help the GRs in their voting decisions. The use of unallocated funds will require a vote from the GRs present at the district meeting in which the request is presented.
