Our Area Alateen Process Person's Story...

After 18 years of marriage my husband decided the best way to deal with his drinking was to get rid of his wife, two teenage children, two dogs and two cats. When I agreed that divorce would probably be the best for all of us I retained a lawyer. My thinking was he would help me do something I never thought would happen to me become a divorcee and I would be alright. My husband was in another state with his job and I called him to let him know I had spoken with the lawyer and decided to "let him go". He was so happy with the news he went out to celebrate, wrecked his vehicle and ended up in the "drunk tank" of the local police station. His employer and the local judge were not impressed with him at all nor did they consider enabling him as I had done for years. His employer said if he wanted to keep his job he would go to a 28 day treatment program and the local judge thought that sounded like a good idea and made the same offer if he wanted to stay out jail.

He came back to our town and moved into an apartment and the children and I stayed in our home. He went to AA meetings six weeks before he could go to the treatment center. He took part in a local AA Convention and listened to all of the speakers. There was only one Al-Anon speaker but she spoke for 90 minutes and he stayed for the whole talk. Afterwards he bought her tape and spoke to several of the Al-Anon members between speaker meetings. He asked about literature and meetings for his family – he was given a meeting list and the suggestion to purchase the book Al-Anon Faces Alcoholism.

He showed up on my doorstep with the book and the meeting list – needless to say I was not very receptive to hearing how someone or something could get him to stop drinking and think about what kind of person he had become. So he tossed the book on the couch next to me and ran out the door. Three weeks into his treatment program I received a letter from the center explaining to me that alcoholism is a family disease and they would like for our family to come to a family week and learn more about how we had been affected by someone's drinking. I knew they needed me to tell them about him and how he had been for the last 10 years. Funny, they really didn't want to hear about him, they wanted to hear about me and the children. They shared with me and my children that even if we did get divorced from him, we had still been affected by his drinking and we really needed to attend Al-Anon and Alateen. For four days they talked about Al-Anon and Alateen, gave me the One Day At a Time and the Twelve Steps and Twelve Traditions of Al-Anon books and gave my children A Day At a Time in Alateen and Alateen, Hope for Children of Alcoholics. The last day at the treatment center was August 30 - that was the first day I read the ODAT. This reading gave me the courage to give my marriage a chance with, each family member in their program of recovery. We talked it over with each of us scared to it try and scared to not try it. We agreed to give us and the programs one year before we threw in the towel.

Twenty-one years later we are still married and both are in our respective programs. I still don't know what he is doing in his recovery because I am focusing on mine by reading those same books and more, and attending my home group meetings weekly. My program also includes service by being a certified Alateen group sponsor and sharing my spiritual understanding of a Power greater than myself with others.

District Representative

District 6 Meeting, April 21, 2007

Greetings everyone,

Not a lot has happened for me to report, though I expect to get busier with the district meeting on April 21st and the Spring Area Assembly in May in Victoria.

What I would like to mention are some tentative agenda items our GRs may be voting on at the Assembly. I say tentative, because the Area World Service Conference will set the agenda for the assembly business meeting on Friday night, the first night of the assembly.

One item will have to do with recommendations for the South Central Regional Trustee position, and for a Trustee-at-Large position. I don't know who has expressed interest yet, but it always brings Al-Anon business closer to home for me when one of our own is one of these trusted servants.

I expect there may be some discussion of raising the cost of our assembly registration fee from \$15 to \$20. Expenses of presenting an assembly have risen, yet this would be another increase in expenses for GRs and others who attend. The registration fee has been considered nonrefundable, though is hasn't been explicitly stated as such.

Also perhaps to be discussed is the considering whether we do, in fact, want to continue sending the Beacon (our area newsletter) free on a trial basis. It appears that this motion was made and passed some years ago without the trial period being defined.

A final item may be whether the training of volunteer Alateen sponsors and drivers within each district is better done by area coordinators (the Alateen Process Person and/or the Alateen Coordinator) or by other volunteers within the district, such as the district Alateen Coordinator.

You might want to talk about these topics in your groups and see what your members think. Of course, some topics might be settled before the assembly and never come up for a vote, and some other topics entirely may be mentioned: one of the variables that makes assemblies unpredictable. Hope to see you in Victoria!



Alateen scholarships (1/2 of registration fee) will be available through the Kristy Fund. Groups may also choose to "sponsor" a needy teen by paying ½ their registration. anon.org/tx e alateen guidelines.htm. To become a certified chaperone, you'll need 2 years in Al-Anon, pass a criminal background check to become certified, fill out Forms 1-2-3-4. Certified chaperones help Alateens and sponsors by transporting the teens to conferences or assemblies. Once certified, you can then sit in on Alateen meetings too. Get Sponsor training, attend a district sponsors meeting and district meeting and soon you'll be completing the last two forms (5-6) to become a certified sponsor!!!!

A District Sponsor's meeting was conducted today with 8 attendees. We discussed the importance of monitoring our physical contact with the Alateens and waiting for the teens to initiate a hug. Some Alateen groups hug after a meeting and some don't! Sponsors discussed ways to increase attendance such as letters and/or literature to local schools and churches. We decided more public outreach may be in order to inform the public about Alateen. Flyers posted at local AA as well as Al-Anon meetings are recommended. Alateens may always attend an Al-Anon meeting and Alateen literature can be used in any Al-Anon meeting. All certified sponsors and chaperones are encouraged to attend TEA 53 AC!

A1: Please refer to pg. 48, 73, 74, & 90 in the Service Manual regarding Public Relations. There is a guideline at the membership level on the WSO website about internet practices. It is recommended one should not give their name if they state they are a member of Al-Anon. Another option is if you want to state your name you could simply say you are a member of a 12 step group.


