JAYNE'S STORY.....

My name is Jayne G. I am a grateful member of the Just For Today AFG in Elgin and an Alateen sponsor of the Ride To Sanity Alateen Group in Bastrop. I like to say I am a member of the Al-Anon program because I choose to practice the principals of the fifth tradition. I work the twelve steps of AA for myself, I extend compassion and understanding to the alcoholics in my life and I reach out and welcome family members who come to our meetings in search of comfort.

I came to Al-Anon back in the stone ages (1985), as the result of thinking there was only two options left in life, Kill myself or kill him. But by the grace of my Greater Power, I had been seeded with the idea of Al-Anon back when I was in college.

In college I had been dating a young man whose drinking was what I thought as excessive. He also became very abusive physically. I was frightened. But as I had grown up in a physically abusive family, I did not concern myself with the abuse part, it was the drinking that bothered me.

My housemate took me to my first Al-Anon meeting and I heard them tell me I had choices. My choice was to terminate my relationship with the young man and I didn't need Al-Anon after that.

What I didn't understand was that I needed to change who I was. The choices I had to make were about making a decision about how I wanted to live my life. Since I didn't change, nothing changed. And I chose to have a relationship with the same kind of person. Later I married the same kind of person. And I became an over managing, mothering, martyr. And as time progressed and we became ever more entrenched in our disease, I lost what little self there was and I attempted to kill myself.

Greater Power had other plans as I ended up in the hospital, had my stomach pumped, and spent two weeks in a room with bars embedded in the glass. Somewhere in the fog was the remembrance of Al-Anon.

The Yellow Pages gave me a phone number that promised someone would call back within twenty-four hours. I got lucky; I got a call in two. I was directed to an Al-Anon meeting down the street from our house and started going. I was told to make six meetings and if I didn't think Al-Anon had anything to offer they would refund my misery.

I went to six meetings. I got a sponsor almost immediately. I was desperate. She said if I wanted what she had, I had to do what she did. I worked the steps. I was a "Get in the car" sponsoree. I went and shared in prison meetings. I went to district meetings. I went to Assembly meetings. And when I got busy, I started feeling better.

DR Report for May, 2008

Greetings to Everyone,

Thanks to Courage to Change AFG in Austin for hosting our last District Meeting and for the workshop on how our personal growth is good for Al-Anon. We were in three discussion groups: gain to the person, gain to the group, and gain to Al-Anon as a whole, and had some short articles to read to get us started. Here are some one-liners I heard that I'd like to remember:

- Service is the rent we pay for recovery.
- It's not "Practice makes perfect," but "Practice makes progress."
- I don't have to show up for every fight I'm invited to.
- Service doesn't have to be perfect to be beneficial.
- To try is to risk failure, but not to try is to guarantee it.
- Taking a service position does not mean taking control.

With our district elections coming up at the October District Meeting, the current district officers and coordinators will be writing a "job description" of what they do in their position. Many will have the duties written in the literature, but I am hopeful that we will also learn what is done that is not written down, so we can get a better picture of what the position actually entails. See later in this newsletter and the next edition for specifics about district positions.

In the meantime, see the last two issues of The Beacon, our Area Newsletter, for job descriptions at the Area level. Anyone interested in volunteering for one of those positions can see me for a blank resume form.

Many of us, if not most, now have access to e-mail and electronic media, but it is easy to forget that not everyone does. I've seen the term "e-buddy" used to describe someone who has e-mail access who volunteers to relay and

convey information for an Al-Anon member who does not. Regular mail through the U.S. Postal Service takes much longer to be delivered, and is more expensive. If you don't have e-mail access, ask a friend if they would mind serving as your "e-buddy" to receive and send e-mail on your behalf. You could then list their e-mail address as a way for you to be contacted. For those of us who already have e-mail, see if you know someone who does not and consider volunteering to be their "e-buddy." It would be a friendly thing to do.

One way this could be immediately put to use is by checking out the latest issue of "Area Highlights." To see this go to the WSO Web site for members at <http://www.al-anon.alateen.org/members>. Enter the name of your group, plus "afg" (no space after the group name is needed). Select "Publications", then "Newsletters", and click on "Area Highlights" for the most recent issue. It doesn't take as long to get there as it does to describe the process.

In the latest issue there is an article by our Area Alateen Coordinator, Brigitte B., on page 3, as well as descriptions of new departments in our monthly magazine, *The Forum*, and a quiz on page 4 to see how healthy your group is. In addition, there is a report on the theme of this year's World Service Conference, several Public Outreach ideas from other Areas, and more. One of the parts of this newsletter that helps me remember the international character of Al-Anon is that the last page is printed in French, and the next-to-last page is in Spanish.

Recently, Lizz S., our District Alateen Coordinator, and I approved applications for scholarships from the Kristi Fund to help two Alateens attend the Texas East Area 53 Alateen Conference in June. I'm sure we will all look forward to a report at our next District Meeting.

In the meantime, I hope to see many of you at the May Area Assembly in College Station.

As life takes its twists and turns, my first marriage ended in divorce, after he tried AA and decided he didn't have a drinking problem and physical abuse returned to the house. I married a second time and this one was short, as he became ill and passed away barely a year after we were married. Hopefully, this third shot will be a keeper. Not because he's a Prince Charming, but because I have a better grasp of the principles of minding my own business and serenity to accept that changing him isn't for me to do.

I have stayed busy in the program. It is in service work I have learned to say "No." I have also learned to what level I can say, "Yes." I have served as Institutions Coordinator at the district and Area level. I have been an Alateen sponsor for three separate Alateen meetings. I have a sponsor and I actively sponsor others. I take phone calls as referral for AlAnon meetings in the Bastrop area. I have sat in the Information Center and stamped price tags and books for sale.

I have learned that if I want to keep what I have I have to give it away. What better way to give it away than to suit up and show up. Show up to meetings. Show up to district meetings. SERVICE JOB DESCRIPTIONS FOR UPCOMING OCTOBER ELECTIONS!!!

DISTRICT REPRESENTATIVE:

The 2006-2009 Al-Anon Alateen Service Manual has the most comprehensive information about being a District Representative, with most information under District Representative (DR) in the index. Those who are eligible to stand for this position are described on page 134. The best description of duties is on page 144, but related information can be found under other headings, such as Area World Service Committee, Assembly, District meetings, and Elections. In addition, there are two relevant Guidelines: G-15, District Meetings, and G-37, District Representatives. Click on "Guidelines" under Group Services in the Members' part of the WSO Web site (<http://www.al-anon.alateen.org/members>).

You might think this would cover everything a DR needs to do, but not quite. I believe the basic function is to help pass information to the groups from the Area and the WSO, and to pass information from the groups to these other levels of service. There's a phrase on page 63 of the Service Manual that says the DR "...serves as a resource and a source of information for the groups." This is what is unpredictable, but a great source of learning about our program.

Two of the duties seem to have taken up the most time for me: the meetings and the reports. The District Representative attends at least eight meetings a year directly related to being a DR: four District Meetings and four Area World Service Committee meetings, two of which are at Area Assemblies.

District meetings require writing an agenda, preparing a verbal report to the district, and copying whatever handouts are needed for the Group Representatives and others attending those meetings.

Meetings of the AWSC also require some preparation, primarily preparing a verbal report on the district, though the Chairman of the AWSC sets the agenda. The Chairman may also ask members of that committee to serve on ad hoc committees, or work on other tasks. I was asked to serve on the committee that is reviewing the guidelines for hosting Area Assemblies. In addition, the DR is usually asked to give a verbal report to the Area during each Assembly.

Each of these eight meetings also requires a written report, four for the district newsletter and four for the area newsletter.

Other writing now includes preparing a "heads up," as I like to call it, of upcoming items for the Next District meeting. One helpful result of all this writing is that I am learning that expressing my thoughts and experience in this way helps me think.

Perhaps the biggest change since I was last DR, in 2001-2002, after I took over for Laura W., involves all the changes to protect Alateens. It was a new process for everyone, so all of us were learning how this was supposed to work. It required verification that prospective Alateen sponsors had attended at least one district meeting, at least one district Sponsor's meeting, and Alateen Sponsor training. This was time-consuming at first, until I was able to meet with those members I didn't know. Now I can at least recognize those I am certifying.

One part of my position was made much easier because John M., the Area Group Records Coordinator, is in our district. Otherwise, I would have been much more involved in keeping the Area, the WSO, and the Austin Information Center informed of group changes.

The last topic I want to mention is visiting the groups in the district. I didn't do very well at this, but I was welcomed by every group I did visit. If doing the rest of the work as DR took me an average of three to four hours per week, then visiting another group would probably add another two or three hours.

ALTERNATE DISTRICT REPRESENTATIVE:

The job description of the Alternate DR is found on page 134 of the service manual. The Alternate DR serves as DR when the DR is ill or resigns. The Alternate DR may also serve as Secretary, Treasurer, public outreach contact from the district to the Area, or as chairman of meetings on the service structure, Traditions, and Concepts. The Alternate DR may also be a GR of a group.

What I have been doing so that I will be prepared if Randy gets ill, is attending the Area World Service Committee meetings and the Assemblies. This attendance without vote allows me to be aware of what is happening at the Area level. If you are not a GR for your group, you will have to pay your own way to the Assembly and the district meetings. If you are a GR, the group will contribute towards your costs to attend the district and the Assembly meetings.

SECRETARY:

Attend quarterly district meetings. If the Secretary cannot attend, let the District Representative know. Try to find someone to take the minutes for that meeting.

During the district meeting take the minutes for the meeting. Always record motions made, who makes the motion, and who seconds the motion. Just a reminder: the officers and coordinators will submit their own report to the newsletter coordinator.

During the district meeting, give a report. Ask for any changes to the minutes printed in the previous newsletter. If no changes, ask for a motion to accept the minutes as submitted. Ask for a second.

After the district meeting, type up the minutes and email to the newsletter coordinator.

TREASURER:

The treasurer handles the collection and distribution of district funds approved by the district.

Make a quarterly written financial report to the district.

File for retention receipts of expenditures.

Prepare annual budget for approval by the district.

The current check register, treasurer's report and budget is kept using the software Microsoft Excel. It would be beneficial to have access to a computer with this software; however it isn't required.

ALATEEN COORDINATOR:

Primary goal?

Keep District informed with reports to the newsletter;

Foster awareness that Alateen is part of Al-Anon and encourage Al-Anons to become involved as Al-Anon Members Involved in Alateen Service (AMIAS)!

Provide practical support to the District 6 Alateen AMIAS- sponsors and chaperones;

Attend Alateen Sponsor Training* –POSSE;

Facilitate Alateen Sponsor meetings at District Meetings;

Coordinate Alateen Sponsor Training* in the District;

Maintain roster of all certified sponsors and chaperones;

Visit as many Alateen groups* as possible;

Approve scholarship applications for Kristy Fund and

Support Alateen conference by encouraging Alateens to attend!

NEWSLETTER EDITOR:

Set a deadline for reports to be submitted by Officers, Coordinators, Group Representative's, and those reporting for the Area Information Service centers.

Correct grammar, punctuation and spelling, including the correct spelling of "Al-Anon" and "Alateen".

Use an organized and consistent format for the readers

Update the mailing list as needed.

Redact any personal information from the newsletter, i.e., names, addresses, phone numbers and email addresses before submitting the newsletter to the website coordinator for posting on the Al-Anon website.

List any and all future events that are Al-Anon related.

Guidelines for Newsletters Editors, G-21

FORUM/LITERATURE COORDINATOR:

The District Literature coordinator promotes the use of Conference Approved Literature by:

- Sharing news about Conference Approved Literature (CAL) from the World Service Organization and Area with the District.
- Sharing news of Electronic Conference Approved Literature (ECAL) with District members.
- Communicating about opportunities for sharing our experience, strength and hope through sharing in the Forum, ECAL, and other Alanon Literature.
- Bringing a complete supply of CAL from the Austin Information Center to the Quarterly District meeting, and arranging for sale of this literature to groups during the Quarterly meeting.
- Staying in contact with the Area Literature Coordinator in order to insure up and down communication about Literature.
- Attending all district meetings, if possible, and giving a report for the previous Quarter.

LENGTH OF TERM?

Three years. Elected by GR's attending the District Meeting. Can be nominated or may volunteer.

WHO?

Knowledgeable and experienced Al-Anon members with a willingness to work and a desire to carry the Al-Anon/Alateen message.

ARCHIVIST:

The Archivist is concerned with preserving and organizing historical Al-Anon and Alateen material, making it available to the membership and researchers. A space in your closet for the tubs of materials and a way to bring the material to the District meetings for display.

PUBLIC OUTREACH SOUTH:

Coordinate opportunities for informing the public about Al-Anon/Alateen. Recruit volunteers to man booths at Health Fairs, be speakers, place pamphlets, table displays, posters, meeting notices and times in various public locations, do mail-outs to professionals, place Al-Anon/Alateen conference approved literature in libraries and schools, contact AA Intergroups, attend AA functions, etc. Attend all district meetings, if possible, and give a report for the previous quarter, work with the Information Service Liaison and the Area Public Outreach Coordinator.

LENGTH OF TERM? Three years. Elected by GR's attending the District Meeting. Can be nominated or may volunteer.

WHO? Knowledgeable and experienced Al-Anon members with a willingness to work and a desire to carry the Al-Anon/Alateen message.

WHERE? In local communities using various means at your disposal.

WHY? To inform the public of who we are, what we do, and how to find us.

WHAT? Inform communities of the existence and availability of Al-Anon/Alateen as a resource for families of alcoholics.

HOW? Establish a list of contacts through the phone book, the Chamber of Commerce, Visitor Centers, hospitals, schools, treatment centers, family courts, communicate with Area Public Outreach Coordinator, attend Assembly workshops, communicate with the Al-Anon/Alateen Information Service, GR's, DR's, social agencies, community and civic organizations, and utilize the media and WSO publications.

WHERE? In our district.

To me, the biggest challenge is finding volunteers to help. The benefits are greater than the challenges, though. I am doing 12th Step work, helping others, and recovering through service to Al-Anon/Alateen for which I am very grateful.
