### STEVE'S STORY – An Alateen Sponsor

Hello, my name is Steve and I am a very grateful Al-Anon. Like most of you, I am in Al-Anon today because someone else's drinking has affected my life. In fact, there are primarily two Alcoholics in my life. My first Alcoholic is my real father. He really never was a part of my life, divorcing my mother when I was around five years old. The last time I saw him was in 1977. Since then, no contact, not sure if he is even alive. My second Alcoholic is my son. Because of him, I was introduced to the Al-Anon program in 1996. It wasn't until I had quite a few years in the program before I realized that my first Alcoholic was my dad. When I came to Al-Anon, my youngest daughter would also come to meetings with my wife and me. Most of the time she attended the Alateen meetings where we lived. Shortly after my wife left me, I was blessed to have physical custody of my youngest daughter. Had it not been for church members, Alateen and those Alateen sponsors, I would have never made it trying to raise her.

Today, I am a grateful Alateen sponsor partly because of the example of all those Alateen Sponsors. There is no way for me to turn the clock back and do things differently for my children. So, I have decided to do the next best thing, do for others what I did not do for my own. Nearly all the Alateens I have met come from broken homes. Remembering how empty and insecure I felt as a young boy reminds me of how some of these Alateens must feel today.

So, I am committed to the Alateen Sponsorship program. How about you? Anyone in Al-Anon can be involved with our Alateens. To become an Alateen Sponsor, we must be an active Al-Anon member, be in the program at least two years, and be at least 21 years old. The process to get certified, first as an Alateen Chaperone, and then as an Alateen Sponsor may take some time to accomplish. But the rewards are endless. In case you don't qualify to become either a Chaperone or Sponsor, you can always support your local Alateen group, or contribute to the Kristy Fund, that provides funds that allow our Alateens to attend their annual Alateen Conference.

I often thank the parents/guardians of the Alateens for trusting me as one of their Alateen Sponsors. Also, I want to thank you for trusting me to be your Alateen Coordinator. The next time you see one of your Alateen Sponsors or Chaperones, give them a hug and thank them for their their service to the program.

# DISTRICT 6 MEETING MINUTES April 18, 2009 Hosted by Just for Today AFG Elgin, Texas

The meeting was opened at 9:02 by Shelley S. with a moment of silence followed by the Serenity Prayer. The opening, preamble, 12 Steps, 12 Traditions, and 12 Concepts and Warranties were read. Pat E. announced that the World Service Conference was to start this morning. She passed around a card for all to sign to send to Rosie M., our Texas East Delegate. Introductions were made.

New GR's and those attending their
first district meeting were recognized.
The "Ask It Basket" and donation
baskets were passed. From 9:30 to
10:45 a workshop was held on "Using
the Service Manual." An Alateen
Sponsor meeting was held during the
workshop. At 10:45, sharing on the
workshop was held. The four topics
were "Groups at Work", "Policies,
PSA's (Public Service Announcements), WSO (World
Service Office) films, Symbols and
Logos", "Job Descriptions for
Trustees, the organizational chart, the
charter, listing of terms, the election
process, and equalized expenses", and
"History of the Concepts, AA and Al-
Anon Cooperation, Where We Came
From and Where We're Going,
harmony between the groups, district,
and area and Our Roots from AA."

The business meeting began at 11:08. Reports were given by the officers and coordinators. Shelley announced that a quilt is to be made for ATAAC and that Alateen "hearts" are needed for the quilt. The morning session closed at 11:57 for lunch. The business meeting resumed at 1:01. Group updates were given by GR's. Future district meeting locations were discussed. The July 18th meeting will be hosted by the Pflugerville Path to Serenity AFG. For the October meeting, Susan P. will check with the Hilltoppers AFG, Barbara will check with the Courage to Change AFG, and Jennie will check with the Killeen AFG.

#### New Business:

Ask It Basket questions were discussed.

1. "Is it OK for someone in AA to sponsor someone in Al-Anon?"

Answer: Anyone may learn from anyone. However, an Al-Anon sponsor is someone who attends Al-Anon the meetings, works Al-Anon program, and has sponsor a themselves.

2. "Is there such a thing as a "grandsponsor?"

Answer: Al-Anon does not have a "pyramid scheme" of sponsorship and does not endorse any "control" by sponsors. We are a fellowship of equals-one sponsor helps one person. Some, however, jokingly refer to a "sponsor's sponsor" as a "grandsponsor" or lovingly express gratitude for the history and recovery they see passed down.

3. "How do you discourage detailed naming of drugs used by members sharing?"

Answer: The Chair Person controls the meeting discussion, a Group Conscience can be held, any member can say something (group autonomy according to Traditions 1, 4, and 5), and talk to that member after the meeting. A discussion on drugs could be educational to some.

4. "Where are the five allowed WSO films available? Are they for rent?"

Answer: The films are: Lois' Story, Al-Anon Speaks for Itself, Alateen tells It Like It Is, Walk This Path of Hope, and Lois W. and the Pioneers. (Refer to pg. 81 in the Service Manual.) To rent, contact WSO.

5. "If a group is struggling to survive because it can't afford literature or the members cannot even give donations on a regular basis, what can other groups or the district do to support those groups?"

Answer: Please refer to pg. 39 of the Service Manual on "Finances", see the pamphlet on finances from WSO, or contact Shelley to see if she can get the word out.

6. "Is it OK to use AA literature in Al-Anon meetings?"

Answer: The literature should be Al-Anon conferenced approved. It also depends on each group and what the "group conscience" decides (group autonomy). We are Al-Anon, friends and families of Alcoholics. (See pg. 94 in the Service Manual.)

7. "What meetings are announced at local meetings? I have been to several meetings where other 12 Step conferences were announced. I was at another meeting where Al-Anon speakers at other 12 Step conferences were announced. What is correct?"

Answer: Please refer to the Service Manual 48-"Group on pg. Announcements", pg. 92- "Use of Material", 94-"Outside pg. and pgs. 106-107-Publications", "Dilutions".

8. "Several people at our workshop said their groups never receive appeal letters from WSO. I told them they are probably not registered with WSO. Please tell them how to get registered to receive the service manual and the appeal letter."

Answer: We should first verify that the group is not registered. We can check the CMA (Current Mailing Address) with the DR (District Representative). If the group is

registered, then only the CMA needs to be changed. If the group is not registered, details needed to register a group can be obtained by calling WSO or refer to pg. 31 of the Service Manual.

9. "Question on a dominant member who is a 'double winner'".

Answer: In the Service Manual, refer to pg. 80, pg. 48-Group problems and solutions, look in the books 12 Steps and 12 Traditions and Paths to Serenity, hold a group inventory/group conscience.

The next agenda item was a discussion on the newsletter subscriptions. Sixtythree individual newsletters were mailed out, but there are not 63 individual paid subscriptions. There are 85 group subscriptions. Questions asked and points made were:

- 1. Can't a charge be tacked on? This is a big expense at the Area for the Beacon also.
- 2. The subscription form is in the newsletter.
- 3. Check your CMA.
- 4. Send an electronic copy of the newsletter when available.
- 5. Is there an expiration date for a subscription? No.
- 6. A yearly appeal letter could be sent out.
- 7. If you subscribe to the Forum, you get a Forum; so if you subscribe to the newsletter, you get a newsletter.
- 8. Designate what you want your donations to go toward.
- 9. Tom could put an article on the front page explaining that each group gets one.
- 10. Send out a postcard asking if an individual subscription is still wanted. If Tom doesn't get an answer from that person, their name will be taken off the list.

- 11. Password protected version put on line with all information.
- 12. Would an individual be willing to pay for a "cleaned-up" version on line?
- 13. Make the subscription January to January.

The next agenda item was a discussion on "How Can We Make Our Groups Better?" Ideas on Newcomer retention were offered and discussed.

- 1. Area Highlights publicationservice is investing in our future.
- 2. Sponsors tell sponsees to do service.

- 3. Members share why they keep coming back.
- 4. Welcome the Newcomer.
- 5. Assign one person to welcome Newcomers. Give them a Newcomer Packet.
- 6. Seek out a face you don't know, make them feel very special and remember their name.
- 7. Read the pamphlet "Understanding Alcoholism and Ourselves".
- 8. What do you do when the Newcomer doesn't come back-LET GO AND LET GOD.

Shelley thanked Just For Today AFG for hosting today's meeting.

The meeting closed with the Al-Anon/Alateen Declaration.

#### MINUTOS DE LA REUNIÓN DE DISTRITO 6

el 18 de abril, 2009

#### Elgin, TX, Just for Today AFG

La reunión fue abierta a las 9:02 por Shelly S. con un momento de silencio y la Oración de la Serenidad. La Bienvenida, el Preámbulo, los Doce Pasos, las Doce Tradiciones, los Doce Conceptos y las Garantías fueron leídos. Pat E. anunció que la Conferencia de Servicio Mundial iba a comenzar este mismo día. Firmamos y le mandamos una tarjeta a Rosie M., nuestra Delegada de la Zona Este de Texas. Se presentaron los Dirigentes, los Coordinadores, los Representantes y los nuevos Representantes de Grupo y les dimos la bienvenida a las personas que asistían por primera vez a una reunión de Distrito. Se pasaron "la Cesta de Preguntas" y la cesta de donaciones. Desde las 9:30 hasta las 10:45 nos dividimos en grupos pequeños y discutimos el asunto "Cómo Usar el Manual de Servicio." Discutimos lo siguiente: "Grupos de Al-Anon y Alateen en Acción", "Compendio de Guías", "Anuncios de Servicios Públicos", "Oficina de Servicio Mundial – películas y símbolos", "Descripciones de los Puestos para La Junta de Administradores", "Gráfico - Estructura del Comité de Servicio", "Carta de la Conferencia de Servicio Mundial Al-Anon", "Términos utilizados en el servicio de Al-Anon", "El proceso de elecciones", "Gastos igualados", "Historia de los Conceptos", "Cooperación entre AA y Al-Anon", "De dónde vinimos y adónde vamos", "Armonía entre los Grupos, el Distrito, y la Zona", "Nuestros raíces de AA."

La Junta de Trabajo comenzó a las 11:08. Los Dirigentes y los Coordinadores dieron sus informes individuales. Shelly anunció que van a hacer una cobija para ATAAC y que necesitan "corazones de Alateen" para la cobija. Se cerró la sesión de la mañana a las 11:57 y almorzamos. La Junta de Trabajo siguió a la 1:01. Los Representantes de Grupos leyeron sus informes individuales. Discutimos el lugar para las siguientes reuniones del Distrito. Pflugerville Paths to Serenity AFG va a tener la reunión el 18 de julio. Para la reunión de octubre, es posible que tres grupos tengan la reunión: Hilltoppers AFG (Susan P.), Courage to Change AFG (Barbara), y Killeen AFG (Jennie).

#### Asuntos Nuevos:

Se discutieron las "Preguntas en la cesta:"

- 1. "¿Se permite que un miembro de AA sea Padrino/Madrina de alguien en Al-Anon?" Respuesta: "Podemos aprender algo de cualquiera persona; sin embargo, un Padrino/una Madrina de Al-Anon es alguien que asista a las reuniones de Al-Anon, que trabaje con el programa, y que tenga su propio Padrino/ Madrina."
- 2. "Hay cosa como un "grand-sponsor" (Padrino/Madrina del Padrino/Madrina de un miembro)? Respuesta: "Al-Anon no tiene un 'plan de pirámide' del Padrinazgo y no apoya ningún "control" por medio de los Padrinos/Madrinas. Somos iguales; un Padrino/Madrina ayuda a otra persona. Se refiere a un Padrino/Madrina del Padrino/Madrina de un miembro cariñosamente o para agradecerle la recuperación que le ha pasado.

- 3. "¿Cómo se puede disuadir a alguien de que no mencione detalles de las drogas que usa otra persona?" Respuesta: "La Coordinadora de Mesa controla la discusión de la reunión; se puede tener una consciencia de grupo; cualquier miembro pueda decir algo, según la Primera, la Cuarta, y la Quinta Tradición; se puede hablar con el miembro después de la reunión. Una discusión de las drogas puede ser instructiva para algunos."
- 4. "¿Cuáles son las cinco películas disponibles de la Oficina de Servicio Mundial? ¿Se las puede alquilar?" Respuesta: "Son Lois' Story, Al-Anon Speaks for Itself, Alateen Tells It Like It Is, Walk This Path of Hope, y Lois W. and the Pioneers. (Vea p. 81 del Manual de Servicio.) Para alquilarlas, comúniquese con la OSM."
- 5. "Si un grupo lucha para sobrevivir porque no se puede comprar literatura o los miembros no se pueden dar donaciones regularmente, ¿qué pueden hacer otros grupos o el Distrito para apoyar a estos grupos?" Respuesta: "Vea p. 40 del Manual de Servicio 'Finanzas del Grupo/Presupuesto", vea el folleto de finanzas de la OSM, o llame a Shelly para ver si ella puede comunicarse con los otros grupos acerca del problema.
- 6. "¿Se puede usar literatura de AA en las reuniones de Al-Anon?" Respuesta: "La literatura debe ser Aprobada por la Conferencia de Al-Anon. También depende de lo que decide cada grupo en su consciencia de grupo. Somos amigos y familiares de los alcohólicos. (Vea p. 94 del Manual de Servicio.)
- 7. "¿Cuáles son las reuniones que se anuncian en las reuniones locales? He participado en varias reuniones en las cuales se anunciaron otras conferencias de los Doce Pasos. Y en otra reunión se anunciaron oradores de Al-Anon en otras conferencias de los Doce Pasos. ¿Cuál es correcto? Respuesta: "Vea pp. 47-48, 92-94, 107 en el Manual de Servicio."
- 8. "Varias personas han mencionado que sus grupos nunca reciben las Cartas de Petición Trimestrales de la OSM. Les dije que probablemente no estén registrados con el OSM. Favor de decirles cómo pueden registrarse para recibir el Manual de Servicio y la Carta de Petición Trimestral de la OSM." Respuesta: "Debemos verificar que el grupo no está registrado. Podemos consultarla Dirección Postal Actual y a la Representante de Distrito. Si el grupo está registrado, sólo necesita cambiar la Direcció Postal Actual. Si el grupo no está registrado, se puede obtener detalles de cómo registrar a un grupo de la OSM o se puede referir a p. 31 del Manual de Servicio.9. "Pregunta de un miembro dominante que es miembro de AA y de Al-Anon." Respuesta: "En el Manual de Servicio, vea p. 80 y p. 49 (Problemas del Grupo y Soluciones), y también vea Los Doces Pasos y las Doce Tradiciones, y Senderos a la Recuperación. También se puede tener una consciencia del grupo.

Más tarde, se discutieron el asunto de suscripciones a la carta informativa del Distrito. Se mandaron 63 cartas individuales pero no todas están pagadas. Hay 85 suscripciones para los grupos.

#### Preguntas:

- 1. "¿Por qué no se puede cobrar? Respuesta: "Es un gasto grande en la Zona y para el Beacon."
- 2. "Hay una forma de suscripción en la carta del Distrito."
- 3. "Revise su Dirección Postal Actual."
- 4. "Se puede mandar electrónicamente la carta cuando sea posible."
- 5. "¿Hay una fecha de caducidad de la suscripción?" Respuesta: "No."
- 6. "Se puede mandar una carta de petición cada año."
- 7. "Si tiene una suscripción al Forum, recibe un Forum; entonces, si tiene una suscripción a la carta de Distrito, recibe una carta de Distrito."
- 8. "Señale a lo que quiera dar sus donaciones."
- 9. "Tom puede escribir algo en la primera página de la Carta de Distrito, explicando que cada grupo va a recibir la Carta de Distrito."
- 10. "Mándeles una tarjeta postal a las personas que quieran una suscripción. Si Tom no recibe respuestas, puede cancelar la suscripción.
- 11. "Una versión protegida con contraseñas se puede mandar electrónicamente con toda la información. (¿\$10?) ¿Estará dispuesta una persona a pagar por una versión electrónica?
- 12. "La suscripción puede durar un año—de enero a enero."

- 3. "Los miembros comparten su experiencia y por qué siguen viniendo a Al-Anon."
- 4. "Salude sinceramente al recién llegado."
- 5. "Nombre a una persona para saludar al recién llegado. Deles un Paquete para el Recién Llegado."
- 6. "Busque a una persona que no conozque, hágale sentirse especial, y recuerde su nombre."
- 7. "Lea 'El Alcoholismo y Cómo Nos Aftecta,' pp. 26-28 en el Manual de Servicio.
- 8. "¿Qué hace Ud. cuando un recién llegado no regresa al programa? "¡Riéndase el control y qué Diós los bendiga y los cuide!"

Shelly le dio las gracias al Grupo Just for Today por tener la reunión de hoy, y se cerró la reunión con la Declaración de Al-Anon/Alateen.
