I was always comparing my insides to your outsides. You were cuter, more talented, smarter, and if you were another girl, you always got the guy I thought I wanted.

I tried to fill that hole inside me with books, dreams, and associations with people who lived on the edge. From an early age, I ran around with people who drank too much, and I loved it. I even participated in the drinking and merrymaking. Why I did not become an alcoholic, only God knows; for that, I am truly grateful.


Situations happened (he got a divorce and needed to move to Ohio). I was having trouble in school, so I thought it was a good time to get married. I was not getting my way in graduate school; he did not ask me to marry him, so I did what was natural and moved to another state. This was one more geographic fix to try to get the result that I wanted. Situations again happened, and we did get back together and married.

In Southeast Texas, we both hit bottom, and luckily, he knew that alcohol was the major contribution to the unhappiness in our marriage. I was okay with him getting help as long as I didn't have to participate in anything (like therapy), and it had to be on our insurance plan. I was angry and said some very hateful things to him at this time. I had become hateful and unloving to my parents, and I was not a stellar employee. Oh, I went to work every day, but everyone avoided me so that they did not hear my harsh words. No one wanted to work for me, unless forced.


We started down the AA/Al-Anon path with kind and loving people. They loved us when we did not love ourselves. I was sentenced to six meetings during family outpatient day, and I went because I thought it would keep him sober. I was so angry, but when I got in those meetings and whined about how he had messed up, the kind and loving people just let me talk and told me to keep coming back. I did not want to be there. It was his problem, not my problem. I kept going back because they seemed to understand. They shared with me one-on-one what it was like in their households, so I did not feel alone. The group asked me to make coffee, so I started my first service job. I kept hearing, "If you want what we have,

you have to do what we do." I asked what that was, and they said to watch how people laugh and have a sparkle in their eyes. Ask them what they do, so I did. They told me to make Al-Anon my first commitment, get a sponsor, do service work, work the Steps, and my life would change. I was so desperate to get rid of the emptiness; I just did what they said since my way sure was not working. I got a sponsor and started working the Steps. My group needed a GR. I said I had not been coming long enough (about one year), but they said to just do it and that they would help. I got busy in service, and that was a blessing was for me. Active alcoholism had returned to my household, but service work kept me busy and my mind off of him.

Eventually, I became the DR for District 8 (east of Houston). At area assemblies, I met people that would help me when I moved to Houston and Austin. My job moved to Houston, so we moved; we were also deep into active alcoholism again.

During this time in Houston, I hit another bottom in my life. You see, at this point, I had not truly given my will and my life, or the alcoholic's life, over to the care of the God of my understanding. I was still trying to get my husband sober by being the Al-Anon cheerleader. I would cheer him on if he decided to go to meetings. I would also huff and puff if he did not go to meetings. I had come to the point of decision - could I live with active alcoholism or not? What a turning point in my spiritual growth, I finally let go of trying to manipulate an outcome. I started asking God to help me be of

service and to live with an attitude of gratitude. I became grateful for the days he did not drink. I eventually could be happy whether he drank or not and could love him where he was at. attribute that to the solid foundation from Al-Anon because at this time, I was not in touch with my sponsor. I was finally in a situation where I really had to rely on the God of my understanding for my peace and serenity. Since that surrender, my life has taken off. My husband did get sober, and we both changed careers and moved to Austin shortly after 9-11 (that's another story). Today, I have two committed Al-Anon meetings, and I attend open AA meetings.

I have done various service activities at the district and area levels. My position as the Texas East Area 53 Chair has rocketed my spiritual growth into the fourth dimension. I have learned a new understanding of unity and how issues, or small decisions, can affect Al-Anon as a whole. I try not to let small things become large issues and have learned that discussing issues prior to taking action (e.g., a vote) is much more effective than jumping right to action.

I can guarantee Al-Anon will be there for others in my family by continuing to go to meetings; doing service work outside of my group; sponsoring others; and giving back to a way of life that has made me a kinder, gentler, and more accepting person. Today, I know that I have received a blessing from God and that my purpose in life is to pass that blessing on. My small amount of service, inside or outside of the group, rewards me ten-fold every time.

 stated that he wants to get more Alateens active at
 the district meetings and welcomed any suggestions.
- WACO AIS did two appeals to the groups in that area to continue, but due to no interest at this time, it was determined that WACO AIS would be dissolved at the end of April.
- Deanna M. did an update on the Alateen poster distribution for Rosemary C. Judy W. gave a history on the start of the Alateen poster distribution, all of which resulted in a lively discussion of how to carry the message.

- GRs did updates on successes and challenges in their groups.
- Paula H. received a call from an Austin Spanish group who learned that the Fall Assembly will be held in Austin and wanted to know how they could help. She appealed to the district for some members to go with her in solidarity. I met Paula at their Sunday night meeting, and Paula did the talking. It was an awesome experience!
- Public Outreach South's report was that they desperately need volunteers on Wednesday night to come to the Lockhart Prison for the women's Al-Anon meeting there. If you are looking for service work, please contact the Public Outreach South Coordinator (see Page 15 for contact information).
- With the exception of a Spanish Coordinator, all other service positions in District 6 are filled. An anonymous birdie told me that we might have someone interested (Yes!). Waiting to hear more information.
- In reviewing my recent e-mails from our Area Alateen Process Person (AAPP), District 6 has five new AMIAS.
 Thus far, I have seen that there are five recertifications. There is also a new Alateen meeting in Round Rock that just started! I am sure our AAPP is not done yet in processing. I will keep you posted.

Ask It Basket April 8, 2017

- What can be done when a group member keeps talking to non-members about who and what was said at our meetings? Also, the person's behavior away from the meeting time scares the new members.
 - **Answer:** Read Traditions 11 and 12 and include in your meeting opening that anonymity is an important principle in an Al-Anon meeting. Pages 91-94 in the service manual are about anonymity in all aspects of Al-Anon. If this person continues to not follow the principle of anonymity, the group can have a group conscience on the topic and decide what to do next.
- 2. Is it acceptable to ask for a special donation for AIS separate from our overage in the group treasury?

 Answer: Yes. This is a topic for discussion at group conscience.
- 3. Is commenting on a positive thought to someone on what they said considered crosstalk in a discussion meeting?

Answer: There is no mention of crosstalk in the service manual, or most of our other literature. "Crosstalk" is a term adopted from treatment

centers, and it has recently come into use in Al-Anon. Because of this, each group must decide for itself what crosstalk is and how to define it. As a general rule, if it is harmful to the group, it might be worthwhile to examine it.

4. "Keep Coming Back" vs. Al-Anon Declaration — Is it up to the group conscience as to which we say? Chairperson? Is K.C.B. the closing for Al-Anon or for AA?

Answer: It is up to the group conscience what closing to use.

Page 22 of the service manual states: "It is suggested that groups close in a manner that is agreeable to the group conscience. Many groups say the Al-Anon Declaration after their closing."

Al-Anon Information Service (AIS) Centers

Austin AIS

The Austin Al-Anon Information Center Board met on May 15, 2017, at 6:30 P.M. at the Austin Al-Anon Information Center. Eleven voting members were present. The minutes from the last meeting were approved as amended.

The center's finances are adequate, but improvements could be made. Another appeal letter will be sent to groups asking for donations since the operating cash balance has continued to decline since 2012. A possible reason for the decline is that literature sales are down due to people buying Al-Anon literature on-line and at discount book stores. One solution may be to price the literature higher. There is a committee studying the possibility of increasing the price of the literature. It was mentioned that it would be helpful to track the number of copies of *How Al-Anon Works* and the number of newcomer packets that have been sold over a certain period of time. The Finance Committee is continuing to monitor the bank statements and financial reports as well.

Some new business was discussed. To foster better communication with the groups, it was discussed that the minutes of the board meetings will be sent as a draft to groups. The minutes will continue to be published on the Austin Al-Anon Web site (www.austinalanon.org) after approval by the Board. Also, a member with experience in Al-Anon is being sought to answer e-mails sent to the center's

inquiry Web address. In addition, in August, payment must be made for our Web site. It is quite costly for a three year renewal, so suggestions were made to investigate a cheaper service.

A survey on the effectiveness of the Information Center will be sent electronically and via regular mail to groups soon. Deadline for submission of the survey is in July, and the results of the survey will be announced at the next board meeting on August 22, 2017, at 6:30 P.M. at Northland.

The learning curve is pretty steep, but as in all things Al-Anon, I have had lots of help and support – thanks to everyone at P.O.S.S.E. and TEA AC. These events have made me feel a part of Alateen, in spite of my short time as an AMIAS and even shorter time as DAC.

The new group at Cedar Ridge High School in Round Rock began meeting in May. Darlene, the primary sponsor, and the rest of the sponsors involved will be meeting with Ron this week to discuss continuing the group in the fall.

Darlene has registered a new group to begin on June 1 at Grace Presbyterian Church in Round Rock near the school. It will meet at the same time as an Al-Anon and an AA meeting.
