Greetings! I pray that everyone is staying healthy and safe through this uncertain time. Within the District, COVID-19 presented us with unprecedented challenges that included a cancelled district meeting in April, a cancelled area assembly in May, and significant limits to our social contact. However, everyone pulled together to keep members connected, to remain self-supporting even with dwindling group donations, and to keep our focus on recovery. Even though we've had to slow down, a lot is actually happening, so I've included some reminders and updates since my last report in March.

Requests from AAIC

Some messages from Janie H. at the Austin Al-Anon/Alateen Information Center (AAIC) –

- For cash payments, please request change for bills no larger than \$20. Janie H. often receives large bills of \$50 or \$100 for which it is difficult to make change since she has a very limited amount in the cash box.
- Please make sure that checks and money orders are signed and completed correctly. The bank will refuse the deposit if the written part does not match the numeric amount, does not have a full signature, and/or is not dated. Please also include your group's name (as it is registered with WSO), your WSO group number (see next bullet for additional information), and the reason for the check or money order (literature or donation).
- Please always include your WSO group number on any check written as a donation. If you don't know your WSO group number, you can usually find it with your group's information on the meeting list on the AAIC web site. If it isn't there, or your group isn't on the list, please contact me at etx.district6@gmail.com or Cathy M. (our District Group Records Coordinator) for assistance.

For any group changes, please contact our District Group Records Coordinator Cathy M. at etx6grouprecords@gmail.com. She will work with you to get the changes made as quickly as possible.

Status of Group Meetings in the District

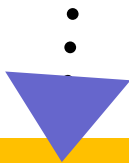

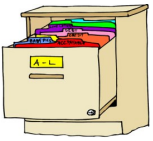

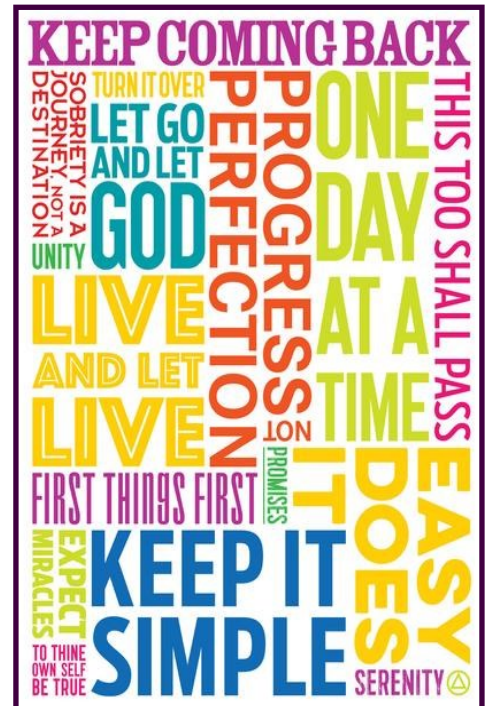
Hope for Today AFG

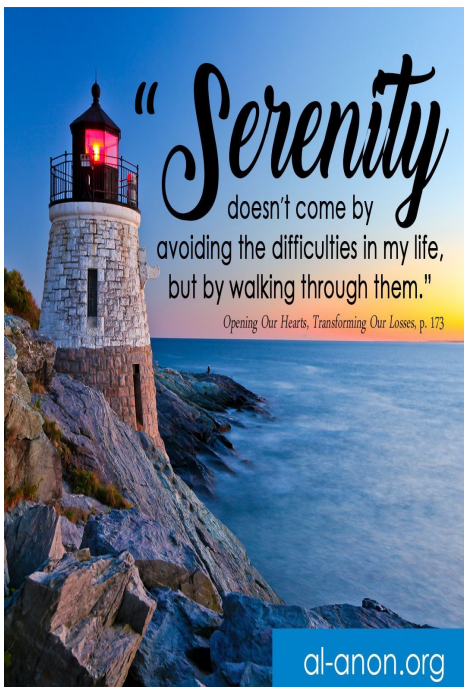

Staying Positive in a Pandemic

I am very proud and grateful of my home group. My wife and I were in California at an RV park in our truck camper. We had driven there just the week before in order to take care of my 92-year-old mother who had gone on hospice when this pandemic hit. The park immediately went to self-quarantine status and was considering whether or not to ask us to vacate. They decided to let us stay. However, we were no longer able to provide care for my mother. After waiting two weeks to evaluate the situation and realizing this was not going to be a short-term condition, we confirmed we could drive home and did so.


Immediately after the self-quarantine orders came out, I got on the phone with my sponsor who is a past GR and discussed options. We brainstormed ideas, finally deciding on having a Zoom Group Conscience. The outcome was to register with Zoom and hold our meetings the same day and time as we normally did. After getting Zoom setup we emailed our entire group all four meeting ID's and codes.

Being a typical Al-Anon I was concerned that since we have a lot of seniors who are not internet savvy, they might get left out. Not so. Those of us who are more tech savvy worked with those who needed help and the outcome has been great. We have as many and sometimes more attendance than at our normal meetings. We've also had a few members who do not like the format and don't use it. To support them we make calls directly to them and they know they can call us. We have also registered our meeting with the District.

To date we have attendees from Canada, Missouri, New York, and other groups in Central Texas. It's been fun getting to meet and have meetings with people from other areas.

We all miss the personal connection and especially the hugs and look forward to the day when we can get together in person again.

Greetings!

It has been an honor to serve the Austin area as a board member of the All Texas AI-Anon/Alateen Conference since 2018. However, my term expires this year and a new representative is needed. The guidelines for being a board member are listed below. The current board members will need to review resumes prior to the August 2020 board meeting, which will be held virtually on August 8, 2020. You can email me at haschke_paula@aol.com, and I will send you a copy of the resume, as well as the email address of where to send it.

Guidelines for Selection of ATAAC Board Members

- Members of Alcoholics Anonymous are not eligible for election to the ATAAC Board.
- Board Members will be representative of an area, not a specific town or city.
- Must be an active participant in regular local AI-Anon meetings.
- Must be able and willing to work within the Board framework.
- Must be responsible and have ability to complete projects.
- Must be available when needed.
- Must be willing to serve and attend board meetings.
- An announcement will be made at Conference Board Meeting and the Conference Business Meeting of pending vacancies to the Board. Persons wishing to apply for a board position must submit an ATAAC Resume. In order to allow Board members time to review resumes, it is suggested that they be submitted at least (1) month prior to the mid-year, usually August, Board meeting.
- Board members are elected at mid-year Board meeting to take office in January or, if elected in February, will take office at the mid-year Board meeting.

There are two board meetings a year. One is usually in August, and the other board meeting happens at the conference. At this time the 2021 ATAAC is still being planned as a face-to-face conference, with the understanding that part or perhaps all of it might be held virtually, depending on the status of the COVID-19 pandemic.

Whoever takes this position will be the Chair of the 2023 and 2024 ATAAC, which will be held in Austin. Many people in the Austin area have been on the ATAAC committee in the past so there is a wealth of experience in this area. ATAAC has guidelines, which include a detailed description for each member of the committee. Austin is a popular destination for ATAAC, and hotels book sometimes two years in advance so preparation for the 2023 and 2024 conference should start as soon as possible. As with all AI-Anon service, you do not have to do this conference alone! You will have lots of help!

I will be happy to answer any questions you have regarding service on the ATAAC board. Thank you for considering this important service opportunity.

- Write checks for various district expenses such as newsletter printing and mailing, rental space for district meetings, and purchase of district supplies
- Make timely bank deposits



Alternate District Representative

Someone willing to:

- Complete the DR's term if/when the DR resigns
- Attend all service meetings the DR attends
- Assist in visiting the groups in the district
- Backup and help the DR when necessary

Must be an incoming, outgoing, or active past GR, who is not a member of AA, with a basic knowledge of the Traditions and Concepts and how to apply them in the links of service.



Secretary

A skilled recorder who will:

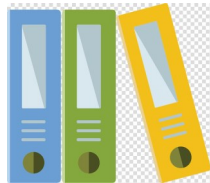
- Attend district meetings and record minutes of the meeting to include motions, who made and seconded the motion, and the motion result
- Present previous meeting minutes and request approval of minutes
- Prepare and submit a written report to the Newsletter Coordinator



Archivist

An organized person willing to:

- Preserve and organize Al-Anon and Alateen district history
- Bring materials to district meetings for display
- Make materials available to the membership and researchers
- Transport and house storage containers
- Attend district meetings



Alateen Coordinator

Someone with patience and compassion willing to:

- Coordinate Alateen sponsor certification in the district
- Support district AMIAS and sponsors
- Attend Alateen support training, like P.O.S.S.E.
- Work with the Area Alateen Coordinator and Area Alateen Process Person
- Encourage teens to attend Alateen meetings and functions
- Attend district meetings



Coordinador Hispanohablante

Someone with bilingual writing and speaking skills to foster Spanish speaking groups' growth by:

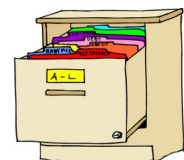
- Visiting Spanish-speaking groups and encouraging participation in district meetings, assemblies, and conferences

- Coordinate draft review of newsletter by district officers
- Coordinate newsletter publication and distribution with the printer
- Create an on-line version of the newsletter and provide that to the AIS Web site coordinator
- Understand MS Word, PowerPoint, or equivalent publishing program
- Attend district meetings



Public Outreach (North) Coordinator

Someone with good organizational and communication skills, with a passion to:

- Tell people who we are, what we do, and why/how we do it
- Seek opportunities to promote Al-Anon in the community by attraction and cooperation
- Recruit speakers and coordinate mailouts
- Attend district meetings



Public Outreach (South) Coordinator

A reliable person with good organizational and communication skills that can:

- Match Al-Anon speakers with treatment centers
- Find Al-Anon volunteers for health fairs
- Inform the public of who we are, what we do, and how we do it
- Make phone calls and follow through
- Attend district meetings



Forum/Literature Coordinator

Someone interested in spreading the written word of Al-Anon who will:

- Promote the use of CAL and eCAL
- Recruit Al-Anon members to share their written stories of experience, strength, and hope for *The Forum* and other Al-Anon literature
- Coordinate with WSO, the area, and the district on literature matters
- Sell CAL at district meetings
- Promote subscriptions to *The Forum*
