# Our New Alternate DR's Story...

When Lori asked me to write my story for the newsletter, I did what we are taught to do and said yes. I secretly thought-what am I going to write! Anyway, thanks Lori for giving me a chance to practice my program in another area of my life. I will try and tell in a general manner what I was like, how I got here, and what it is like for me today.

Long long time ago, in the plains of Kansas an Al-Anon was born (that's me). I was not born into a family of alcoholism or grew up around alcohol abuse. My parents encourage me in all aspects of my life and taught me the work ethic I have today. With all those blessing, I never felt a part of. I was always comparing my insides to your outsides. You were cuter, more talented, smarter, and, if you were another girl, you always got the guy I thought I wanted.

I tried to fill that hole inside me with books, dreams, and associating with people who lived on the edge. From an early age, I ran around with people who drank too much and I loved it. I even participated in the drinking and merry making. Why I didn't become an alcoholic, only God knows, and for that I am truly grateful.

Situations happened (he got a divorce and needed to move to Ohio) and I was having trouble in school, so I thought it was a good time to get married. I wasn't getting my way in graduate school and he didn't ask me to marry him, so I did what was natural and moved to another state. One more geographic to try and get the result that I wanted. Situations happened and we did get back together and married.

In Southeast Texas, we both hit bottom and luckily he know that alcohol was the major contribution to the unhappiness in our marriage. I was ok, with him getting help as long as I didn't have participate in anything-like therapy and it had to be on our insurance plan. I was really angry and said some very hateful things to him at this time. I was so angry by this time, I had become hateful and unloving to my parent and I wasn't a stellar employee. Oh, I went to work every day, but everyone avoided me so that they didn't hear my harsh words. No one wanted to work for me, unless they had to.

We started down the AA/Al-Anon path, with kind and loving people. They loved us when we didn't. I was told to go to six meetings during family out-patient day so I went because I thought it would keep him sober. I was so angry, but when I got in those meetings and whined about how he had messed up, the kind and loving people just let me talk and told me to keep coming back. I didn't want to be there. It was his problem, not my problem. I kept going back because they seemed to understand. They shared with me one on one what it was like in their households so I didn't feel alone. The group asked me to make coffee, so I started my first service job. I kept hearing, if you want what we have, you have to do what we do. I asked what that was, they said watch the people how laugh and have a sparkle in their **KAY'S STORY CONT. ON PAGE 8** eye. Ask them what they do, so I did.

# District Representative

### District 6 Meeting, October 20, 2007

Greetings everyone,

I only have two big items to discuss for this quarter.

First, I am pleased to report that the situation with the missing laptop computer has been resolved. As you may remember, the computer had disappeared after our district meeting in April and the church had initially asked us to replace it. At our last district meeting a committee was appointed to arrive at a mutually satisfactory solution. We learned that the church had already filed an insurance claim, as well as the police report, and had replaced the computer. It did cost them, however, the \$500 insurance deductible. The majority of the committee felt that since we did have the key to the church, we bore at least part of the responsibility for what happened while we had the key, and that the district should repay that part of the church's expense. Accordingly, and acting as trusted servants, we did pay \$500 to the church to replace their insurance deductible. The issue was not only one of financial responsibility, but one of moral responsibility, or "doing the right thing." The committee suggested that the money be taken from our prudent reserve and that we pass the basket for those who wished to help make up this cost.

The second item concerns our part as Support District for the November Area Assembly in Houston, hosted by District 5. At our last district meeting, we had volunteers to coordinate Group Representative registration and Action Committee registration, and to provide assistance for both the Friday night workshops (for those in various service positions) and the Action Committee workshops on Saturday afternoon, and, finally, for our Alateens to present the game show skit that was such a hit at the April District Meeting. I hope that all will be ready and that we can ask for help when and if we need it.

One last quick item: Mike J has resigned as District Literature/Forum Coordinator, and Stephen S was elected to complete the rest of his term thru 2008 at our last district meeting. Thanks to Mike for his service to the

district over the past two years.

Many thanks to Kay for stepping up and leading district meeting on October 21st. I'm sorry that I couldn't be there, but I thought our timing in selecting a new Alternate District Representative worked out very well for us.



Local News? Alateen attendance in Waco has been improved since the group's move in March 2007. One of their younger Alateens submitted a sharing to Alateen Talks- its in the most recent edition. Check it out! The Alateens in Georgetown are very active and recently sponsored a spaghetti dinner. They will be hosting a haunted house on Saturday, October 27<sup>th</sup> at the local club as a fundraiser too! Tally donated several Alateen books at the District Meeting and these were distributed at the meeting.

I'd like to pass along some Q&As (questions and answers) received from Mary Lou M. from WSO. Mary Lou is the Associate Director Group Services - Alateen and Special Services. I hope that the members of District may find informative. whether thev currently certified and working with Alateens or not! WSO is a great resource for us and they are always available via email or phone. Mary Lou reminds us of the Member's Web Site and give directions below as how There is loads of to access it. information, meeting topics, etc.. Of particular interest to Alateens and AMIIAS may be the Al-Anon Guide-

lines on Alateen Safety Guidelines (G-34) that provide guidance on how we can support Alateen groups- and guidance to the Alateens themselves on how to Guidelines on conduct themselves. Alateen participation in conferences and other topics can also be founds on the Members Website.

Here are the Q&As that were received from WSO via email in 8/07: Thanks for writing to your World Service Office—I am happy to respond to your questions.

The Service Manual refers "temporary" Alateen sponsors. What does this mean? A "temporary" Alateen Group Sponsor would be someone who is certified in their Area as an Al-Anon Member Involved in Alateen Service (AMIAS) who might substitute for a Group Sponsor, or take on the job for a short time while a permanent Sponsor is sought. Anyone of service to Alateen, whether temporary or permanent, must be certified by their Area process.

If a sponsor wants to join an Alateen activity in another area, is this OK as long as they meet their own area requirements? It is up to the Area where the event is held to determine the certification requirements for out-of-Area Sponsors. If it is a multi-Area Alateen Conference, the Areas should collaborate on the matter. Normally, the out-of-Area certification must meet or exceed the certification requirements of the Area where the event is held. It is up to the autonomy of that Area to decide to accept other Area's certification for one-time events.

Can Alateen groups still follow their group conscience in terms of non-certified adults in their meetings? In other words, can a group vote to have one "open" meeting a month as a public service? It is recommended that Alateen groups host one or two open meetings a year, to help to spread the word about Alateen and to attract Al-Anon members to get involved with Alateen service. We would not recommend more frequent regular open meetings, such as monthly.

Can an Alateen group vote to allow a non-certified adult to attend a meeting? Maybe a counselor interested in Alateen

issues- or an Al-Anon who wants to find our more about Alateen before committing to becoming certified as a chaperone? There may be occasions where a professional or media person wants to attend one meeting, and the WSO would support accommodating them. I recently put a writer in touch with Alateen local to her as she was writing a book in which a character attended Alateen. The group voted to allow her to attend a meeting as an observer. These Public Outreach opportunities should be handled on a case by case basis.

With regard to Al-Anon members attending Alateen meetings, other than special, one-time open meetings, we would not be comfortable with uncertified Al-Anon members attending Alateen meetings.

What are the minimum requirements for Alateen sponsorship, interpreted by WSO? The Al-Anon Board of Trustees established minimum requirements that each Area process must meet or exceed. This is not an interpretation of requirements, but a mandate from the Board, which was affirmed by the World Service Conference. I am attaching a copy of that motion. Each Area has that autonomy to develop their own requirements, as long as they meet or exceed the minimum established by the Board of Trustees.

The pamphlet S-27 on Alateen Sponsorship makes no mention of the Alateen **Sponsor** Certification Will this be updated? Process. Again, I think you must be looking at an old copy. The one I have, printed in 2005, states on the back side, "If you are at least 21 years old, have been an active member of Al-Anon for at least two years, have met your Area requirements, and are willing to your program, Alateen sponsorship may be for you."

# **ASK IT BASKET QUESTIONS!**

**Q1:** Recently our group adopted an opening statement at the beginning of our meetings that goes over guidelines on the way the meeting is ran. Many of us were not there during the adoption of these guidelines and we are uncomfortable with this. It seems unfriendly, controlling & long. We think we should keep it simple. Please help w/ District input.

**A1:** Recently my home group adopted a new opening format. Before that happened we formed a committee of 3 members to collaborate, write up a new format and present it to the group. Once this was done, it was used for 1 month before being voted on at the monthly business meeting. Once it was adopted, copies were made and laminated. I don't know what procedure this group used but perhaps it can be revisited at a future group conscience. Perhaps it could be condensed. I have seen all of this in different group openings and most of it is mentioned in the service manual. What it comes down to, I feel, is group autonomy and the needs of the group as expressed in the group conscience. Service Manual pg. 34, 40, 47, and 52. – Cindy

**Q2:** Is naming a group after your city considered affiliation?

**A2:** Tradition 3- can call themselves an AFG provided they have no other affiliation. Service Manual reference- pg. 81, groups are autonomous; WSO cannot shut down if they do not like how the group practices Al Anon or pg. 48, choosing a group's name- it is not a problem. - Tom R

**Q3:** Is there a definition of cross-talk? Does any of the literature address cross-talk?

**A3:** I believe the conference summary addressed "cross-talk" a few years ago- stating that cross-talk is not an Al Anon term. This is a group autonomy decision. My home group opening includes the following: "Cross-talk is discouraged at our group meetings- one on one conversation during our actual meeting. As our 1<sup>st</sup> Tradition states: Our common welfare should come first; personal progress for the greatest number depends upon unity."

They told me to make Al-Anon my first commitment, get a sponsor, do service work, work the steps, and my life would change. I was so desperate to get rid of the emptiness; I just did what they said. My way sure wasn't working. I got a sponsor and started working the steps. My group needed a GR, I said I hadn't been coming long enough (about 1 year), but they said just do it and we will help. I got busy in service and what a blessing that was for me. Active alcoholism had returned to my household and I just hit another bottom, but I was responsible, I had those service duties to do so I went. What a blessing, service work kept me busy and my mind off of him.

Since that surrender, my life has taken off. My husband did get sober; we both changed careers, and moved to Austin shortly after 9-11 (that is another story). Today I have two committed Al-Anon meetings and I attend open AA meetings. My committed home groups are Courage to Change in Austin and The 3 C's in Lakeway.

I know that the only way I can guarantee that Al-Anon will be there for someone else in my family is by continuing to go to meetings, doing service work outside of my group, sponsoring and giving back to a way of life that has made me a kinder, gentler, more accepting person. Today I know that I have received a blessing from the God of my understanding and that my purpose in life is to pass that blessing on to others. I also know today that my small amount of service to Al-Anon-inside or outside of the group rewards me tenfold every time.

We also strive for name recognition and credibility as a community resource. Public Outreach includes Outreach to the Public/Media, Outreach to Professionals, and Outreach to Institutions. Your area/district may choose to combine these service areas under Public Outreach, or to maintain separate coordinators and/or committees. All those in Public Outreach are encouraged to work together to avoid duplicating efforts.

For more information, consult the member's web site at WSO, <a href="http://www.al-anon.org/members/">http://www.al-anon.org/members/</a>, enter your group name, and see Group Services in the left column for Guidelines G-9, G-10, G-29, and G-38. Also, look under Public Outreach in the left column for service tools in each of the areas.

Please consult with your sponsor and/or Higher Power, not necessarily in that order, about whether this is a good time for you to start, or continue, service work at the district level. Remember that there are many others willing to help you learn, so you don't have to do this alone.



- 2) Sign in with your password. This is the name of your home group followed by the letters afg
- 3) Click on the ECAL link and you will see this greeting:

"Welcome to electronic Conference Approved Literature (e-CAL)

You are invited to share experience, strength, and hope in creative ways to make e-CAL an exciting recovery environment for Al-Anon members around the world!

e-CAL will grow as a direct result of the submissions you send. Personal stories, graphics, poetry, and even multi-media are welcome. If there is a feeling or a thought you have about recovery that you would like to share, even though words can't quite express what is in your heart, feel free to explore other ways to present your message."

That's all there is to it. You will be able to read other people's shares and share whatever you feel. There are rules about what will be accepted, which are outlined at the site. Happy surfing.
