Danni's Story

My name is Danni. When I sat down to write this, I thought of how the disease of addiction has touched so many generations of my family.

I met my husband in 1970 and we were married in 1974. Our life was good; we enjoyed being together, we worked, were able to travel, and when he finished graduate school, we moved to Austin.

After a few years, we were ready to start a family. We had our first son in 1981. In 1985 our second son was born, and in 1987, the birth of our third son made our family complete. I was fortunate to be a stay at home mom.

We were married for fifteen years before I realized my husband had a drinking problem and was also a workaholic. I began to be resentful of all the time he spent away from the family. I would nag and complain that he was not making me happy, and this became a constant theme in our marriage. I thought I could fix him, and that if he loved me, he would guit drinking. As the years passed and the boys got older, my behavior worsened. I had a lot of anger and no coping tools.

When our oldest son, at the age of twelve, started experimenting with drugs, my focus was off my husband as I became obsessed with trying to control my son. I became very codependent, never realizing the harm I was doing to myself and to my family. Fear takes on many forms and in me, it was mostly anger and trying to control. In 2002, I started going to Al-Anon meetings.

I can relate the experience of my first painting class to my first Al-anon meeting; I was out of my comfort zone in a class with some very talented artists. I kept going though, listened to the instructor, and worked at home practicing and painting. Over time, I began to understand what I was (continued on page 9)

The meeting was opened at 9:01 by Shelly S. with a moment of silence followed by the Serenity Prayer. Announcements were made. Annette T., founder and GR of Been There AFG recently passed away. Pat E. announced that the next POSSE of Sponsors Sharing (Program Everything) will be March 16, 17, and 18, 2012. Steve J. announced that LaVern W. who has fifty-two years in Al-Anon and is a long-time member of the TNT (Tuesday and Thursday) AFG in Waco recently had a stroke. She is now living with her daughter in Corsicana. We then went around the room reading the Preamble, Steps, Traditions, Concepts and General Warranties. Introductions were made by all. There were many present for their first district meeting. Two Alateens were present. A workshop was held. The topic was a discussion of the duties of officers and coordinators that will be up for election today. During the workshop, an Alateen Sponsor meeting was held.

The Fall Assembly will be in San Antonio. The TEAM (Together Empowering Al-Anon Members) event will be in August, 2012. Pat E. is the chair and Shelly S. is the Co-Chair. This event is hosted by our own District 6. The morning session paused for lunch at 12:08.

Ask-It-Basket:

1. Question: One of our local groups has an e-mail group that announces things that are going on (not just Al-Anon related). One of them wants me and the other Alateen Sponsor to get involved in this to announce anything that might be going on with Alateen, etc. (including Health Fairs we are participating in for Alateen/Al-Anon). Is this in compliance with WSO guidelines for Al-Anon and Alateen they announce non-Al-(since Anon/Alateen happenings)?

Answer: Page 108 Service Manual. "A group may pay for an ad in a newspaper or magazine to make the community aware of Al-Anon and Alateen."

2. *Question:* Al-Anon groups that meet on Thursday, should they meet on holidays (Thanksgiving)? Is that to be decided by the group or the district? *Answer:* It is up to group autonomy. If someone wants to be responsible to be there and have the meeting open. It is always good to be there in case a newcomer should show up.

3. Question: Our group does not provide babysitting, but a lady with three children under five started bringing her children to the meeting. The children are very disruptive. Do we ask her to find a meeting with babysitting or tell her she can't bring her children to the meeting?

Answer: Ask her to find a meeting with babysitting. One member could offer to take the children to another room or sit out in the hall with them. On page 96 in the Service Manual, it states, "Using group funds or taking a special collection to pay for a babysitter at the meetings is within a group's autonomy". Page 68 in the Service Manual - suggest the Lone Member meeting to the person to use in her home on the computer. Pages 36 and 37 in the Service Manual and page discuss electronic meetings. Suggest she get a sponsor to talk to on a one-to-one basis.

4. Question: If it is a conflict of interest for an AA member to hold office, why is it not a conflict of interest for an OA member, etc., to hold office? Telling me to read the book is not an answer. Telling me/us that you are here to make us feel welcome, then treat a double winner like a step-child is definitely a contradiction. It sounds like Why/Because/Next?, anyone else have a question? When asked who decided this, I was told Lois. So - is this Lois Al-Anon?

Answer: Pages 78 and 79 of the Service Manual addresses dual membership. "The need to focus on the Al-Anon program and the possibility of a conflict of interest led the World Service Conference to its decision".

5. *Question:* Since the door is firmly closed to anyone else (except for Al-Anons) to sponsor an Alateen group meeting, is there anyone here today who is willing to establish an Alateen meeting in South Austin?

Answer: See page 78 of the Service Manual, first paragraph on "Dual Membership"; page 35 of the Service Manual, "How to Start an Alateen Group" section; and page 84 of the Service Manual, "Starting an Alateen Group" section.

A Thought Force Report on the Kristy Fund was given by Pat E. and Steve J. with input given for Jayne G. in her absence.

Nancy made a motion for our district to support the Al-Anon International to be in 2018 in Central Texas. Lorelei seconded the motion. The vote was unanimous.





Also, we reviewed District 6 minutes and no motions or votes were found regarding requirements or distribution of funds. The fund was set up for Alateens only and not to help pay for sponsors to attend the Alateen conference.

The committee would like to recommend the following:

- A. Leave the half scholarships available in order to get support from Al-Anon groups as well as Alateen members.
- B. The District Alateen Coordinator will get a written request from sponsors listing the numbers of Alateens requesting scholarships.
- C. The Alateen sponsor would determine if, for some reason, a full scholarship would be needed.
- D. There will not be any limit to the number of times to request scholarships. This is due to ample funds available at this time, and the shortage of Alateens attending the conference.

We try to derive a topic for that meeting from the "Newcomer's Packet". Many of us realized that we had not read the pamphlets when we were handed the packet at our first Al-Anon meeting. There has also been some interest in adding a speaker meeting. We will discuss that at our next Group Conscience. In short, our group is healthy. The AFG is here for all of us.

River of Hope AFG

River of Hope AFG meets in the yellow portable building behind Gateway Community Church, 7104 McNeil Drive, Austin, TX. We have been experiencing attendance of around a dozen people. We nearly always discuss a step on the first Thursday of the month and a tradition on the third Thursday of the month. We have tried this year to have a group conscience once every second month. It does seem to promote an understanding and greater sense of the fellowship and unity of Al-Anon. We welcome people even if they need to

go to lunch after our meeting, since our meeting time is from 12:10 pm to 1:10 pm every Thursday except when Thursday falls on a major holiday or on Thanksgiving Day. This informal fellowship after the meeting is open to any attendees willing and able to come with us, and we find it a valuable way to make our group's friendships and personal relationships even more supportive.

Just for Today AFG. Elgin

We have 10 to 15 members. We also have 2 to 3 newcomers coming. We meet every Tuesday at the Methodist Church in Elgin from 6:30 pm to 7:30 pm. At our last Group Conscience meeting, we decided to change the 4th meeting from Birthday to another discussion and celebrate Birthdays once a quarter. Our format is to have a Step meeting on the 1st Tuesday, a discussion meeting on the 2nd and 4th Tuesdays, a Concept or Tradition meeting on the 3rd Tuesday, and a speaker on any 5th Tuesday. After 6 meetings, we give a copy of How Al-Anon Works to newcomers. If they have already purchased it, we give them credit toward another piece of literature.

being taught and was able to apply the techniques when I painted. It was the same with Al-Anon. I went to meetings, listened to others speak, and learned about the disease of addiction and the part I played in my dysfunctional family. I saw how the steps work for those that work them. I had gone in desperation and stayed because of inspiration.

At the meetings, there were people who understood what I was going through. No one judged my family and many shared openly about their own problems. I realized others were going through many of the same struggles I was facing and could see that I was not alone. In meetings, I saw faith, strength, courage, hope and joy. These were all building blocks that helped me build a strong, deep spiritual foundation.

Many years of ups and downs, going back to old behavior and starting over at Step One brought me to the year of 2005. I began to see how powerful addiction was, the reality being that the addict in my life would either get sober, go to jail, or die. I reached a point where I knew I had to let go and trust God, that as much as I loved my son, God loved him more. I began to trust that whatever happened, our family would be all right.

I remember the words someone said to me early on, that Al-Anon and its members would always be there when I needed encouragement or help. The years of going to Al-Anon helped prepare me for the call no parent ever wants to receive. On July 8, 2007, I learned my 25-year-old son had died from an overdose. He had struggled with addiction for over half of his life.

That day changed our family forever; to love deeply is to grieve deeply. We have walked through the sadness of missing his lopsided grin, his hugs and laughter, his presence in our life. I take comfort in the good relationship we had, knowing he knew how much our family loved him. With the help of God and Al-Anon, I do my best to honor my son's life by walking in faith and helping others touched by this disease.

My boys are finding their own path; my husband and I are still together after 37 years. We have our son's dog that reminds me so much of him; he is big and strong, sweet and loving, my constant companion.

Al-Anon has kept me in a healthy relationship with my boys and my husband. I learned to love them where they are, and in the process, they have taught me much. My family is healing. There is laughter and love in our home, memories to hold onto and new ones being made, and my son lives forever in my heart.



How Al-Anon Family Groups Came to Be

The Family Group idea is nearly as old as Alcoholics Anonymous. In A.A.'s pioneering days from 1935 to 1941, close relatives of recovering alcoholics realized that to solve their personal problems they needed to apply the same principles that helped alcoholics with their recovery.

As early A.A. members and their wives visited A.A. groups throughout the country, the visiting wives told the mates of the newer A.A.s about the personal help received when they themselves tried to live by A.A.'s Twelve Steps, and how this helped to improve family relationships that often remained difficult even after the alcoholic had become sober.

Thus, mates and relatives of A.A. members began to hold meetings to discuss *their* common problems.

By 1948, numbers of Family Groups had applied to the A.A. General Service Office for listing in the A.A. Directory, and scores of relatives of alcoholics had asked them for help. But A.A. was designed to aid alcoholics only.

In 1951, two wives of A.A.s, Lois W. and Anne B., formed a Clearing House Committee to get in touch with these 87 inquirers and to coordinate, unify, and serve them; 56 groups responded. As a result of questionnaires, the name Al-Anon Family Groups was chosen. The Al-Anon name is simply a derivative of the first syllables of "Alcoholics Anonymous." The Twelve Steps of A.A., virtually unchanged, and later the Twelve Traditions were both adopted as guiding principles.

Soon the movement came to public attention. New groups and individuals here and abroad wrote to the Clearing House about their problems. By 1954, a small paid staff became necessary. The Clearing House was incorporated as a nonprofit organization under the name Al-Anon Family Group Headquarters, Inc.

In 1955, Al-Anon's first book, *The Al-Anon Family Groups, A Guide for the Families of Problem Drinkers*, was published. Since then many more books and pamphlets were added.

In 1961, Al-Anon initiated its annual World Service Conference of Delegates, WSO staff, and volunteers to act as the fellowship's overall conscience. In the quarter century from 1951 to 1976, over 12,000 groups in the United States, Canada, and many lands overseas were added to the original 56. In 2001, the WSO started registering on-line meetings, and in 2007, other electronic meetings.

By 2010 there were over 25,000 groups in 134 countries and over 80 electronic (Internet and telephone) meetings.

How Alateen Came to Be a Part of Al-Anon Family Groups

Teenage children in the families of alcoholics soon realized that their problems differed from those of adult members. In 1957, Alateen grew out of this need. A 17-year-old boy, whose father was in A.A. and mother in Al-Anon, had been fairly successful in trying to solve his problems by applying the A.A. Steps and slogans.

With his parents' encouragement, he asked five other teenagers with alcoholic parents to join him in forming a group to help other teenagers. The idea caught on, and the number of groups began to grow.

In response to articles distributed by the WSO, 10 new Alateen groups were registered, and by 1958, the Board of Directors announced 31 new Alateen groups, with 39 more proposed, and its decision to establish an Alateen Committee.

In 1957, *Youth and the Alcoholic Parent* was submitted by California Alateen groups for publication. Subsequently, several books and pamphlets were produced as well as a newsletter, *Alateen Talk*, and the video *Alateen Tells It like It Is* (no longer sold).

By the end of 1962, there were 203 registered groups, and the Alateen program was spreading to other countries. In April of 1964, a staff member was added to work for Alateen, to handle correspondence with members and groups, send free packets of literature to new groups, and respond to inquiries from concerned professionals.

In 2003, the Al-Anon Family Group Headquarters, Inc. Board of Trustees took action to assure the safety of Alateens and Al-Anon Members Involved in Alateen Service. The 2003 Alateen Motion from the Board of Trustees required that all Al-Anon Areas in the World Service Conference (WSC) Structure establish Area Alateen Safety and Behavioral Requirements, and have a process for certification of Al-Anon Members Involved in Alateen Service (AMIAS).

In 2010, there are numerous Alateen pamphlets, leaflets, and books; a quarterly newsletter, *Alateen Talk*; and service materials for Alateen Group Sponsors. There are over 1,700 Alateen groups worldwide.
