With the assistance of Lynn S., District 12 Alateen Coordinator, an Alateen Group Sponsor Training Workshop was held in Cedar Park. We started with getting to know each other. Why were we here? Four attendees were there for their second training session, recommitting for another year to their registered Alateen Groups. The others were curious. For that I am grateful.

Six of our attendees were there for their first time ever at an Alateen sponsor training event. They sat in amazement as we discussed how we, as citizens of this state, are not above the law, and as group sponsors, there are laws with which we must abide. They learned about Permission Forms and Medical Forms, and how they have to be notarized. They learned a few new acronyms and who their trusted servants are.

Yes, it isn't as easy as it was back in the "old days" to become an Alateen Group Sponsor. But there are those who feel that the rewards for becoming an Alateen Group Sponsor far outweigh the requirements. The rewards can come when we least expect it, and my heart is filled with gratitude.

For the 10 people who elected to spend a Saturday learning about becoming an Al-Anon Member Involved in Alateen Service (AMIAS), I hope that they have at least increased awareness of our needs. I hope that they are willing to do public outreach within their own communities to publicize the need for group sponsors and for Al-Anon members to bring their teens to meetings.

And reminder to those current group sponsors. If you haven't completed your annual recertification requirement for attending a district meeting and a district group sponsor meeting, you have two more chances to get that requirement fulfilled - this coming January and then April. Hope to see you.

The changes in anonymity are on pp. 41-43, 91-94; public outreach changes are on 109-116; Alateen group sponsor changes are on p. 49. A hard copy of the new manual will be mailed to groups in early 2014. Please make sure your mailing addresses are current with Area Group Records in order to receive the manual and other mailings from WSO. (Group record change forms the are on Texas website, www.texas-al-anon.org under TX East. Password is "anonymity." OR contact Kay C., Area Group Records Coordinator.

Also new on the Member Website are two publications that were previously only available to certain audiences via snail mail. They are "Area Highlights" and "Alateen Talk." Two District 6 members, Jayne and Steve, have published articles in the "Area Highlights". On the Member Website, click "Publications" and "Newsletters." Jayne's article about Alateen is on p. 6 of the Summer, 2013 edition, and Steve's article about District 6 North Public Outreach is on p. 7 of the Fall, 2013 edition.



# DISTRICT 6 MEETING MINUTES October 19, 2013 Hosted by Taylor Al-Anon Family Group, Taylor, TX

# Forum/Literature Coordinator Report

Having Had A Spiritual Awakening is available as an e-book from your electronic book provider. The cost is \$9.99. This book features member sharings, photographs, and artwork from around the globe, reflecting the diversity of Al-Anon members' spiritual experiences. So far, 1596 ebook copies have been sold.

How Al-Anon Works is now available as an audio book of audible.com, amazon.com, and hopefully, will be available in mp3 format on Apple iTunes soon. Sales of the soft cover version of How Al-Anon Works have totaled 49,211 copies, while hard cover sales are 6,246 copies.

As of September, WSO has received about 900 sharings for *Intimacy In Alcoholic Relationships*. More sharings are still needed if this piece is to express the diversity of our fellowship. So far, 65% of the sharings have been from men.

Al-Anon's newest publication, *Reaching for Personal Freedom*, is selling like hotcakes. Since July, sales have totaled 20,000 copies in English, 178 copies in Spanish, and 947 copies in French. It is a workbook to be used with the Steps, Traditions, and Concepts. There are a few copies on the literature table and Kitty has plenty at the book store.

Sharings are needed for the new pamphlet "For Parents and Grandparents of Young Problem Drinkers". Members are encouraged to write on this topic. Of particular need is how parents and grandparents apply each of the Twelve Steps. If there are aspects of their situation that make a particular Step difficult, how have they worked through those challenges? Sharing sheets are available on the member website:

How are you making the Forum more visible? The Forum is a monthly publication that is the voice of Al-Anon. If you are a GR, please make sure your group knows about the Forum and gets a chance to read the free copy that your group gets every month. Al-Anon members can have their own copy for a subscription fee of \$11 per year. What a deal! As December approaches, remember that a Forum subscription or any CAL would be a great Christmas gift.

# **Public Outreach South**

A BIG Thank You to all that supported the following Accomplishments during the last 3 months! Without you, Public Outreach would not be possible. If you are interested in getting involved, please contact Judy W to express your interest.

"WE" Accomplishments:

1) The Saturday Closed Parent's Meeting at the Phoenix Academy Juvenile Center continues to meet weekly. This facility houses children 11 to 17 that are coping with drug/alcohol addictions. Recently, the District Representative sent a request to all groups for additional volunteers. We have increased our subs and will be rotating new volunteers into the weekly closed Parent's meetings. We are also having a Spanish interpreter (that affiliation with has no the counselors) sit in on our Saturday meeting to assist the Spanish speaking only parents. We have printed the 12 Steps in Spanish and are using the interpreter to help these parents share their input at of our meetings.

2) Held 4 three-panel member speaking events for monthly family support day at the Austin Transitional Center Family Day in Del Valle. This location is a low security halfway housing center for clients that are learning about community support systems and expected to be released in the upcoming 90 days.

3) Held a three-panel member speaking event with an AA member on our panel at the Developmental Counseling Center, Inc (DCCI) in July.
4) One member supported three visits to the Texas Civil Correction Drug Court (TCCDC) to speak with families supporting clients required to appear by CPS.

5) The District Rep also helped send new volunteer information to the Public Outreach Chair for those interested in helping with the Travis County Sherriff's office in Del Valle. Those volunteers are being contacted so we can determine what service level they are interested in.

6) CASA has reached out to Al-Anon to begin discussions about how we can work together in the future. Another meeting is planned to continue these discussions in the next quarter.

If you or your group is also doing something for Public Outreach, please share! We love to hear those stories, get your ideas, and are also here to support you if you need help.

Things have been picking up a little for the Northern part of the District. This past guarter we participated in the annual Children's Health Fair that took place at the Waco Convention Center on August 10. # Ask It Basket October 19 District Meeting

1. Texting in meeting-people feel disrespected versus meeting note taking.

# Answer: From: "Conflict Resolution"

Tradition Two-"For our group purpose there is but one authority-a loving God as He may express Himself in our group conscience. Our leaders are but trusted servantsthey do not govern".

"There is an intentional absence of personal power or authority, we presume goodwill. We are free to think and feel as we choose, but...we put aside our fears, anxieties, and agendas, and trust the process".

Tradition Four-"Each group should be autonomous, except in matters affecting another group or Al-Anon or AA as a whole".

"Conflict can arise when we force our personal agenda without considering how our decisions affect everyone concerned".

Tradition Five-"Each Al-Anon Family Group has but one purpose: to help families of alcoholics. We do this by practicing the Twelve Steps of AA ourselves, by encouraging and understanding our alcoholic relatives, and by welcoming and giving comfort to families of alcoholics".

"Using the Steps, we learn to put the focus on ourselves. As we grow, so does our kindness and compassion for others. We no longer feel it is our business to judge what is or isn't appropriate for anyone else".

Tradition Nine-"Our groups, as such, ought never be organized; but we may create service boards or committees directly responsible to those they serve".

"In Al-Anon we share as equals. No one is empowered to resolve our conflicts by telling us what is right and wrong".

2. When I chair a meeting people often don't participate. "We are afraid of you".

Answer: Not really a question so rather than answer, we will comment-

- If someone has told me they're afraid of me, I would step back and self-examine to see what I am doing to warrant those feelings.
- It's okay to be silent. Learn to be comfortable in silence/quiet. Meditate/pray.
- Choose a longer reading-it may be that people are shy or aren't ready to share.
- Consider changing the format of meeting.
- Hold a group conscience to discuss the underlying issues.
- Ask 'old-timers' to attend and share to show the way of how we share ESH (experience, strength, and hope).
- Pass a daily reader around so people can read passages on a particular topic (use index).
