## Meeting Minutes

April 17, 2021

Virtual meeting held online via Zoom

District Representative, Anna A., called the meeting to order at 9:00 am, thanked everyone for attending, and welcomed Norma as the Spanish translator, and no new GRs. After introductions, the group said the Serenity Prayer, and members read The Twelve Traditions in English and Spanish, asked if anyone would like a Spanish translation (the answer was no), and the Twelve Concepts of Service, and General Warranties of the Conference were read.

Roll call showed 34 members in attendance and 25 voting members.

Ask it Basket was provided through text, chat, or email to Anna with all information provided to contact her.

After the 7<sup>th</sup> tradition was read, information for the new mailing address for the Treasurer, Debbie P. was given.

Corrections to the Service Arms Page was mailed out to CMAs. Corrected information was given as Donna M. the middle 3 numbers are 308 and Gail H., 234 is for the house address.

### **DR Announcements-**

The ETAAA Fall Assembly 2021 is November 12-13 and an in-person meeting. All are invited. The registration is open and reservations can be made at <https://texas-al-anon.org/events/>.

We are hosting the AWSC August 7, 2021 at the Wyndham in Round Rock for \$1,027, which is \$473 under budget.

The July 9 Delegate's Chat, held via Zoom, has a slide show entitled *July 2021 Electronic Meetings Chat with the Delegate Presentation* posted at <https://texas-al-anon.org/texaseast/>. (Click on the link then you will put in the password; "anonymity". Click on Members and Groups, then in the Delegate's Corner you will find the July 2021 Electronic Meetings Chat with the Delegate Presentation). Groups do not have to make any permanent decisions regarding whether they are meeting virtually, in-person, or choosing a hybrid until April 2022. Groups choosing to meet concurrently (simultaneous meetings in-person and virtually but as separate meetings) should make their decision on how they would like to continue and notify WSO sooner to register as two separate groups. One meeting will keep the same WSO Group Number and the other meeting will get a new WSO Group Number. Groups meeting only virtually (permanent electronic groups) may stay within the physical area of East Texas or be in a new area that is a Non-panel/Non-geographic Area; it is yet to be determined. Each Geographic Area (ours is East Texas) will decide if these permanent electronic groups stay within the current Area's service structure or be in their own Non-geographic Area. There is a work group to looking into this and report at the August 7th AWSC meeting. Anna is on the work group, if you have any questions.

Cathy M. has updated all district meetings and WSO websites with Zoom information. They have requested the AIC web site use a link to the WSO web site as compared to listing meetings on the AIC's web site, as the AIC web site takes too long to be updated. In the mean time, the district has requested the AIC to take down all meeting information as it is outdated. This will be discussed at August's AIC Board meeting. #### ***Distributed Report Questions-***

***Secretary*** – Previous minutes were amended to show Peggy T. is Area Group Records Coordinator, and 'form' was changed to 'from'. The minutes were approved as amended.

***Treasurer*** – Anna shared a spreadsheet of budget via Zoom as Debbie presented. There were no questions.

***ATAAC Chair*** – The February 18-20, 2022 ATAAC in Fort Worth and Cat is our Austin Chairperson. Registration opens August 1, 2021 at <http://www.ataactx.com>. We need a Board Treasurer ASAP and an Alateen Coordinator. This is a 2 year (2023-2024) commitment and Austin is hosting the 2023 at the Marriot in Pflugerville. Please contact Cat at [Amlofarms@gmail.com](mailto:Amlofarms@gmail.com) if you are interested in either of these service positions.

***Alateen Coordinator*** – Pat E. is our interim Alateen Coordinator. The Area did not meet the deadline of June 15, and we did not have enough AMIAS sponsors to continue Alateen. There were many districts who had problems with recertification this year due to Covid-19. Alateen cannot meet as of July 21, 2021 in District 6 and throughout Texas East Area 53. We are currently working to meet all the requirements. We need to get 67 AMIAS sponsors certified with a goal date of mid-September, but hopefully sooner. We cannot use the Alateen name right now due to dealing with minors, Texas law, and no current AMIAS. Alateen folks can attend Al-anon meetings for now. We are not currently looking for an Alateen coordinator as we have no Alateen meetings.

#### ***New Business***

25 people voting – 16 people is 2/3rds and 13 simple majority

As a consensus, GRs liked the on-line registration process versus email, so we will continue it.

A couple of years ago, the district considered having a web site mainly as a repository for documents. Through the KBDM process they agreed that the East Texas web site worked. The issue has been raised again mainly due to the fact that the AIC web site is slow to be updated, and there is no single place to get all necessary documents, so people must go to multiple web sites. Someone would have to develop and maintain this website. The floor was open for discussion of what we would like to see on this web site. A thought force with Cathy M. as Chair, Jessica, Joyce, and Lydia Francine was put together to consider what we would want on this web page and why. Anna will provide them with a charge, so all is clear. This thought force will report back at the next District Meeting.

A Day in Al-Anon Thought Force with Mary R. and Gail H. let us know they need a couple of more people. Gail went to a rehab facility in Georgetown, and they were happy to have someone representing Al-Anon come by, willing to provide access to rooms for Al-Anon meetings, and suggested Al-Anon's presence on Family Day. Nancy B. will go for Family Day. Jessica P, Kristi H., and Kay C. will visit the Rehab facility. The new Thought Force volunteers added are Kristi and Nancy. Anna will create a charge, so everyone is clear of their task.

#### ***Lunch 11:50-12:20***

For the Spring Assembly 2023, Kay C. is now the Assembly Mentor, so there is a conflict with her being the Speaker Chair. Kay is resigning from Speaker Chair but happy to be a resource. We now need a Speaker Chair for the Spring Assembly.

AMIAS training will be on a Saturday for 6 hours with a date TBD. If you are interested, please contact Pat E. at [peng1301@sbcglobal.net](mailto:peng1301@sbcglobal.net).

Brian M. presented an update for the October workshop committee. From a survey sent out, people are not yet interested in meeting in-person. Wimberley can host an in-person/hybrid meeting. From GRs at the meeting there was a consensus of half the people willing to meet in person. The floor was open for discussion. 6 people were willing to attend in-person workshops and 3 people were open to hybrid. There were not enough people to move forward. More discussion and 17 people were willing to attend a virtual workshop.

\*\*Mary R. moved we have a virtual workshop on the same day as the meeting in October. Jessica P. seconded. 18 people voted yes, so the motion passed.

Wimberley AFG will be the Host Group. Anna will work to condense this business meeting. Norma B. will assist Brian as the host group.

There was consensus to hold the January District Meeting virtually.

We need a Treasurer ASAP for the East Texas Area Al-Anon/Alateen Spring Assembly 2023 as we are the host. Speaker Host Chair will be Linda B. A possible venue is the Wyndham Hotel, a venue for 200 people. Please contact Anna if you would like to serve as Treasurer.

GRs shared successes and challenges in regards to virtual and/or in-person meetings.

Anna gave special thanks to the host group and the Spanish Translator.

## Events

- District Meeting on October 16 – It will be virtual, as voted on by the GRs at the April District Meeting. Please invite others from your groups who are interested in seeing what goes on at our district meetings. ## **Alateen Coordinator Report**

Dear Al-Anons and Alateens,

To start, the good news is effective September 1st the World Service Office advised we can start up our Alateen Meetings.

Our Texas East Delegate, Mattie T., advised that Texas East was the first area to resubmit our recertification for Alateen Sponsors, AMIAS, Al-Anon Members in Alateen Service.

Our Alateens suffered the most during this time by not being able to have their meetings. Now is the time for us to step up and get our teens into the face-to-face meetings. Since our teens do not drive, it is necessary for them to have transportation.

We have four Alateen groups in District 6; Northland, South Austin, Cedar Park and Fort Hood. We have several that closed due to no attendance; Bastrop, Lake Travis (Lakeway), Dripping Springs and Wimberley. We have 11 certified AMIAS in District 6. For those that did not recertify it is necessary to take the 6 hour training certification.

We need the help of everyone to get our teens that have been affected by the disease of alcoholism in family and friends introduced to our Alateen program.
