January 22, 2022

Virtual meeting held online via Zoom

Meeting called to order by District Representative, Anna A. at 9:11 am. Anna welcomed new GRs and thanked everyone for attending. There was no host group. Anna A read the Serenity Prayer, Debbie P read the Traditions, Linda N read the Concepts of Service, and Donna M read the General Warranties.

Roll call: 28 members in attendance, 21 voting members. Simple majority = 11, 2/3 majority = 14.

7th Tradition: The Treasurer, Debbie P.'s address was given for members to send contributions.

District Representatives' Announcements: Full reports are available in the Winter 2022 District Newsletter. The following information is in addition to the report.

Electronic meetings follow-up to the Fall Area Assembly: Policy recommendations have been developed as requested; a revised proposal will be submitted at the Area World Service Committee meeting next week.

Peggy T. resigns as Area Group Records Coordinator as of January 29. Cathy M will keep information updated until a new Area Group Records Coordinator is installed.

A list of all members on the **Service Arms Page** was mailed to each groups' Current Mailing Address (CMA). A hard copy must be mailed rather than communicated electronically because of the requirement of anonymity.

Fall, 2021 District Meeting Minutes, as published in the District Newsletter, were approved by consensus vote.

Treasurer's Report by Debbie P, District 6 Treasurer, updated since the Newsletter, were approved by consensus.

Archivist Report, as published in the District Newsletter, no questions.

Group Records Report by Cathy M. Cathy will be acting as Area Group Records Coordinator until a new AGRC is elected. Cathy will send a copy of all changes and all CMA's to Group Representatives. Please review this information and send questions or comments to Cathy M at etx6grouprecords@gmail.com.

Austin Information Center (AIC) Liaison, Jessica P. reports that there was a loss of almost \$3000 for AIC in 2021. She reminds us that sales of Al-Anon literature are tax-exempt. This is not true of other Al-Anon branded items, such as coffee mugs or tee shirts. The AIC Board is looking for a new chair. This group meets quarterly via Zoom. All are invited to

attend. A recommendation to reopen the salesroom was passed on 1/3/22, so it is now open. However, since we are in Stage 5 Covid restrictions now, it is closed to foot traffic. Telephone or email orders can be filled by curbside pick-up until restrictions are lifted. Volunteers for the salesroom are needed and will be trained. Problems persist with getting things posted on the AIC website. A new secretary will begin next month. The next AIC Board meeting will be Feb 15. All are welcome.

The All Texas Al-Anon Alateen Conference is scheduled for February 18-20 in Fort Worth. There is a virtual option offered for no cost. The website <http://www.ataactx.com/>, was posted in the Chat for additional information.

Speaker: Carolyn F, Alateen Area Coordinator: The acronym POSSE stands for Program Of Sponsors Sharing Everything. POSSE conferences can certify an Al-Anon Member Involved in Alateen Service (AMIAS) whether they are new or renewing. There are new ways, now, to certify via Zoom. The documents were approved in November 2021 and the new Alateen Service e-Manual can be found at <https://al-anon.org/for-members/members-resources/manuals-and-guidelines/alateen-service-e-manual/>. As of January 13, 2022, training is available to recertify AMIASs on Zoom. Initial training is also available on-line. Getting new Alateen groups started is very important. Zoom meetings can get things started but they are not satisfactory for long term.

Kay C. added that in District 6, people who live in Llano and Burnet Counties must get certified in Texas West to serve as AMIAS.

New Business Change in attendance, now 22 voting. Simple majority =12, 2/3 majority = 15

District Secretary Position Election: Duties explained,

term to end 12/31/2023. **Norma B.** volunteered for the position. Elected by unanimous vote.

Vote for District Alateen Coordinator: Must be a certified AMIAS planning to recertify this year. Term to end 12/31/23. No volunteer.

Budget presentation, Debbie P. Treasurer The proposed budget was posted on a shared screen for discussion. #24 Newsletter is a much lower number since the District is not sending hard copies. #26 AMIAS currently pay for their own background checks, discussion of possibly budgeting for the District to pay for them. This would have to be voted on at a later meeting, but the budget is sufficient to take care of the item. Currently, 10 AMIAS background checks are needed. #30 POSSE scholarships. Anyone wanting a POSSE Scholarship requests it from the District Alateen Coordinator. POSSE is March 18-21, 2022. #14 Question: What does AAIC stand for? Changed to AIC for consistency.

Motion presented by Toni H: *I move to approve the proposed budget for 2022 as presented at the January 22, 2022 District Meeting.* Second, Gail H. Passed by unanimous vote.

LUNCH BREAK 12:00 – 12:45

New Thought Force for District website, Barbara M, reporting. Task: to recommend if District 6 needs a website or a document repository. Concern is not to duplicate information. Used Knowledge Based Decision Making (KBDM) questions to form the review of current realities. See report in the Winter 2022 Edition of the District Newsletter for details.

Recommendation: To form a Task Force to study the details and to make concrete recommendations regarding a document repository, including whether a service position needs to be created to monitor activity. After discussion, a District Repository Task Force was set up by a consensus vote. Volunteers for the Task Force: Jessica P (Chair), Natanya A, and Denise F. Anna A will meet with the Task Force to come up with the charge. With the creation of the Task Force, the Thought Force was dissolved.

Introduction to Al-Anon, Gail H (Public Outreach North), Mary R. (Public Outreach South) cochairs. Committee: Angela E, Nancy B, Christi H. Nothing new to report. Next steps are to get in touch with others on the Task Force to get things rolling.

July District Meeting Format: Anna A: Discussion about trying to have a hybrid meeting. Question: How do people feel about an in-person July meeting, unless on a given date, we are in Stage 5 Covid restrictions and must have a virtual meeting? Decision: Consensus vote to poll the entire District via email to plan for an in-person July meeting unless Covid restrictions one month before the district meeting require a virtual meeting. This will require a volunteer host group.

District Meeting Format Discussion Anna A: Anna presented the District 5 format for District Meetings, which were considered and discussed. The issue was introduced to see what the District thinks about having more frequent, but shorter meetings, to see if this might help more members attend the district meetings. Questions: Do we want to table these ideas and come back to them at the next District Meeting? 12 hands, yes. Do you think we have talked about this enough? Do you want to create a Thought Force to talk more? 5 hands, yes. Do you want to forget about it? 2 hands, yes. Decision: To table this for now and talk about it again in April.

District 6 will host the East Texas Al-Anon/Alateen Spring Assembly in 2023. Place: to be announced. Tentative Date: May 5-7. Theme: to be announced (possibilities: spring/wildflowers/slogans).

Committee chairs needed in the next two months: ETAAA Secretary: Cat A. volunteered; Public Outreach: no volunteer; Speaker Chair: Lydia Francine volunteered; Theme: all are invited to send ideas for the theme to Anna A.

Group Representatives Share – GRs shared their successes and challenges.

Al-anon Declaration read: Spanish, Jessica P.; English, Anna A.

Events

- East Texas Al-Anon/Alateen Area Assembly (ETAAA) on May 13-15 – This will be a face-to-face event held in Corpus Christi at the Holiday Inn Corpus Christi Downtown Marina. - ETAAA Spring 2023 Host Committee – District 6 will be the host district for the 2023 ETAA Spring Assembly, and we have selected a venue. Yay! Electronic Meetings Update

I sent out an email on February 20 providing an update regarding electronic meetings to groups with multiple meetings where one or more of the meetings occurs electronically with no face-to-face component. The guidance does not affect meetings with no electronic component (formerly referred to as hybrid meetings) and does not affect electronic meetings with no face-to-face component that are temporary (i.e., you plan to have a face-to-face component to the meeting at some point in the future).

So, here’s what this means:

If you are a group with multiple meetings and some are electronic only (i.e., face to face on Saturday and exclusively electronic on Tuesday evening), the electronic meeting must either add a face-to-face component or register with WSO as an Al-Anon Family Group Which Meets Electronically (AFGWME). Groups in this situation should make a decision and take the appropriate action by the end of April. Please remember that any group records changes should be sent to our District Group Records Coordinator Cathy M. at etx6grouprecords@gmail.com. I’ll also be happy to answer any questions via phone or at one of your meetings if you like.

Remember, if your group would like me and/or our Alternate DR Lynn P. to come visit, please let me know. We’ll get back to you with schedules and plan a visit, either virtual or in person.

Thank you all for your service, and I look forward to seeing everyone on April 23.
